02/13/2024	Sterling	<b>Geek Squad Scam:</b> The complainant received an email which she believed was from Geek Squad and called the number provided to obtain a reimbursement. The person on the phone convinced her to give them access to her computer to process the transaction, then was told she was credited too much money and needed to withdraw the difference from her bank and deposit it into a Bitcoin machine. She then realized she was about to be the victim of a scam. The case is under investigation. SO240002704
12/13/2024	Leesburg	<b>Snap Chat Scam:</b> The complainant reported that he received a Snap Chat request from an unknown person who he believed to be a female and began communication with her. The person requested explicit photos and videos from the complainant, which he sent. After doing so, the complainant was told to send money via gift cards, or she would send the pictures and videos to his friends and family. After sending gift cards, the person demanded more money, and the complainant blocked the person and ended communications. SO240002693
