The deceased has been identified as Michai Dandridge-Carter, 19, of Sterling.
		On February 14, 2024, at approximately 7:19 PM, deputies responded to 9- 1-1 calls about a gun shot heard and pedestrian down in the 44400 block of Keller Square. Upon arrival, the victim was discovered in the parking lot and determined to be deceased. It has since been determined that the victim suffered a gunshot wound, and the case remains under investigation.
