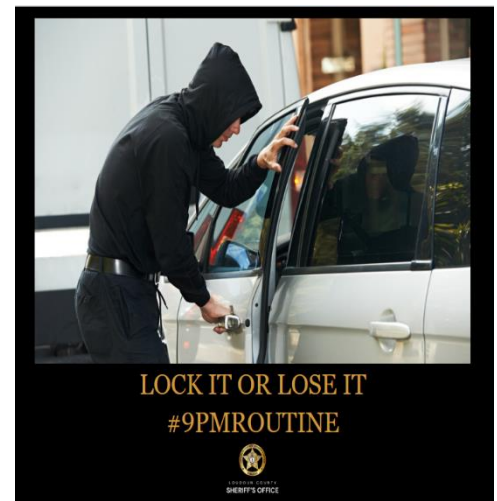
Safety Tips / Announcements
