During the time he and Natasha were corresponding, she introduced him to crypto currencies and was able to persuade him into investing money. Natasha provided him with a link for him to invest in |

When his money got to a certain amount, he attempted to withdraw it but was unable and told he needed to pay more money to get his money out. Natasha then encouraged him to invest more money, but the complainant declined. This upset Natasha who in turn blocked the complainant. This is when he realized he was the victim of a scam. She reached out to the group who told her what the cost of the kittens would be. The complainant paid the amount via Zelle and agreed to meet at a location in Maryland on a specific date. The seller then reached out to the complainant and informed them she was not going to be able to meet her but would ship the kitten via a transport company to her. The transport company then reached out to the complainant and asked her to pay the shipping cost, which she did via Zelle. The complainant was then called back and told she needed to pay for pet insurance. This is when she realized she was the victim of a scam. SO240005827 |
