Scams

04/15/2024	Ashburn	Microsoft Scam: Complainant reported he received a pop-up message stating his computer has been hacked. He called the number that was provided believing it was legitimately from Microsoft. The complainant was then convinced to purchase Home Depot Gift Cards and provide the numbers and codes on the back of the cards to the suspects in order to resolve the issue. He then realized he was the victim of a scam. SO240006761
04/15/2024	Ashburn	Facebook Scam: Complainant reported that she began corresponding with a man she met on Facebook and over time a trust was developed in their relationship. The man told her that while on a business trip he was not able to make a bank transaction because of bad internet service. He then asked the complainant to make the transaction for him, allowing her to see he had a large sum of money in that account. Believing the suspect had a large amount of money the complainant did not hesitate to purchase gift cards for him with the promise that he would repay her when he returned home. Once he let the complainant know he was back, she told him she would pick him up but received no reply. The complainant then realized she was the victim of a scam. SO240006704

Safety Tips / Announcements

How are they doing it?



- ▣ **The thief will go to a gym that they do not belong to & purchase a day pass to use the facility. Many gyms do not ask for identification to purchase a day pass. (recommend checking with your gym to push them to do this).**
- ▣ **He or she will then go to the locker room;**
- ▣ **Take a bolt cutter out of their bag;**
- ▣ **Cut open your lock to access your locker;**
- ▣ **Take your wallet and any other valuables;**
- ▣ **Take your broken lock with them and leave the gym;**
- ▣ **Immediately go to a store or stores nearby and attempt to use your credit cards to purchase gift cards or items.**

All of this before you even realize your items are missing.
