Loudoun County, Virginia, and the Loudoun County Heritage Commission, are pleased to present this application for a grant to support the research and documentation required for expansion of the Ball's Bluff National Historic Landmark (NHL) from its current 76 acres to a potential 2900 acres.

The existing NHL and National Cemetery at Balls Bluff only includes the ground in Virginia where some of the last and most intense fighting of this important Oct 21, 1861 battle took place. It is far smaller than the "core area" identified by the 1992/3 CWSAC and more recently updated by ABPP, and fails to include important locations and sites where key troop movements and engagements took place. This proposed expansion would encompass significant battlefield structures and features, well preserved land and beautiful river viewsheds along both the Virginia and Maryland shores of the Potomac and on Harrison Island, Maryland.

In our view, and that of the State Historic Preservation Officers of both Virginia and Maryland, as well as many preservation groups in both states, this is an important and worthy project. It provides the opportunity to recognize, honor and potentially protect a beautiful, well preserved and important landscape which still retains its historic character while surrounded by intense development. It is a critical step in our long term plans to encourage appropriate land use policies, research and education programs and private actions to preserve this special place.

The members of the Heritage Commission, and the staff of Loudoun County, intend to support this study with their own time, knowledge and capabilities. We appreciate the advice and support we have gotten from the ABPP team and look forward to your review of this application.

2. Briefly, state the project preservation objective/goal and project description.

The Loudoun County Heritage Commission proposes to expand the boundaries of the current 76 acre National Historic Landmark at the Balls Bluff-Edwards Ferry Battlefield to include approximately 2,900 acres which closely follow the recommendations of the 1992/3CWSAC studies as updated by ABPP. The proposed expansion includes well preserved land, earthworks and contributing structures along both the Virginia and Maryland shores of the Potomac River and Harrison Island, Maryland.

This expansion will recognize and honor more of the well-preserved and historic Potomac shoreline where significant and critical elements of the October 21, 1861 battle occurred. It will raise public and official awareness of the significance of this land in the midst of major public and private development pressure

and serve as a critical element of a program to preserve this landscape for future generations.

This section of the Potomac between Virginia and Maryland was considered a key strategic area in late 1861. The crossing of the River on October 21 by thousands of Federal troops and their subsequent disastrous defeat so close to Washington DC, coupled with the death in battle of a US Senator and close friend of President Lincoln, Edward Baker, led to the formation of the Joint Committee on the Conduct of the War and profound changes in how the war was considered and how it was prosecuted.

The grant will fund improved and more detailed maps of the battle, expanded and defined boundaries, professional surveys and a photographic record of terrain, structures, earthworks and other features, copies of required nomination documents, a PowerPoint presentation for the NPS Landmarks Committee and Advisory Board and responses for peer reviewers. 15. How does this project contribute to the long-range preservation goals for the site?

Official recognition of the historic significance and well preserved landscape and beautiful river viewshed of the expanded area will contribute to local land use policies which encourage preservation in both states and enhance the potential for acquisition of additional parkland. Recognition of the expanded area will require assessment of less intrusive alternatives for public and private development projects than provided for under current zoning. Improved studies and maps of the battle and the official recognition of the expanded area will lead to better public understanding and increased opportunities for private easement programs or other preservation steps for private properties. Further, it will increase opportunities for further scholarship including KOCOA assessment of the battlefield and archeological studies which will refine the interpretation and understanding of this important battle within the context of its historic landscape. This scholarship, coupled with National recognition, will enhance existing heritage tourism opportunities and affirm the tangible value of preservation in both Virginia and Maryland.

- 16. Why is the proposed project the most appropriate preservation action or strategy for this site at this time? Expansion of the boundary of the current National Historic Landmark combines research already undertaken by the CWSAC and ABPP with the support for preservation of this area recently demonstrated by the Loudoun Board of Supervisors and the Leesburg Town Council. The honorary designation provides a strong foundation for future preservation initiatives on both private and public lands. Further, official recognition of the expanded area will require development alternatives which consider and minimize impacts to both individual historic resources as well as to the expanded NHL as a significant, historic entity. Finally, increasing public awareness of the historic significance of the area (already rising due to anticipation of this project) can influence private landowners in their consideration of development alternatives for their properties.
- 17. What special factors contribute to the present opportunity for this project (e.g., personnel, timing, availability of matching funds, community support, or other unique circumstances)?

  Growth in Loudoun County is among the highest in the nation and is expected to increase as the economic situation improves. The current Leesburg Town Council and the Loudoun Board of Supervisors have recently expressed strong interest in protecting this particular area as a "historic gateway" into this rapidly developing area. Major regional organizations have indicated strong support, and input from affected landowners at two public meetings has been positive. The current membership of the Loudoun Heritage Commission has unique experience in the recognition and preservation of historic battlefields. Further, the C&O Canal National Historic Park is currently updating their overall Park Plan. And, private owners within the proposed new boundaries are currently evaluating development alternatives.

Two well advertised public meetings have been held within and near the project area, which outlined the history of the Battle, the process for the proposed expansion project and the potential implications of NHL expansion. Major landowners have been approached and met with privately.

The Heritage Commission meetings, and meetings of this project subcommittee, have been posted on the County's official calendar and are open to the public. The Project team expects to exceed the requirement for public notification and outreach with regular updates to landowners and presentations to local government bodies. In addition, the project team will provide local, regional and national media with information about the project and the historical significance of the area. Finally, members of the Heritage Commission will continue to brief local and regional preservation organizations on project objectives and progress.



I am writing, as Virginia's State Historic Preservation Officer, to support the citizens of Loudoun County and the Loudoun County Heritage Commission in their efforts to study and map a potential Balls Bluff and Edwards Ferry Civil War Battlefield district that may significantly expand the boundaries of the current Balls Bluff National Historic Landmark. It is clear to me and the professional staff of this agency that the current 76 acre National Historic Landmark encompasses only a small portion of the ground on which this important event of national significance took place. Thus, I fully endorse your efforts to recognize this larger area along both banks of the Potomac and your application for funding from the National Park Service through the American Battlefield Protection Program (ABPP).

My support is based on the results of a careful review of documentation about the expanded battlefield area by this agency's multi-disciplinary evaluation team as well as staff visits to the battlefield. This highly experienced team has reported that the expanded boundary appears to meet the criteria for expansion of the boundaries of the existing National Historic Landmark from its current 76 acres to almost 2900 acres including areas on both banks of the Potomac River and Harrison's Island, Maryland. The proposed expansion has also been reviewed by our State Review Board, which concurs with the Evaluation Team.

A second and perhaps equally important basis for my support is that the full extent and importance of multi-jurisdictional resources are recognized all too rarely. I believe that the Balls Bluff district expansion provides for unprecedented opportunities for cooperation among the jurisdictions for resource protection, education, and tourism in both Maryland and Virginia.

The effort to determine appropriate boundaries and integrity of resources encompassed by the Balls Bluff/Edwards Ferry battlefield is both appropriate and commendable. It can only serve to advance local, state and national efforts to recognize, interpret and protect this important battlefield and raise the appreciation for the citizens of Virginia and Maryland for their significant shared history.

We trust that the ABPP will give your application the full consideration that it clearly merits.

The Ball's Bluff Battlefield Historic District (2013 Boundary Increase) will expand the Ball's Bluff Battlefield (which was designated an NHL and listed in the registers in 1984) from the current 76 acres to approximately 2,870 acres to include well-preserved surrounding land along both sides of the Potomac River. The expanded boundary will encompass land in Loudoun County, including the Town of Leesburg, and Montgomery County, Maryland. Land on both the Virginia and Maryland shores of the Potomac River will be included as well as Harrison's Island, Maryland, which lies between the shores. The proposed boundary expansion is based on the Battlefield Core Study Area created by the Civil War Sites Advisory Commission. Included in the Virginia area are Ball's Bluff Battlefield and National Cemetery (NHL), two ferry crossings, one active and one historic; three structures extant at the time of the battle; earth works constructed as part of the defense of Leesburg; Fort Evans; Edwards Ferry Road; a roadbed abandoned after the Civil War; and rolling lands that retain much of their character from the mid-19th century. The Maryland side contains portions of the Chesapeake and Ohio Canal National Park, Harrison's Island, and the Edwards Ferry landing. The expanded district will add many locations significant to the events on and around October 21-22, 1861, when the Civil War first came to Loudoun County. The boundary increase area includes approximately 20 contributing and 36 non-contributing resources. A comprehensive archaeological survey of the proposed boundary increase area has not been conducted, however, the battlefield is known to retain subsurface cultural resources related to the battle; the area also has a high potential for prehistoric sites, although these would not be related to the area and period of significance being evaluated here.

The evaluation committee recommended the boundary increase eligible for the National Register at the **national** level of significance under **Criterion A** (Military) and **statewide** level of significance under **Criterion D** (Archaeology), with a period of significance of **October 21-22**, 1861. Boundary increases are not typically rated.

I am writing to express the Maryland Historical Trust's support for the Loudoun County Heritage Commission's grant application to the American Battlefield Protection Program (ABPP) to research and potentially expand the Ball's Bluff Battlefield National Historic Landmark (NHL) to include additional battle-related areas in both Maryland and Virginia. The Maryland Historical Trust, an agency of the Maryland Department of Planning, is Maryland's State Historic Preservation Office.

Significant events associated with the October 21, 1861 Battle of Ball's Bluff occurred within Montgomery County Maryland as Union troops stationed there moved to cross the Potomac River at and near Edwards Ferry, occupied Harrison's Island in the middle of the river, and then retreated back from Virginia following the crushing Union defeat. Much of the area in Maryland related to the battle lies within the C&O Canal National Historical Park, while Harrison's Island is in private ownership. The Ball's Bluff Battlefield NHL project would significantly contribute to fulfilling our shared goals of protecting our most significant battlefield sites, preserving open space, and supporting

The Chesapeake & Ohio Canal National Historical Park (C & O Canal NHP) strongly supports the Loudoun County Heritage Commission's initiative to research and potentially expand the boundaries of the existing Balls Bluff National Historic Landmark to include land on both sides of the Potomac River.

The Chesapeake and Ohio Canal stretches 184.5 miles along the Potomac River from the mouth of Rock Creek at Georgetown in Washington D.C. to Cumberland, Maryland. It is the finest relic of America's canal-building era. Although it never fully realized its potential, the Chesapeake and Ohio Canal Company did provide for the transport of heavy, bulky cargoes including coal, cement, and agricultural products during its heyday. Its remaining canal and lock structures, built mostly using manual labor by Irish workers, are testament to early engineering and construction practices that have endured to this day. The C&O Canal NHP was established on January 8, 1971 (Public Law 91-664) to preserve and interpret the historic and scenic features of the Chesapeake and Ohio Canal and to develop the potential of the canal for public recreation, including such restoration as needed. Approximately 20,000 acres lie within the legislative boundary of the park.

The Ball's Bluff Civil War Battlefield along the Potomac River in Loudoun County is an important star in this larger constellation of resources. I am writing on behalf of the Civil War Trust, the nation's largest nonprofit battlefield preservation organization. Our mission is to protect America's endangered Civil War sites and promote appreciation of these hallowed grounds through education and heritage tourism. Please accept this letter as our statement of support for the expansion of the existing boundaries of Ball's Bluff National Historic Landmark and for the American Battlefield Protection Program (ABPP) grant to fund the study of this proposal.

The current 76-acre National Historic Landmark boundary at Ball's Bluff contains the site of the last and most severe fighting of the October 21, 1861, Battle of Ball's Bluff one of the earliest battles of the Civil War and a lopsided defeat for the Union. U.S. Senator Edward Baker of Oregon, a personal friend of President Lincoln, was among those killed in the fight, the only sitting member of Congress to die in battle. The site also contains Ball's Bluff National Cemetery, one of the smallest National Cemeteries in the country, the final resting place of 54 Union soldiers.

However, the action on that day encompassed a much greater area than the 76 acres currently preserved. Significant maneuvers surrounding the present battlefield site occurred on both the Maryland and Virginia shores of the Potomac River, as the riverbanks of both states served as crossing points for Union troops arriving to and retreating from the battle. It is because of these noteworthy actions in October, 1861, that the Civil War Trust endorses the plan to include an additional 2,900 acres in the Ball's Bluff National Historic Landmark. Expanding the boundaries of this landmark will allow for greater interpretation of these sites associated with the battle and honor the memory of those who fought and died here.

Additionally, it will allow Loudoun County, Montgomery County, and the States of Virginia and Maryland to support and encourage land uses that sustain cultural tourism economies. Battlefields can be an economic boon for states, communities and their citizens, as noted in our recently released report, *Blue, Gray and Green*.

The Civil War Trust continues to play an active role in the preservation of Ball's Bluff

Battlefield. Through a partnership with the Virginia Department of Historic Resources and the Northern Virginia Regional Park Authority, we were able to save the historic Jackson House on the battlefield, a witness structure to the fighting in 1861 and an important landmark that tells the story of the battle itself. On August 15, Virginia Governor Bob McDonnell announced more than \$2.2 million in preservation grants, including funds to purchase the Jackson House, at a press conference held on the Ball's Bluff Battlefield, which drew additional attention to this site. In order to further preserve this significant battlefield, we strongly support this proposal to expand this landmark and endorse your application for funding from the ABPP.

The Friends of Ball's Bluff Battlefield was founded in 2012 to help support the Northern Virginia Regional Park Authority's efforts to maintain and properly interpret the approximately 221-acre Ball's Bluff Battlefield Regional Park, part of which is the currently designated National Historic Landmark.

Aside from its natural scenic beauty, the battlefield park was the site of an early battle in the Civil War. Small by comparison with later and better known battles like Antietam, Gettysburg, or the Wilderness, Ball's Bluff, fought on October 21, 1861, was significant at the time because of its location northwest of the national capital, because of it being the third consecutive Union defeat that year, and because U.S. Senator Edward D. The Northern Virginia Regional Park Authority (NVRPA or Park Authority) strongly supports the Loudoun County Heritage Commission's initiative to expand the boundaries of the existing Ball's Bluff National Historic Landmark (NHL) to include a larger area of Loudoun County as well as land on the Maryland side of the Potomac River. We encourage the American Battlefield Protection Program (ABPP) to fund this important work with a grant to cover the cost of research and nomination preparation.

The Park Authority owns and operates multiple park and historic resources in the vicinity that would benefit from historic district expansion. NVRPA's Ball's Bluff Regional Park is 215 acres surrounding Ball's Bluff National Cemetery, including the existing 76 acre NHL lands at the core of the Ball's Bluff Battlefield. In partnership with the Civil War Trust, NVRPA is acquiring the Jackson House at Ball's Bluff and expects to take ownership by the end of the year.

NVRPA also owns Red Rock Overlook Regional Park, 1.75 miles downriver from Ball's Bluff, and has been working with neighboring landowners and the Loudoun Heritage Commission to protect the historic resources along Edwards Ferry Road.

In 2009, the Park Authority also acquired White's Ford, approximately 5 miles upriver from Ball's Bluff, that was the home of Lt. Col. Elijah V. White, CSA, commander of the 35th Virginia Cavalry battalion. White's Ford was found to be associated with the Battle of Ball's Bluff according to a report prepared for NVRPA that was funded by an ABPP research grant. In the hours leading up to the Battle of Ball's Bluff, White's Ford provided a vantage point from which the Confederates observed Union troops across the river in Maryland. On the night of October 20, 1861, General N.G. Evans (CSA) ordered Lt. Col. John McGuirk to White's Ford to conduct reconnaissance. The following morning, McGuirk sighted Union troops in formation across the river. Later that day, McGuirk and the pickets from the 17<sup>th</sup> Mississippi abandoned their position at White's Ford to join the battle against Union troops who had crossed the Potomac River at Ball's Bluff (U.S. War Department 1880-1898, Series I, Vol. 5:361, 363).

In addition to the connection of White's Ford with the Battle of Ball's Bluff as set forth in the Park Authority's ABPP report, the resources at White's Ford may complement the historic resources at NVRPA's Temple Hall Farm Regional Park just 3 miles away. Col. White's wife, Elizabeth White, her children and nurse, moved into Temple Hall, home of Mr. Henry Ball, at the beginning of the Civil War. Mrs. White, Mr. Ball's daughters Kate and Betty, and another neighbor Annie Hempstone, were arrested July 9, 1864 for running the blockade after the picket post left the river bank, smuggling gray cloth and cavalry boots for the Confederates across the Potomac at White's Ford (from The Confederate Veteran Vol. 35, page 19).

The lands surrounding the Potomac in Loudoun and Montgomery Counties are significant for natural scenic beauty and historic villages, battlefields, and farmlands. The Ball's Bluff Civil War Battlefield along the Potomac River in Loudoun County is the most significant of the many resources in the area. The existing 76 acre Ball's Bluff National Historic Landmark, however, is only a small portion of the still pristine landscape in which this important battle took place. The additional research and mapping that would take place as part of an update to the existing nomination will add significantly to our understanding of the October 21, 1861 battle and its battlefield, will honor the memory of this historic event and will raise the awareness of Virginia and Maryland residents to the history in their midst. Expanding the National Historic Landmark area to include additional NVRPA and Town of Leesburg resources along the river, as well as historic resources along Edwards Ferry Road and Harrison Island, will help NVRPA tell the story of this landscape to its park visitors.

Official recognition of the expanded battlefield would also allow Loudoun County, Montgomery County and the States of Virginia and Maryland to support and encourage land uses that sustain cultural tourism economies while preserving community open space assets that enhance the local quality of life. A recently released Civil War Trust economic impact report (http://www.civilwar.org/land-preservation/blue-gray-and-green.pdf) confirms battlefield preservation's economic benefits for states, communities and their citizens.

Our history is priceless and the Northern Virginia Regional Park Authority is proud to support historic preservation and this project for current and future generations.



### Dear Landowner:

The Loudoun County Heritage Commission wants to honor the land near Balls Bluff where Federal and Confederate soldiers fought in October of 1861. Your property is potentially part of the area to be honored. This letter will give you information about the Civil War events that occurred on or near your property, and the recognition sought by the Heritage Commission.

In late October of 1861 a small scouting party of Federal troops crossed the Potomac River seeking information about Confederate camps near Leesburg. Through a series of errors and mistakes, this small scouting mission developed into a serious battle in which many hundreds of soldiers were wounded, captured or died. The losses were particularly dire for the Federal side, which was unable to retreat across the swollen Potomac. A US Senator, Edward Baker, was killed in the battle. The US Congress, reacting to the disastrous outcome so close to Washington DC, established the Joint Committee on the Conduct of the War which significantly affected the entire course of the terrible war.

The 76-acre National Historic Landmark at Balls Bluff contains a small National Cemetery and is the site of the last and worst of the fighting. However significant events occurred over a much wider area that day in October ranging from Edwards Ferry, where thousands of Federal troops crossed over from Maryland but never managed to come to the aid of their beleaguered colleagues so close by, to Whites Ferry where thousands of Federal troops were camped on the Maryland side. It also includes land on the Maryland side of the Potomac along the C&O Canal and Harrison's Island from which the Federal troops crossed and to which they tried desperately to return. Amazingly, much of this land, on both sides of the river, looks much as it did 152 years ago.

The Heritage Commission proposes to increase the official boundaries of the Balls Bluff National Historic Landmark to include approximately 2900 acres over which both sides ranged during this struggle. The proposed boundaries, which will be adjusted by the research to be conducted, are shown on the enclosed preliminary map. This designation would in no way affect your property rights or allow anyone to enter onto your property, but it represents a significant honor. It would also provide generous tax benefits for those who own and want to restore structures that were standing at the time of the battle. National Historic Landmark status is the highest designation awarded by the Federal Government for historic areas and is given only for locations that have made a significant contribution to the Nation's history. There are only 2500 such designations in the United States today.

At this point the Heritage Commission is seeking a grant from the National Park Service American Battlefield Protection Program to help fund the historical research that will support the expansion of the designated battlefield area and will establish official boundaries for the enlarged historic landmark.

We have enclosed several items to help you better understand the history, to show you a very preliminary map of the proposed landmark area and to answer any questions you may have about the battle, the project or the effect on your property.

In addition, the Heritage Commission is holding two public meetings:

- > November 12 at 7 p.m. at Temple Hall, 15855 Limestone School Road, Leesburg

At these public meetings noted historians will tell more about the important history on and around your property and other experts can answer your questions about the research process for determining the new boundaries and explain this honor and why it will not in any way affect your ability to do as you like on or with your property.

This area is rich with history from the Native Americans who traversed this land for thousands of years, to the very earliest European explorers sailing up the Potomac, to the wars fought on our Loudoun soil that created and shaped our nation. We want you to join us to understand our history, to learn the history of your own property and to encourage the proper recognition of this wonderful place.
