New Procedure for Transmittal of Legislative  
Land Use Applications**

**Procedures for Legislative Land Use Applications**

Procedures for accepting and reviewing land use application materials in advance of **Board of Supervisors and Planning Commission** meetings are intended to ensure that legislative land use applications are complete and available for sufficient review by the public, Supervisors and Planning Commission members in advance of official meetings. Schedules also allow county staff and applicants adequate review and response time prior to distribution of meeting packets.

**When Applications Do Not Meet the Published Schedule**

Board packet distribution dates are listed in this document. Proffer Statements and Conditions of Approval must be approved to legal form by noon on Monday the week of packet distribution.

When schedules are not met or amended materials are received after the meeting packet is distributed, staff reserves the right to recommend that the Board leadership and/or Planning Commission recommend action on the application be deferred to a future Board/Planning Commission meeting.

Staff may make exceptions to this procedure for minor revisions to proffers such as notarization, signatures, numbering, pagination, typographical errors, and other such non-substantive changes. Similarly, staff may make exceptions to this procedure for minor revisions to special exception conditions of approval that do not affect the requested use of mitigation of impact.
