We are pleased to offer additional eligibility options for the **PRCS CARES (Childcare Assistance and Resources for Enrichment Support)** Program by providing discounted fees for children's programs for eligible participants.

### DISCOUNTED FEE PROGRAMS

You may apply for discounted fees based on the program's payment schedule (weekly or monthly) and availability in our Children's Programs including:

- Preschool and Child Care at Community and Recreation Centers
- After-School CASA at various LCPS Elementary Schools
- After-School CASA Academy at Community and Recreation Centers
- Licensed Summer Camps at various LCPS Elementary Schools and at Community and Recreations Centers.

<b>TANF</b> - Temporary Assistance for Needy Families	Approval letter dated within last 12 months from DFS	75% for Oct 2023 through Sept 2024 fees
Section 8 Housing Choice Voucher	Approval letter dated within last 12 months from DHCD	75% for Oct 2023 through Sept 2024 fees
Loudoun County Public Schools Free and Reduced Meal (FRM) Program Letter	2023-2024 approval letter from LCPS or other jurisdiction	50% for Nov 2023 through Oct 2024 fees
