SBA Announces Exclusive PPP Application Period for Small Businesses



Beginning on Wednesday, February 24, 2021 at 9 a.m., the U.S. Small Business Administration will establish a 14-day, exclusive PPP loan application period for businesses and nonprofits with fewer than 20 employees. This

will give lenders and community partners more time to work with the smallest businesses to submit their applications, while also ensuring that larger PPP-eligible businesses will still have plenty of time to apply for and receive support before the program expires on March 31, 2021.

SBA also announced four additional changes to open the PPP to more underserved small businesses than ever before. While these changes are being implemented, SBA will work with community partners to improve the emergency relief “digital front door” and conduct extensive stakeholder outreach. And, SBA will strengthen its relationships with lender partners to advance equity goals, deliver funding efficiently, and prevent fraud, waste, and abuse.

More Sites in Virginia Join Federal Retail Pharmacy Program

According to the CDC, additional retail locations in Virginia are receiving limited amounts of vaccine, as part of the [Federal Retail Pharmacy Program](#), for eligible individuals based on state and local guidelines.

Details on when participating locations in Loudoun will start administering vaccinations or how much of the doses or what type they will receive is currently unknown. Whether these sites will use the Commonwealth's centralized vaccine sign-up system is also unknown at this time. The Governor is expected to make a formal announcement Tuesday, February 23. This program is optional for retailers. There may be some participating retail chains whose locations are not participating in Loudoun but could be participating in a neighboring jurisdiction.

In addition to the CVS Pharmacy at Lansdowne Town Center in Leesburg, the following retailers have opted to join the program:

Loudoun County's schedule of free, drive thru COVID-19 testing events includes a large-scale event February 24 and smaller, twice-weekly testing events through March.

The testing events are open to all. There are no age or residency requirements. No prescriptions or appointments are necessary. A person does

not have to exhibit symptoms of COVID-19 in order to be tested. A PCR test (nasal swab) will be administered, which tests for the novel coronavirus. No antibody or rapid tests will be offered.

No COVID-19 vaccine will be available at these events.



Data Migration Continues on Statewide Registration System

As we reported over the weekend, the Virginia Department of Health (VDH) continues to work to improve the new statewide system for COVID-19 vaccine pre-registration and to migrate the pre-registration data from health districts across the state, including Loudoun.



Many people who submitted a Loudoun County pre-screening survey prior to 5:00 p.m., February 12, have not been able find themselves in the statewide system because the "Check the List" feature is not yet working correctly.

Please note that anyone who previously submitted a pre-screening survey to Loudoun County is still on the county's waitlist and we are working to schedule vaccination appointments for those on the list.

Members of the public have an opportunity to shape future routes and schedules for Loudoun County Transit's Metro Connection Bus service. The county is seeking feedback on 10 proposed new and modified routes that will provide service to and from Metrorail Silver Line stations in Loudoun County through an

online public information meeting and comment period. All responses to the proposed routes will be taken into consideration before final decisions are made on the routes and schedules.

The public is invited to join the online public information meeting for the proposed Silver Line Bus Routes on **Thursday, February 25, 2021, from 6:00 – 7:30 p.m.** to ask questions, provide input and learn more about the proposed routes.

Free Tax Preparation Assistance Available for Seniors in Leesburg and Sterling

This year to keep you safe, all AARP Tax-Aide services are virtual.

You must complete all required forms in advance and bring those along with your tax documents, photo ID's and social security cards (taxpayer, spouse and dependents) to your intake appointment.



Certified volunteers will review your documents, conduct a brief interview and scan your documents into secure cloud storage for later preparation. Once your return is complete, you will make another appointment to return to the intake site to review and sign your return and receive a copy to keep. All scanned tax documents will be deleted once the return has been successfully e-filed.


