

COVID-19 Update



State and Local COVID-19 Data Summary

Loudoun's seven-day positivity rate slightly increased to 6.7% this week. [Loudoun's data dashboard](#) shows the seven-day average case count also has increased to 85.3 per day. At the state level, Virginia's seven-day average of

daily cases have stagnated since last week. By continuing to socially distance and registering for the vaccine when you are eligible, Loudoun residents can help blunt the potential resurgence of COVID-19.

One of Loudoun County Public Schools' CDC [core indicators](#) remains at the highest risk level (158 new cases per 100,000 in the last 14 days). The Department of Education and LCPS now are using secondary indicators to help inform decision-making, including the move back to hybrid learning. Schools will begin offering in-school instruction four days a week for hybrid students on April 20. 

Residents Aged 16+ to be Eligible for Vaccine Starting April 18

Eligibility for COVID-19 vaccinations will be expanded to all Virginians 16 and older on April. Based on the supply projected by the federal government, all local health districts will have enough vaccine to open appointments to the general public, Gov. Ralph Northam said Those at highest risk will continue to receive priority in the scheduling process. [Read details in this news release from the governor's office.](#)



Weekly Vaccinations Update

As of today, Loudoun has started offering appointments to individuals who submitted pre-registration forms online or by phone on March 31, 2021. The current waitlist is down 8,966 since last week's update, but is

Loudoun Officials Encourage Vaccine Pre-Registration

Loudoun County health officials encourage anyone in the [Phase 1a](#) or [Phase 1b](#) priority groups to pre-registered for the vaccine. As reported in an [earlier blog post](#) from the county, Loudoun has made significant progress in working through the waitlist of people who are pre-registered for a COVID-19 vaccine.

- Anyone who has not yet pre-registered can do this in one of two ways:
 - **Online:** Visit vaccinate.virginia.gov. The fastest method for receiving a vaccination appointment is to include email addresses in the pre-registration form for each individual who will receive a vaccine.

- **Phone:** Individuals who do not have access to the internet can pre-register by calling 1-877-829-4682.
- Anyone who is in the 1a or 1b groups and pre-registered with the county and has not been contacted should:
 - Check your spam or junk email folder for an email from the CDC (Centers for Disease Control and Prevention) which is an invitation to register in VAMS and sign up for an appointment;
 - If you have not received an email, contact the county by calling 703-737-8300, Monday through Friday, between the hours of 9:00 a.m. and 5:00 p.m.

Loudoun County is holding weekly drive-thru COVID-19 testing events on Tuesdays in April. The next event is scheduled for April 6, 2021, 10:00 a.m. - 1:00 p.m., at [Philip A. Bolen Memorial Park, 42405 Claudia Drive, Leesburg](#) (Enter the park on Crosstrail Boulevard from Sycolin Road.) COVID-19 Funeral Assistance

The Federal Emergency Management Agency (FEMA) has announced that it will begin providing financial assistance for funeral expenses incurred after January 20, 2020, for deaths related to COVID-19 to help ease some of the financial stress and burden caused by the pandemic.

Governor's Updates

Governor Ralph Northam today announced that an additional \$203.6 million in federal stimulus funds and expanded eligibility criteria for the Child Care Subsidy Program will help further stabilize Virginia's early childhood care and education system, provide child care assistance to additional families as they seek stable employment or return to work, and deliver critical operational and technical resources to new

Governor Northam also announced several efforts aimed at increasing Virginia's vaccinator workforce to support the continued expansion of COVID-19 vaccinations across the Commonwealth, including a new initiative to recruit eligible individuals interested in administering vaccines. Health care providers who are now authorized to administer the COVID-19 vaccine in Virginia include but are not limited to dentists, dental hygienists, veterinarians, optometrists, and health professions students enrolled in an accredited Virginia program. [Eligible providers](#) may serve as vaccinators if they have the appropriate training and meet the

supervision requirements. All COVID-19 vaccine providers are responsible for ensuring that individuals who administer shots at their site are authorized by law to do so.

Eligible health care providers may [register to volunteer as a COVID-19 vaccinator](#) through either the Virginia Medical Reserve Corps (MRC) or the newly-established Virginia Volunteer Vaccinator Registry (VVVR).
