Dear Neighbors,

Great news! Loudoun County has exhausted the waitlist for COVID-19 vaccine and now residents can directly schedule their appointments. Please visit

The county continues to operate the site at the Dulles Town Center, but has also partnered with community organizations to bring the vaccine to those who can't make it to the mall. Schools are now back for hybrid learners four days a week and I am optimistic about the trends in our infection and hospitalization rates. However, in order to crush this pandemic and any new variants, please continue to adhere to CDC guidelines for masks, washing hands and social distancing.

As I mentioned in my last newsletter, the county passed the budget with an additional \$810,000 added to eliminate school athletic fees based on my initiative during our budget work sessions. The School Board completed its budget reconciliation this week and decided to use those funds to eliminate fees for up to

four Advanced Placement tests for Loudoun students. While I would have preferred the funds be used for their intended purpose, I am glad the School Board decided to eliminate fees that also disproportionately impact students in the same way as the athletic fees. After speaking with several of my colleagues on the School Board, I am confident that athletic fees, which were already cut by half this year, and additional fees that create inequities for students based on their ability to pay rather than their ability to perform, will be eliminated next year.



This week, Loudoun County began enforcement of the new gun ordinance initiated by my office. Firearms are now prohibited in county buildings, spaces used for county purposes whether owned or not, and parks. I am proud to have brought this initiative to the board and will continue to work for gunsense propositions in the future. Gun violence is a national epidemic and must be addressed. 

Public Input for Inventory of Confederate, Segregationist Symbols

The Loudoun County Board of Supervisors has initiated a review of Confederate and segregationist symbols in Loudoun County. Members of the public are invited to participate in an informational inventory of roads, buildings, signs and other public infrastructure that memorialize Confederate and segregationist figures or history in Loudoun County by submitting such sites through a new online mapping tool.

A multi-departmental team, including staff from the Departments of Planning and Zoning and Transportation and Capital Infrastructure and the Office of Mapping and Geographic Information, is working to provide comprehensive information to the Board, which will consider these items and their history.

An online map and survey has been developed through which the public can submit information about items potentially named after or memorializing Confederate or segregationist figures, symbols and slogans in Loudoun County. The online map will be open for public submissions until April 30, and the inventory is scheduled to be presented to the Board of Supervisors by June 2021.

Loudoun County Transit resumes fare collection on all bus routes on Monday, May 3 which have been waived since the beginning of the COVID-19 pandemic.

In preparation for this service change, riders should review the fares for their trips at loudoun.gov/transit. SmarTrip cards and/or cash will be accepted for all Commuter Bus, Metro Connection Bus and Local Bus routes. Riders of the Route 40 Purcellville Connector will still use cash only or the Virginia Regional Transit (VRT) punch pass.

Loudoun County Transit continues to follow the guidance of local, state and national health authorities to reduce the risk of COVID-19 exposure on transit buses. Operational changes include face covering and physical distancing requirements as well as more frequent bus cleanings. Here's What's Happening with Traffic Around Algonkian

VDOT has provided updates to several transportation projects throughout Algonkian:

Riverside Parkway


- Construction continues with conversion of the four sediment basins into the final SWM Pond configurations. Also, crews are working on the installation of storm drainage pipes, the underdrain, sidewalks, and grading.
- Loudoun County is asking all pedestrians to not walk in or around the construction site. Signs are posted around the construction site for your safety.
- Our office has received several complaints regarding the removal of trees on Smith Circle. We are looking into this issue and contacted county staff earlier this week. Stay tuned for additional information.

Algonkian Parkway and Lowes Island Boulevard Intersection Improvements

- A design plan has been submitted to Loudoun Building and Development and VDOT.

George Washington Boulevard Overpass

- Review of the proposed contract continues and the project remains on schedule to accept bidding in June 2021.



Loudoun Launches New Transit App

Loudoun County Transit has launched a new mobile app called "Transit." Loudoun County will provide all updates regarding any impacts to bus service through the Transit app. The app replaces the county's previous text service—LC Alerts and SV Alerts—which has been discontinued. Loudoun County encourages all subscribers to the former service alerts to download the Transit app to continue receiving accurate, real-time service updates from Loudoun County transit.

Upon launching the app, Loudoun County Transit riders will see nearby options and departure times for local, commuter and Metro connection bus services. App users will have the ability to receive important service alerts and breaking news information directly on the Transit app's home screen. Users of the app can customize how they receive service alerts through their mobile phone's notifications by signing up for push notifications for specific routes. Helpful features of the Transit app will allow users to:

- Check Nearby Departures.
- Track Their Ride.
- Plan a Trip.
- Get Step-by-Step Directions.
- Identify Favorite Bus Routes.
- Connect with the Regional Transit Network.

The Transit app is available for free download to iPhone and Android phones. For instructions on downloading

Planning Commissioner Update

Assistive Technology Webinar



COVID-19 Update



State and Local COVID-19 Trends

According to Loudoun's April 28 COVID-19 Summary Report, the County's seven-day test positivity rate is 6.2 percent (unchanged since last report). At the state level, Virginia has experienced a decrease in its seven-day moving average of cases since April 22 where it stood at 946. According to LCPS's case data, total number of cases per 100,000 people has lowered to the "substantial risk" level while the test positivity rate has declined to a state of "moderate risk." You can access COVID-19 data from LCPS by clicking [here](#).

COVID-19 Vaccine Online Self-Scheduling Now Open to Loudoun Residents, No Pre-Registration Required

Beginning today, individuals 16 and over can directly schedule an appointment online to receive a free COVID-19 vaccine at the Loudoun County Health Department vaccination clinic located at Dulles Town Center in Sterling.

The Health Department encourages all unvaccinated people age 16 and older who live or work in the county to schedule an appointment as soon as possible by visiting loudoun.gov/covid19vaccine. The website includes a link to the online form where individuals can request an account to schedule an appointment. An email address or cell phone number may only be used once to create an account. If an email address or cell phone number was used during the pre-registration phase, that contact information cannot be used again. After completing the form, individuals will automatically receive an email or text message from the CDC with a link to create an account in the Vaccine Administration Management System (VAMS) and schedule an appointment at the Loudoun County Health Department vaccination clinic. With this change, individuals no longer need to pre-register.

Anyone who needs assistance scheduling an appointment, including individuals who do not have

internet access, can contact the Health Department at 703-737-8300, Monday-Sunday, 9:00 a.m. to 5:00 p.m.



Loudoun to Use of J&J Again

The Loudoun County Health Department will resume using the single-dose Johnson and Johnson (J&J) COVID-19 vaccine following a joint announcement by the Centers for Disease Control and Prevention (CDC) and Food and Drug Administration (FDA) indicating the pause in the use of the J&J vaccine should be lifted. Loudoun County's next scheduled clinic that will use J&J COVID-19 vaccine is on this Saturday.

CDC and FDA Investigation

More than 6.8 million people in the U.S. have received the J&J vaccine. The recommendation to resume the use of J&J vaccine follows meetings of the Advisory Committee of Immunization Practices (ACIP), which carefully investigated a total of 15 cases of a rare blood clot disorder among women age 18-59 who experienced symptoms between 6 and 15 days after receiving the J&J vaccine. Based on the results of the ACIP investigation and evaluation of the known issue by medical experts, the CDC and FDA have determined the following:

- Use of the J&J COVID-19 vaccine should be resumed in the United States.
- The FDA and CDC have confidence that this vaccine is safe and effective in preventing COVID-19.
- The FDA has determined that the available data show that the vaccine's known and potential benefits outweigh its known and

potential risks in individuals 18 years of age and older.

- At this time, the available data suggest that the chance of thrombosis-thrombocytopenia syndrome occurring is very low, but the FDA and CDC will remain vigilant in continuing to investigate this risk.
- Health care providers administering the vaccine and vaccine recipients or caregivers should review the [J&J COVID-19 Vaccine Fact Sheet for Healthcare Providers Administering Vaccine \(Vaccination Providers\)](#) and [Fact Sheet for Recipients and Caregivers](#), which have been revised to include information about the risk of this syndrome, which has occurred in a very small number of people who have received the J&J vaccine.



CDC Updates Guidance

The Centers for Disease Control and Prevention (CDC) has issued updated guidance for fully vaccinated individuals, some of the updates include:

- Fully vaccinated people no longer need to wear a mask outdoors, except in certain crowded settings and venues.

- Guiding principles for fully vaccinated people are now provided.
- Clarification that fully vaccinated workers no longer need to be restricted from work following an exposure as long as they are asymptomatic.
- Fully vaccinated asymptomatic people without an exposure may be exempted from routine screening testing, if feasible.

VDH Launches Variants Dashboard

The Virginia Department of Health (VDH), in collaboration with the Department of General Services' (DGS) Division of Consolidated Laboratory Services (state public health lab), launched a COVID-19 Variants of Concern dashboard. The dashboard includes variants of concern received from participating laboratories for specimens that tested positive for COVID-19 since the beginning of the pandemic. Variants of SARS-CoV-2, the virus that causes COVID-19, are concerning as they may increase the risk to human health. The variants may:

- Spread more easily
- Cause more severe illness
- Escape the immune protection provided by available COVID-19 vaccines or by

natural infection with the virus that causes COVID-19

- Make viral tests less accurate
- Make some treatments less effective

With the threat of these new variant strains spreading, it is important now, more than ever, to wear a mask correctly over your mouth and nose, stay at least six feet from others, avoid crowds, wash your hands often, and get vaccinated for COVID-19. Taking part in all of these public health recommendations for stopping the spread of COVID-19 will work for all COVID-19 variants. The best way to stop variant strains from developing in the first place is to stop the spread of the virus. The dashboard will be updated once a week and available on the [VDH website](#).



Governor's Update

Governor Ralph Northam announced that sports and entertainment venues in Virginia may begin to operate with expanded capacity, and social gathering limits will increase beginning Saturday, May 15th. The announcement comes as vaccinations continue to rise in the Commonwealth, and more than half of all adults have received at least one dose of the COVID-19 vaccine. All Virginians age 16 and older are now eligible to for the vaccine. Governor Northam made the announcement in a [new video message](#).

The Commonwealth will continue to mandate mask-wearing and social distancing, even as commercial restrictions are further eased. Key changes in the Sixth Amended Executive Order Seventy-Two will include:

- Social gatherings: The maximum number of individuals permitted in a social gathering will increase to 100 people for indoor settings and 250 people for outdoor settings. Social gatherings are currently limited to 50 people indoors and 100 people outdoors.
- Entertainment venues: Indoor entertainment and public amusement venues will be able to operate at 50 percent capacity or 1,000 people, up from 30 percent capacity or 500 people. Outdoor venues will be able to operate at 50 percent capacity—up from 30 percent—with no specific cap on the number of attendees.
- Recreational sporting events: The number of spectators allowed at indoor recreational sporting events will increase from 100 to 250 spectators or 50 percent capacity, whichever is less. Outdoor recreational sporting events will increase from 500 to 1,000 people or 50 percent capacity, whichever is less.
- Alcohol sales: Restaurants may return to selling alcohol after midnight, and dining room closures will no longer be required between midnight and 5:00 a.m.
