Dear Broad Run Friends and Neighbors,

I want to start off this newsletter by announcing COVID-19 vaccines in Loudoun are now available to all individuals aged 16+ without the need to register ahead of time! You can now directly schedule an appointment online to receive a shot at Dulles Town Center. Please encourage everyone you are close with to receive their vaccine, especially since it is now much easier and streamlined to do so. To

There are several items of importance coming before the Board that affect the Broad Run District. I will explain in the following paragraphs these items based on when they appear before the Board of Supervisors chronologically.

At the April 20th business meeting, the Board received an update on the study, that began last summer, to analyze options for changing Loudoun's form of government. After receiving the [informational report](#), the Board decided to dispense with the study of an overall form of government change. However, the study on whether or not to form a police department is still ongoing. The International Association of Chiefs of Police was chosen to perform this study, with agreement from our current Sheriff. The final analysis on a police department will be presented to the Board of Supervisors in February 2022. Any establishment of a police department in Loudoun would require agreement of the county voters through a referendum.

At the May 4th business meeting, [an item](#) will be before the Board detailing the process the county is undertaking to adopt new airport noise districts in eastern Loudoun. This will update our existing noise districts that are currently guided by a Dulles Airport noise study from 1992. Dulles Airport performed a new study in 2019, which we are using to guide the new districts.

This past February, the Board began the 16-month plan to analyze how we should go about adopting the new districts. On Tuesday, the Board will likely direct the Transportation and Land Use Committee (on which I sit) to perform a mapping exercise later this month to better understand the changes from 1992 and 2019. Much of the Broad Run District is covered in some part by the airport noise districts; however, the Broad Run District does not have much change between 1992 and 2019. Most of the changes in noise occurred in the southern part of the county near Brambleton and South Riding. That being said, there will be opportunities for the public to better understand and provide input on the changes. As we move through this 16-month process, I will share the information as it becomes available.

Two development applications in the Broad Run District are before the Board of Supervisors at our May 12 public hearing. The first application is the Oak Grove residential rezoning application to build

50 townhouses on vacant land in the Oak Grove area of Sterling. The second application is Dulles 2000, which is to allow for the development of two data centers along the east side of Route 28 south of Old Ox Road, also in Sterling. Links to both of these items and more description can be found below in the land use section of the newsletter.

Additionally, at the May 12th public hearing, the public will have the opportunity to comment on Loudoun's draft Unmet Housing Needs Strategic Plan. This plan is a report from a years-long process spelling out how Loudoun can address our need for more accessible housing in the county. Five strategies the Board can undertake to meet this need are identified further down in the newsletter.

At the May 18th business meeting, the Board will vote on whether or not to direct staff to draft a collective bargaining ordinance allowing county employees to unionize. I will support this motion as I believe unions have been of great benefit to the American worker and have created professional environments that are more friendly to workers. This is the beginning of a months-long ordinance process that will have plenty of opportunity for public input. You can [read the item here](#).

Finally, I want to call your attention to two other items in this newsletter: the 2021 Democratic Primary and Broad Run seats that are available on Loudoun advisory bodies.

On June 8 the Democratic Primary for Governor, Lieutenant Governor, and Attorney General will take place. There is no Republican Primary this year as the Republican party is picking its candidates through the convention method. Virginia does not recognize party affiliation in voting, so all eligible voters in the Commonwealth are able to vote in the Democratic primary. Information on the candidates and options on how to submit a ballot are explained below.

There is also a newly available seat as the Broad Run District Representative on the Loudoun Transit Advisory Board. This is in addition to the already available Broad Run seat on the Parks, Recreation and Open Space Board. If you are interested in applying to either of these positions, please read more about them and fill out the linked application in the newsletter below.

COVID-19 Vaccine Online Self-Scheduling Now Open to Loudoun Residents, No Pre-Registration Required

Beginning Thursday, April 29, individuals 16 and over can directly schedule an appointment online to receive a free COVID-19 vaccine at the Loudoun County Health Department vaccination clinic located at Dulles Town Center in Sterling.

The Health Department encourages all unvaccinated people age 16 and older who live or work in the county to schedule an appointment as soon as possible by visiting loudoun.gov/covid19vaccine. The website includes a link to the online form where individuals can request an account to schedule an appointment. An email address or cell phone number may only be used once to create an account. If an email address or cell phone number was used during the pre-registration phase, that contact information cannot be used again.

After completing the form, individuals will automatically receive an email or text message from the CDC with a link to create an account in the Vaccine Administration Management System (VAMS) and schedule an appointment at the Loudoun County Health Department vaccination clinic. With this change, individuals no longer need to pre-register.

“We have exhausted the waitlist for those who have pre-registered in Loudoun County and this is an important step in streamlining vaccination and lowering barriers to appointments,” said Dr. David Goodfriend, director of the Loudoun County Health Department. “Vaccination is the best step we can take to reduce disease transmission and return to normal.”

Individuals who have pre-registered should have received an invitation to schedule a vaccine appointment. Anyone who has not received an invitation to schedule should check their email spam folder or go online to schedule an appointment now. The vaccination site continues to be by appointment only.

Anyone who needs assistance scheduling an appointment, including individuals who do not have internet access, can contact the Health Department at 703-737-8300, Monday-Sunday, 9:00 a.m. to 5:00 p.m.

Individuals under 18 must choose an appointment where Pfizer is offered and must have a parent or guardian present at the appointment. Vaccine types available will be noted during the scheduling process. The Johnson & Johnson vaccine will be available at the Loudoun vaccination site beginning Saturday, May 1, 2021.

2021 Virginia Democratic Primary Election

Tuesday, June 8, 2021 Democratic Primary Election

A Democratic Party primary election will be held in Loudoun County on Tuesday, June 8, 2021. Offices on the ballot will include Democratic Party nominees for Governor, Lieutenant Governor, and Attorney General. The Republican Party has chosen to conduct a

convention process to select their candidates, so there will not be a Republican Primary on this date. Read more about the election:

Virginia does not recognize party affiliation in voter registration; therefore, all registered Virginia voters are eligible to vote in the Democratic primary. There is no Republican primary taking place in any part of the Broad Run District.

 - In-person: Monday, May 17, 2021, at 5:00 p.m.
 - By-Mail: Postmarked no later than Monday, May 17, 2021, at 5:00 p.m.
- Early & Absentee Voting:
 - Early voting opens: Friday, April 23, 2021
 - Last day to request ballot be mailed to you: Friday, May 28, 2021, at 5:00 p.m.
 - Last day to vote absentee in-person: Saturday, June 5, 2021 (office will be open 8:30 a.m. to 5:00 p.m.)

Three Ways to Vote: Pick the Option that Works Best for You

All registered voters in Virginia now have the option to vote at home, vote early or vote on election day. No excuses required no matter your choice. Just click on the underlined title of the voting option you would like to visit that page for more information.

- [Vote at Home](#): We'll mail your ballot and important information to you. You'll fill it out following the instructions enclosed, and send it back.
- [Vote Early](#): Early voting will be available for all registered Loudoun County voters at the Office of Elections in Leesburg starting April 23, 2021 and at additional early voting centers in the final week before the election. There is no pre-application required to vote early in-person, simply check the locations, dates and times and go vote when it's most convenient for you!

- Note that if you have requested a ballot to be mailed to your home and you decide you'd rather vote early you must bring the ballot with you and trade in for a new one. Ballots begin mailing on April 23, so we advise voters to wait until at least April 30 to receive their ballot.
- **[Vote on Election Day](#)**: Polls will be open from 6:00 a.m. - 7:00 p.m. on Tuesday, June 8, 2021. Voters are encouraged to verify their registration information, and to double check their voting precinct at vote.virginia.gov to ensure they know their precinct number and are viewing the correct ballot.

Public Comment Invited on Loudoun County Draft Unmet Housing Needs Strategic Plan

As the Loudoun County Office of Housing finalizes the county's Unmet Housing Needs Strategic Plan (UHNSP), members of the public are invited to review the draft plan and share their feedback.

The strategic plan is designed to help the county and its partners improve housing access, quality and affordability for all families. It identifies strategies and actions to address unmet housing needs in a systematic and comprehensive way with integrated programs. The plan will also aim to create housing targets over the short term and the long term (the next five years).

The draft plan was presented to the Loudoun County Board of Supervisors at its April 6, 2021, business meeting. The Board's feedback and input from the public will be included in the final draft plan, which is scheduled to be presented to the Board at its May 12, 2021, public hearing.

- Establish a coordinated, collaborative and integrated housing network.
- Secure land resources needed to address unmet housing needs.
- Obtain viable funding sources.
- Provide incentives, establish priorities and increase access to affordable housing.
- Implement policy changes to support affordable housing production and preservation.

These five objectives and their associated key actions provide a comprehensive approach, based on research, best practice, and Loudoun County's specific housing needs and housing market, to start addressing the affordability gaps that exist in the county.

Loudoun to Implement New Ordinance Banning Firearms in County Facilities

Loudoun County is taking steps to enforce the recently amended [Chapter 684 of the Codified Ordinances of Loudoun County – Weapons and Explosives](#), which generally prohibits guns in county buildings, including community and recreation centers, and county-operated parks. The new section, [684.04 Possession of Firearms on County Property](#), was adopted by the Board of Supervisors on March 2, 2021.

The ordinance now prohibits the possession, carrying or transportation of any firearm or ammunition in:

- Buildings owned or used by Loudoun County;
- Any part of a building used by Loudoun County for public purposes even if not owned by the county; and
- Parks owned and operated by Loudoun County.

Exceptions to the new ordinance include:

- Sworn law enforcement officers;
- Private security personnel contracted by the county or hired for a county-permitted event;
- Concealed handgun carry permit holders visiting county parks;
- Active-duty military personnel performing official duties;

- Historical reenactors and participants in government-sponsored wildlife management events;
- Individuals participating in wildlife management activities; and
- Lawfully possessed firearms that are stored out of sight in a locked private vehicle.

Signage explaining the new rules is being placed at the entrances to Loudoun County facilities. Security screening stations will be installed at the Loudoun County Government Center and the Shenandoah Building in Leesburg and at the county government's service center located on Ridgetop Circle in Sterling. Signs prohibiting the carrying of weapons are already in place at preschools operated by the Department of Parks, Recreation and Community Services in compliance with [Section 18.2-308.1 of the Code of Virginia](#).

The Board of Supervisors [adopted changes](#) to Chapter 684 earlier this year after several months of consideration. In September 2020, the Board directed staff to prepare a draft ordinance to implement [Section 15.2-915 E of the Code of Virginia](#), which authorizes localities to prohibit the possession of firearms and ammunition in their facilities.

Online Public Map to Aid in Inventory of Confederate and Segregationist Sites, Names and Symbols in Loudoun

The Loudoun County Board of Supervisors has initiated a review of Confederate and segregationist symbols in Loudoun County. Members of the public are invited to participate in an informational inventory of roads, buildings, signs and other public infrastructure that memorialize Confederate and segregationist figures or history in Loudoun County by submitting such sites through a new online mapping tool.

A multi-departmental team, including staff from the Departments of Planning and Zoning and Transportation and Capital Infrastructure and the Office of Mapping and Geographic Information, is working to provide comprehensive information to the Board, which will consider these items and their history.

An [online map and survey](#) has been developed through which the public can submit information about items potentially named after or memorializing Confederate or segregationist figures, symbols and slogans in Loudoun County, including:

- Battlefields
- Buildings
- County-owned and Virginia Department of Transportation (VDOT)-owned road or street names
- Logos

- Markers or monuments
- Signs
- Other names or symbols in public spaces

The tool allows the public to submit a description of the features, pertinent historical information and map locations, as well as upload photos.

Schools and school mascots will not be included in this inventory as Loudoun County Public Schools is currently conducting an independent review of these items. The inventory will also be limited to public items that memorialize a Confederate leader, the Confederate cause, or individuals or movements that promoted and implemented racial segregation laws in Virginia during the eras of Jim Crow (1896-1965) and Massive Resistance to desegregation (1954-1959).

The county's expansive geography, combined with its complex history from the Civil War through desegregation, requires a comprehensive research effort to identify these objects and sites. By involving the public as well as local historians and community groups, the county plans to thoroughly inventory all possible Confederate and segregationist symbols throughout Loudoun. In addition to the public input tool, county staff will be working with community groups to identify these items.

Financial Resources and Updates

Board Adopts FY 2022 Budget; Lowers Tax Rate by 5.5 Cents

The Loudoun County Board of Supervisors has approved a budget totaling approximately \$3.3 billion in total appropriations for the general county government and school system for Fiscal Year (FY) 2022. The adopted budget includes a real property tax rate of \$0.980 per \$100 in assessed value, 5.5 cents lower than the current tax rate. [Read More](#).

A Message from the Loudoun Commissioner of the Revenue – COVID-19's Impact on Vehicle Values for 2021

Commissioner of the Revenue Robert S. Wertz Jr. wants vehicle owners in Loudoun County to know that they could see increases in their personal property tax bills that are due on May 5, 2021. This is not due to a tax rate increase or reduction in tax relief but instead is due to increases in used vehicle values. [Read More](#).

First Half Personal Property Tax Deadline is May 5, 2021

Loudoun County Treasurer H. Roger Zurn Jr. reminds taxpayers that the deadline for payment of the first half personal property tax is May 5, 2021. Payments received or postmarked after May 5, 2021, will incur a 10% late payment penalty. Additional interest at the rate of 10% per annum will be assessed. In addition to the late payment penalty for personal property taxes, if the taxes remain unpaid for 60 days after the original payment due date, the taxpayer will incur an additional 15% penalty of the total amount due. The due date will not be extended for bills where assessment questions have been filed with the Board of Equalization. VDOT 2021 Repaving and Resealing

VDOT has released their [map of roads that will be resurfaced in 2021](#). The exact dates for the road work are unknown at this time, as it is dependent on weather and contractor schedules. Resurfacing projects can last from a few days to a few weeks, depending on the size of the project.

- **Russell Branch Parkway** from Ashburn Village Boulevard to Loudoun County Parkway
- **Sally Ride Drive** from Davis Drive to Glenn Drive
- **Smith Switch Road** from Hasting Drive to Waxpool Road/Farmwell Road

The church is prohibited from using pesticides & excess fertilizers on the fields, and conveyed an acre of land to the county to be used for a future trail connection.

This project is located in Old Ashburn on land in between Ashburn Road, Jenkins Lane, and the Washington and Old Dominion trail. The project includes the construction of 18 single family homes with associated parking spaces, roadways, and sidewalks. This project was allowed by-right, which means a property owner has the right to construct and subdivide their land into certain uses without having to submit an application before the Board of Supervisors for approval. Current building demolition has occurred at the project location and site clearing/preparation has begun.



**Waterside/Waterside North

This project was approved by the Board of Supervisors in 2015 and encompasses most of the land bordered by the Innovation Avenue to the south, Route 28 (Sully Road) to the west, Old Ox Road to the north, and the Loudoun-Fairfax county line to the east. The project consists of filling in the recently closed quarry to create a centerpiece lake surrounded by high-density, high-rise spaces of residential, retail, commercial, cultural, and office uses. An application is under review to amend proffer triggers and the development layout.

This project, at the northwest corner of Ashburn Village Boulevard and Waxpool Road, was approved by the Broad of Supervisors on January 19, 2021 as a rezoning from a church property to high-density residential. The developer will build 384 multifamily units, including 44 attainable housing units. In addition to trails along the project frontage, a roundabout will be constructed at the intersection of Waxpool Road and Faulkner Parkway. If, for some reason, the developer is unable to construct the roundabout, they must pay the county \$9.6 million.


Ashburn Road Improvements **No Change**

[A study \(PDF\)](#) was completed on driver and pedestrian safety along the corridor of Ashburn Road between Gloucester Parkway and Farmwell Road/Ashburn Farm Parkway. The Board has allocated over \$300,000 for engineering and construction of the identified short-term solutions (page 12): additional signage, pavement reconfiguration, new pavement markings. The mid-term and the long-term recommendations were allocated to the "out years" for funding starting in 2026.



Belmont Ridge Road Widening

Dominion Energy's utility relocation is underway and pole relocation is being finalized, weather permitting. Utility relocation for other companies is at 25% completion and is scheduled to be fully completed in fall 2021. The construction contractor bid is expected to be advertised in Summer 2021. The storm water management plan is being revised in an effort to settle a land-acquisition dispute. Environmental and grading plans have been submitted. Croson Lane Widening


