## St. Louis Public Input Session

As promised at the St. Louis community meeting on April 27th, I have scheduled a special public input session for the residents of St. Louis on Wednesday, June 9th from 5:00 to 6:00 pm in the Board Room of the Government Center (1 Harrison Street, SE in Leesburg). The topic of this public input session is the Middleburg Preserve II property.

I have been working for years with the St. Louis community to try and find a solution to protect the 16.38-acre property called Middleburg Preserve II located in the rural historic village. The purpose of this meeting is to give the community an opportunity to give input and for the other Board of Supervisors to hear from the public.

At the April 20th Board business meeting, I moved that the Board direct staff to cease negotiations for the acquisition of the Middleburg Preserve II property. The motion passed 9-0. ## Vaccination for Ages 12 and Older

The Loudoun County Health Department is offering COVID-19 vaccinations by appointment to adolescents ages 12 to 15. The VDH approval for use of the Pfizer COVID-19 vaccine for individuals in this age group follows endorsements by the [Centers for Disease Control and Prevention \(CDC\)](#), the [CDC's Advisory Committee on Immunization Practices \(ACIP\)](#), and the [Food and Drug Administration \(FDA\)](#).

### How to Make an Appointment

The Loudoun County Health Department has streamlined the appointment-making process to make it easier for parents and others to schedule their own appointments online in one single step. Residents may now make appointments in real time without first registering in the Vaccine Administration Management System (VAMS). The system no longer requires users to wait for an e-mail that prompts them to schedule an appointment.

To schedule an appointment for your child or yourself, simply visit Loudoun County's [website](#) and then click on "Schedule A Vaccine Appointment" and follow the "Step 1" instructions. On the VAMS appointment page, [submit a request](#) for an appointment by following the prompts in the online form.

Anyone who needs assistance making an appointment, such as those who do not have access to the internet, should call the COVID-19 Information Line at 703-737-8300 Monday through Friday between 9:00 am and 5:00 pm, excluding holidays.

Individuals ages 12 to 17 must be accompanied by a parent or guardian. All individuals who would like to be vaccinated must have an appointment.
