The Board of Supervisors recently approved a new Parks and Recreation Master Plan and a new Linear Parks and Trails Plan (more on that below) to continue making improvements in these areas. We appreciate the work of our PRCS staff with citizens of all ages.



At the end of last month, the Board hosted its annual Transportation Summit to hear updates from VDOT, County staff, and other agencies on various transportation topics impacting the County. We received an update on our Countywide Transportation Plan, which supplements our General Plan, as well as a discussion on methods to streamline the traffic signal development process, which is something that I have been pushing for. Once again, I raised issues surrounding funding of major projects such as the Route 50 Northern Collector Road and the Route 50 and Loudoun County Parkway interchange. Those two projects combined could cost more than a half a billion dollars to construct and are outside the scope of what we could reasonably complete at the County level without significant assistance. I since have had some follow up discussions with the Deputy Secretary of Transportation, and we brought an item to the July Finance Committee meeting to discuss issues around

the project appropriations schedule, which has been an area of confusion with the Commonwealth.

the surgery because my vision has been severely impacted post-surgery. COVID-19 UPDATE

Latest Numbers and Updates

According to the official numbers released today by the Virginia Department of Health, there have been 28,600 confirmed cases of COVID-19 in Loudoun County. 283 individuals have died from the virus in Loudoun. Virginia now has 694,384 confirmed cases with 11,532 deaths. You can see these numbers yourself at the Loudoun County COVID-19 GeoHub.

Health officials report that over the past month, the number of new cases of COVID-19 have increased significantly in Loudoun County, in Virginia, and throughout the United States, fueled by the coronavirus Delta variant. Loudoun County is now averaging about 30 cases per day, up from about four cases per day in June. At the same time, Loudoun's percent positivity rate has increased from less than 1% to over 3% in the past few weeks. The vast majority of newly infected people are unvaccinated and includes individuals in all age groups.

Governor Northam announced on Thursday via a series of tweets that in keeping with updated CDC guidelines, all Virginians should once again wear a

mask in public indoor settings due to an increased risk of COVID-19 transmission. He stated that "this is not a requirement, but a recommendation." While there is not a mask mandate in place right now, I encourage you to consider wearing a mask in public and follow all proper mitigation practices so that we can slow down the spread of COVID-19 in our community. Loudoun's transmission level moved from the CDC's designation of "moderate" to "substantial" this week. We want to avoid getting back to the "high" transmission level we had during the worst of the pandemic.

Loudoun County Health Director Dr. David Goodfriend has also recommended to LCPS that students, teachers, and staff wear masks indoors during the school day once school resumes this August - regardless of whether or not they have been vaccinated. This recommendation comes as a result of the updated CDC guidance I mentioned above.

We are tracking the Delta variant of COVID-19 and its impact on Loudoun. The majority of cases in Northern Virginia are now the Delta variant, which is highly contagious and is also responsible for most current infections and hospitalizations nationwide. The Alpha variant (also highly contagious), which originated in the United Kingdom last year, is also present in Loudoun. It is crucial that everyone follow proper mitigation practices, especially if you haven't received a vaccine or are around those with immune system issues. It is important to note that the vast majority of deaths and serious COVID-19 cases are occurring among individuals who have not received the vaccine. I highly encourage everyone who is able to get the vaccine to do so and help slow and stop the spread in our area. If we are unsuccessful, more restrictions are likely on the way.

Latest News on Vaccination Efforts

As demand for COVID-19 vaccines in Loudoun County continues to decrease and as more providers in the community continue to offer the vaccine,

Loudoun County is adjusting the hours of operation at its Dulles Town Center clinic. These changes became effective Tuesday, July 27. In addition, the clinic will close permanently on the evening of Tuesday, August 24.

The clinic is currently open three days per week for walk-in vaccinations; however, the clinic is open one hour later on Tuesdays and closes three hours earlier on Fridays. The following hours are effective until August 24:

• Monday: Closed

• Tuesday: 4:00 – 6:30 p.m.

• Wednesday: Closed

• Thursday: Closed

• Friday: 9:30 a.m. – 12:00 p.m.

• Saturday: 9:30 a.m. – 12:00 p.m. (closed Aug. 14)

• Sunday: Closed

Please note that the clinic will be closed to the general public Saturday, August 14, for a closed vaccination event.

To review the current and future hours of operation at the Dulles Town Center vaccination clinic, and to make an appointment for a COVID-19 vaccination, visit the County's website at loudoun.gov/covid19vaccine.

Loudoun County's COVID-19 vaccination clinic at the Dulles Town Center will close permanently, effective at 6:30 p.m. on Tuesday, August 24, 2021.

The County will continue to provide first and second doses of the COVID-19 vaccine through the regularly scheduled hours on Tuesday, August 24; however, individuals who receive their first dose within 21 days (Pfizer) or 28 days (Moderna) of the clinic's closure must receive their second dose from another provider. Loudoun County will provide information to these individuals on where to receive their second dose.

Anyone age 12 and older who has not yet received a COVID-19 vaccine is encouraged to receive one as soon as possible. People may walk into the County's COVID-19 vaccination clinic at Dulles Town Center, 21090 Dulles Town Circle, Sterling, without an appointment to receive a COVID-19 vaccine. Anyone under 18 must be accompanied by a parent or legal guardian.

COVID-19 vaccines also are being offered through various community events in Loudoun County this summer. The next scheduled event is Saturday, August 7, 2021, from 11:00 a.m. – 6:00 p.m. at Bluemont Community Center, 33846 Snickersville Turnpike, Bluemont. DULLES UPDATES

Belmont Ridge Road Corridor Safety and Operational Study

At our July 6 Business Meeting, the Board directed staff to conduct a corridor safety and operational study of Belmont Ridge Road from Northstar Boulevard to Evergreen Mills Road. Residents from the Brambleton Community Association requested that the County initiate this study due to concerns regarding the speed limit, vehicle crashes, pedestrian and bicycle safety at the unsignalized intersections, and truck traffic. The study will also analyze future traffic operational conditions (our current projections do show a decrease in volume after the regional roadway network is completed in the Brambleton and Arcola Area, although completion is still many years away). The total study will cost \$419,850, utilizing funds that have been budgeted for Project Management Consulting Services. While most of the study will center in the Blue Ridge District, I wanted to make you aware of the study since Belmont Ridge crosses into the Dulles District and many of us use it to access Brambleton and Ashburn. I'll update you on the results of the study and recommended safety improvements once they are available.

Contract Awarded for Northstar Boulevard from Route 50 to Tall Cedars Parkway

At long last, I am excited to see more tangible signs of progress for the Northstar Boulevard project. A contract has been awarded to Shirley Contracting Company LLC for the construction of Northstar Boulevard from Route 50 to Tall Cedars Parkway in the amount of about \$18.7 million. The improvements will consist of two northbound lanes and two southbound lanes; associated turn lanes at the intersections of Tall Cedars Parkway, Marrwood Drive, and Route 50; and a 40 ft. wide grass median. Shirley Contracting is also constructing the northern segment of Northstar that will connect Route 50 to Evergreen Mills Road in Brambleton. We expect both projects to be completed within close timing to each other in 2024. Northstar Boulevard will be an important north/south connection to serve as an alternative to Loudoun County Parkway, Stone

Springs Boulevard, and Belmont Ridge Road. I'll update you on a more specific timeline as the contract is finalized and the contractor prepares to mobilize onsite.

VDOT Pavement Resurfacing Update

- Paving is complete on the northbound lanes of Gum Spring Road between Route 50 and Frontier Spring Drive. Striping is currently underway and should be completed soon, weather permitting.
- The application of latex coating on Millstream Drive, Riding Center Drive, and Eastgate View Drive has been completed. The contractor will be returning to apply pavement markings in mid-August after the latex coating has been fully cured.

DULLES LAND USE UPDATES

Dulles Landing Sign Plan Amendment *SIDP-2015-0008*

At our July 6 Business Meeting, the Board voted 8-0-1 to approve an application to allow two entrance signs at Dulles Landing, a previously approved 78 acre shopping center in the Blue Ridge District. One sign will be on Loudoun County Parkway. The center is anchored by Walmart, Dick's Sporting Goods, TJ Maxx, and more. I reported in my last newsletter that the size of the proposed signs had been an issue throughout the course of the application. At the June Public Hearing, I asked the applicant to commit to a max height of 21 feet in order to be consistent with the highest sign previously approved along the Route 50 corridor. The applicant agreed to this request and reduced the total square footage of each sign to 179.51 square feet, so I supported the application.

Signage at Dulles Landing is long overdue, and we heard from the applicant that they feel adding these signs will help business.

As we've discussed, access remains a major issue at Dulles Landing, but that's unrelated to their signage application.

Milestone Tower - Rock Ridge High School CMPT-2021-0001

At our July 20 Business Meeting, the Board unanimously approved the commission permit request for a 142 ft. cellular tower at Rock Ridge High School. The purpose of the tower is to provide upgrades and improvements to the area's network, as well as host private providers. Milestone, who will be developing the project, hosted an informational community meeting and a balloon fly earlier this year. A few residents expressed concerns at the meeting – mainly over 5G and its purported health effects. Currently, experts don't believe that 5G technology has any negative effects on the health of those in proximity. That being said, federal law prevents us from commenting on or taking into consideration the 5G discussion (the health aspect is exclusively handled by the FCC; we as the Board of Supervisors are responsible only for the land use component of the application). The location, extent, and character of the tower are consistent with our 2019 General Plan, which requires proposed telecommunications facilities to be on public use sites and be designed to minimize visual impact. In addition, the Board received a letter of support for the application from the Brambleton Community Association.

Arcola Grove Commercial ZMAP-2020-0010 & SPMI-2020-0013

The July Public Hearing also included an application to rezone 23.44 acres from Rural Commercial (RC) zoning to Planned Development – Industrial Park

(PD-IP) in the Arcola area. The property is located just to the north of the future Dulles West Boulevard and west of the future Arcola Boulevard in the Arcola area. The applicant is seeking to develop 600,000 sq. ft. in either warehouse or data center uses.

The proposal is consistent with the 2019 General Plan for employment uses in the area, but I have some concerns over how the applicant would intend to serve the site with power if it were to develop as a data center (they have included the potential of locating a substation onsite). The PD-IP zoning district requires distribution lines to be located underground, but that would not include transmission lines needed to connect a potential substation to the power grid.

I also have concerns about their Zoning Modification request to reduce the required 100 ft. building setback from Arcola Boulevard to 75 ft. Other development along Arcola Boulevard has been allowed to locate at 75 ft. since it was approved prior to that road's designation changing in 2019. However, the other uses that exist or are planned on the western side of Arcola Boulevard are townhome residential and retail, nothing to the size and scale of what is proposed with this application.

The Board voted to send the application to the September 8 Business Meeting for action in order to get additional information and resolution on these issues. Given the consistency with the General Plan and staff's recommendation, I expect this application to move forward, but I'm seeking resolution on the topics I've raised before it does.

LOUDOUN UPDATES

Countywide Linear Parks and Trails Plan

Back in 2019, the Board directed the Parks, Recreation, and Open Space (PROS) Board to develop a Countywide plan for the development and construction of public trails and linear parks. As we continue to build out transportation infrastructure around the County, we are becoming painfully aware of the locations in which missing links exist for trails and road connections. Through our legislative processes and proffer packages we have been able to build out some of this missing infrastructure, but having a comprehensive plan for the future of linear parks and trails in the County has been quite helpful.

At our July 6 Business Meeting, the Board approved the Linear Parks and Trails System Plan as provided in an update from staff. The plan included a scope of the work done so far and the timeline for the future. schedule updates, an insight into the current state of Loudoun's linear parks and trails, community survey results, and next steps (including the 10-year plan and the refining process for design guidelines). The primary tasks that are associated with the overall project and that are driving the work done by PROS include design elements to ensure aesthetic and mechanical integrity of parks and trails, financing to make sure the projects are delivered on time, community engagement to garner public input at every step of the process, and master planning of signature projects. Having this plan in place will serve as a guide for securing future right of way or easements to make connections.

The original drafts of the plan were light on the southern part of Loudoun. The lack of connectivity across Route 50 is a major impediment and will remain so until an overpass/interchange is built. However, there is the potential for connectivity with several other points that we asked PRCS staff to explore. The result is a new planned recreational trail utilizing the Cub Run Trail as an access point to the planned Elk Lick Preserve trail network located in Fairfax County on the south side of Braddock Road. The planned Broad Run Trail would

serve as a north/south corridor beginning in the southern Ashburn Area and running to Dulles South.

Next steps include the planning team reviewing the maps and methodology with the County and stakeholders, and refining data inputs in response to those discussions. This process will ensure that the final methodology included in the parks and trails maps accurately reflects the needs of Loudoun's communities. Staff provided us with a ten-year plan of action for implementing these projects, so the process involves a lot of long-term planning. I'll keep you updated in the future as things move forward. Real Estate Tax Relief for Elderly or Permanently Disabled Residents

At our July Public Hearing, the Board voted 7-0-2 to increase the maximum annual household income to qualify for real estate tax relief for elderly and permanently disabled residents. This update reflects cost of living increases. The changes will be enshrined in Loudoun's Codified Ordinances to take effect January 1, 2022, and the Board will review the program every four years to ensure future proofing against inflation and other issues. Tax relief was an important part of the County's fiscal response to the COVID-19 pandemic, and the more we can codify assistance for residents the better. Local Administration of the Loudoun Health Department

Each year, the Board of Supervisors adopts a Legislative Program that outlines initiatives we would like to see come to fruition with the General Assembly in Richmond. As part of the 2021 Legislative Program, the Board sought authorization from the GA for Loudoun County to enter into a contract with the Virginia Department of Health (VDH) to operate and locally administer the Loudoun Health Department (LHD). Legislation introduced by Senator Favola at the General Assembly allowed this transition to take place, and the Board voted at our July 20 Business Meeting to begin the steps to locally administer the LHD. Staff will now develop a contract with the VDH to account for financial aspects of the transition, as well as terms and conditions. The contract execution and conversion are expected to take about a year, but I'll keep you updated on the timeline in case we are able to accelerate it. Currently we are expecting to hear more next spring.

Local administration of the Health Department will allow for greater efficiency in day to day operations, as well as better allocation of resources based on the local knowledge of providers and doctors. Local administration will alleviate strain on dual systems being utilized by both the state and the locality and will allow for greater equity among employees. We saw both the VDH and LHD play a crucial role in the local response to the COVID-19 pandemic, but it is always better to remove red tape from a process as integral to community wellbeing as public health.

Most health departments are still administered by the state, but County-administered health departments do not eliminate any services required by law or operate below the required level of service. The health department will be run by a locally appointed director of health services who has intimate knowledge of the community they are serving. I was happy to see this change go forward.

Collective Bargaining for Public Employees

At our July 20 Business Meeting, the Board took another step toward implementing a collective bargaining ordinance with a 6-3 vote directing staff to finalize an ordinance authorizing the traditional model of collective bargaining and recognizing labor unions or other employee associations as bargaining agents for eligible County employees. The Board also voted 6-3 that a collective bargaining unit is authorized by a majority of those who vote in an election rather than a majority of those who work in the unit.

I voted against both motions. I have explained at length my objections to collective bargaining in the past, and I won't reiterate them all here. My major concern is that establishing a third party bargaining unit and codified contracts years in advance eliminates the County's pay for performance system, which has served us well during our period of growth and improved service delivery. It also necessitates millions of dollars in new staffing costs to manage labor relations, and it injects a layer between management and the Board that I think could hurt cohesion, innovation, and productivity.

During the entire debate, my colleagues have never pointed to any particular changes they want to see in the County's wage or benefit scales. Why? Because the Board has already taken steps to improve them, increase pay, and modernize benefits. There have been arguments about the past, specifically during the era of the Great Recession, in which cuts were made and workloads were too high in some areas. The Boards at the time were dealing with a true economic crisis and did their best to keep the lights on and people employed, so I don't think that is a fair example.

It was originally expected that a final ordinance would be presented at the July 20 meeting; however, that ordinance was not ready as the unions and the County are still apart on some terms. The Board

voted to send the ordinance to the October Public Hearing, where the public will have a chance to comment. The Board will also be having a closed session in September to discuss some of the outstanding issues, so I'll have more commentary as the conversation continues.

Proposed Cigarette Tax

At our July Public Hearing, the Board forwarded an ordinance to establish a cigarette tax to the September 8 Business Meeting for action. The General Assembly recently granted localities the authority to increase the cigarette tax rate. The state charges .60 a pack, but counties have not had the ability to tax cigarettes. Interestingly, through the quirk that is Virginia government, cities and towns have had that ability to and have done so for quite some time. In addition, Fairfax County was granted its own special exemption and is allowed to impose a County cigarette tax, which is set at .30 cents per pack.

The General Assembly is now allowing other counties to impose a tax of .40 cents per pack (2 cents per cigarette). Prince William County, Arlington, and Alexandria are moving forward with this tax, while Clarke County is setting their rate at .20 cents.

I am interested to see what Fairfax County decides to do. If they do not raise the rate, I would probably prefer that Loudoun set a rate to match Fairfax's .30. Even at .40, the overall level of taxation in Loudoun would be far less than in West Virginia and Maryland.

Inventory of Confederate and Segregationist Symbols

At our July 6 Business Meeting, the Board heard from staff an inventory of confederate and segregationist symbols located on public property or within the public right of way in Loudoun County. The Board had previously directed staff to compile the inventory and recommend steps that could be taken to eliminate such symbols. The Board asked staff to pay special attention to monuments that were erected to honor or memorialize confederate or segregationist figures or history. The inventory came back with about a dozen such names identified, around half of which were part of a single development in western Loudoun in which the streets were named after confederate generals.

The Board directed staff to develop a work plan (including a timeline, public engagement process, and cost estimates) to remove or change the identified confederate and segregationist symbols, including names of roads and public facilities. We also voted to remove the name of Kephart Landing in Leesburg (one of the identified locations) and have staff from Parks, Recreation, and Community Services submit new names for the landing. Finally, the Board directed staff to obtain cost estimates from consultants to conduct further research on building names that were not included in the inventory but whose origins are unknown. Two cost estimates will be brought before the Board in September: one based on a thorough review of all sites in the County and one based on the existing inventory of symbols that staff has already compiled. I think it will be very important to obtain public input and cost estimates on these changes. Some names are clearly more egregious than others, which have ambiguous origins or could have multiple meanings.

As a reminder, the process is currently underway to rename Route 7 (Harry Byrd Highway) and Route 50 (John Mosby Highway); there is information below on how to submit a proposal for new names.

Board Denies Sterling Rezoning

The Board of Supervisors voted to deny a request to rezone 4.73 acres in the Sterling area. The application

requested to change the zoning designation from single family residential to multifamily residential to allow 50 single family attached units near the W&OD Trail. I initially voted in favor of the application when it first came before the Board in early June. Although there were some concerns with the applicant not meeting commitments that had been made to other Supervisors, staff felt that the applicant was mitigating impacts. However, that vote failed 3-3 over concerns with proffer commitments and mitigation of impacts from some Board members. The tie vote (in part due to absent Supervisors) meant the application needed to be brought back before the Board in July when everyone was present. When the application came back, the applicant further reduced its proffer commitment, and no longer mitigated the impacts of the new development. The applicant also removed their Fire and Rescue contribution. With those changes, I could no longer support the application and voted to deny the rezoning, which failed 7-0-2. The applicant has now served the County with a lawsuit challenging the denial.

Submit New Names for Routes 50 & 7

Loudoun County is seeking public input for the renaming of Harry Byrd Highway (Route 7) and John Mosby Highway (Route 50). Members of the public are encouraged to submit names for consideration by the end of the day today, July 30, 2021. Details are available here.

New Loudoun Animal Services Facility

Loudoun County Transit Commuter Bus Service Adjustments

Loudoun County Transit will modify Commuter Bus Service beginning Monday, August 2, 2021. Due to changes in passenger demands, new Commuter Bus routes will be added to increase service at Dulles South (Stone Ridge II) and East Gate Park and Ride lots, and to add new service at Purcellville and Harmony Park and Ride lots. Schedules and stops for existing routes will also be modified. Details on the service adjustments are available online at loudoun.gov/buschanges and below:

New routes

• New Commuter Bus routes stopping at the Dulles South (Stone Ridge II) and East Gate Park and Ride lots will be added as follows:

- Route 284: two trips in the morning from Loudoun to the Pentagon.
- Route 684: two trips in the afternoon from the Pentagon to Loudoun.
- New Commuter Bus route stopping at Purcellville and Harmony Park and Ride Lots will be added as follows:
 - Route 483: one trip in the morning from Loudoun to Washington, D.C.
 - Route 883: one trip in the afternoon from Washington, D.C. to Loudoun

Route changes

- - Route 281: two trips in the morning from Loudoun to Washington, D.C. at newly scheduled times.
 - Route 481: five trips in the morning from Loudoun to Washington, D.C. at newly scheduled times.
 - Route 681: two trips in the afternoon from Washington, D.C. to Loudoun at newly scheduled times.
 - Route 881: five trips in the afternoon from Washington, D.C. to Loudoun at newly scheduled times.

Schedule changes

 Commuter Bus schedules for most existing morning and afternoon routes will change up to seven minutes. Riders are encouraged to review the August 2, 2021 Commuter Bus Schedule posted at <u>loudoun.gov/buschanges</u> to prepare for new arrival and departure times.

Loudoun County Transit has made operational changes following the guidance of local, state and national health authorities to reduce the risk of COVID-19 exposure on the system's buses.
