As we head into August, I hope everyone is having a pleasant summer and enjoying getting outdoors while we have the warm, sunny weather. During the month of August, the Board of Supervisors is on recess and does not hold any meetings. That being said, the

Broad Run team and I are still spending time in the office, so please feel free to email or call should you have any questions or concerns around the district.

I want to start off this newsletter by announcing that COVID-19 cases are rising again in Loudoun County. The Loudoun Health Department is still administering vaccinations at the Dulles Town Center vaccination site (at the old Nordstrom); however, this vaccination clinic will close on Tuesday, August 24. If you are researching the vaccine and its availability, more information can be found in the "COVID-19" section of this newsletter.

July has been a busy month for the Board of Supervisors, and many of the items we saw are returning this fall on our meeting agendas to receive input from county residents. On September 8, the Board will decided whether or not to institute \$0.40 tax on a packet of cigarettes sold in Loudoun. On October 13, the Board will consider a county ordinance to allow county government employees the ability to formally unionize (this does not include LCPS employees). The meeting on October 13 is a public hearing, and will not be the final determination from the Board on this item. The Board also gave the go ahead to begin the process of creating a county-run Health Department instead of the state-run Health Department we currently have. This is also not the final determination on the health department topic and is just one of several steps. I am inclined to support all of these initiatives as I believe they will make our county healthier, fairer, and run more smoothly. That being said, please feel free to email me your thoughts on any of the matters before the Board.



## **Loudoun Seeking Public Input to Rename Route 7 and Route 50**

Loudoun County is seeking public input for the renaming of Harry Byrd Highway (Route 7) and John Mosby Highway (Route 50). Members of the public are encouraged to visit the [renaming project page](#) to submit names for consideration.

Individuals should first use the county's [online tool](#) to check a proposed name against the naming criteria. In addition to meeting the local and state naming standards, the names should be appropriate to Loudoun County and northern Virginia history and culture, reflect the natural or cultural geography of Loudoun County, are not already used or sound like another street in Loudoun County, and are considerate, sensitive and respectful to all Loudoun County residents.

Then, individuals should submit names through an [online form](#), which is open now through Friday, July 23, 2021. The public submissions will be reviewed for regulatory compliance and to meet the local and state naming standards.

A task force, comprising representatives from throughout the community, will narrow the list down to ten alternate names for each roadway, which will be reviewed and approved by the Board of Supervisors in September. Following the board's review, the public will then rank the short list of names in order of preference. The Board of Supervisors will review the public's recommendations and approve the new names in December.

The approved name for each roadway will be sent to the Virginia Department of Transportation and the Commonwealth Transportation Board for ultimate approval.

In December 2020, the Loudoun County Board of Supervisors initiated the process of renaming Harry Byrd Highway (Route 7) and John Mosby Highway (Route 50) in collaboration with regional jurisdictions.

Route 7 extends across the entire county and connects with Clarke County to the west and Fairfax County to the east. Harry F. Byrd Sr. was the governor of Virginia from 1926 to 1930 and a U.S. senator from 1933 to 1965. A proponent of Virginia's highway system, he was an opponent of school desegregation. The State Highway Commission named Route 7 in memory of Harry Byrd on November 21, 1968.

Route 50 also extends across the entire county and connects with Fauquier County to the west and Fairfax County to the east with

portions of it weaving in and out of Fauquier County. The road is named John S. Mosby Highway in Fauquier County. Route 50 in Fairfax County immediately adjacent to Loudoun is named Lee Jackson Memorial Highway. The General Assembly named Route 50 in memory of John Singleton Mosby, a Confederate Army colonel, on April 1, 1982.

The renaming of these two roadways is one of two projects that have resulted from the Board's initiation, in September 2020, of a review of Confederate and segregationist symbols in the county.

## Dominion Energy's W&OD Trail Power Line Project

### Beaumeade to Pleasant View and Line 227

This project will rebuild an existing 230 kV electric transmission line conductor located in Ashburn. The 5.5-mile line project area is along the W&OD Trail. It connects from Dominion's Beaumeade Substation on Smith Switch Road, to Dominion's Ashburn Substation near Claiborne Parkway, and ends at Dominion's Pleasant View Substation off Cochran Mill Road in Leesburg. Dominion will complete work in two phases:



### Phase 1

Pre-construction activities are scheduled to begin August 2021 through late September 2021. Work will start at the eastern end of

Smith Switch Road and end just south of Claiborne Parkway at the Ashburn Substation.

- Minor right of way clearing will be conducted in the transmission line corridor around impacted structures along the W&OD gravel trail.
- Additional gravel access paths will be installed along the transmission line corridor.

## **Phase 2**

Construction activities will begin mid-September 2021 through December 2021.

- In preparation for the removal of the old transmission conductor and installation of the new transmission conductor, equipment will be staged along the electric transmission line corridor. Crews will have to climb some of the structures, while others can be accessed with a bucket truck for the installation.

Each phase will require the temporary closure of both the W&OD gravel and paved trails. However, during phase 1, only one trail will be closed at a time. Also, to ensure the safety of pedestrians and cyclists, flaggers and spotters will be onsite, and signs will be posted at specific locations to notify trail users of detours.

## **New Loudoun County Animal Services Facility to Open July**

Loudoun County invites members of the public to attend the ribbon cutting ceremony and a series of grand opening events for the new location of the Loudoun County Animal Services (LCAS) facility located just outside the Town of Leesburg adjacent to Philip A. Bolen Memorial Park. The ceremony marks the conclusion of more than two years of construction.

### **Grand Opening Events, July 31 – August 1**

The animal shelter will be open for regular business hours July 31 – August 1. Adoption hours will be 11:00 a.m. - 6:00 p.m.

In addition, throughout the weekend, LCAS will host a series of grand opening events that are free and open to the public. Some events require pre-registration.

- 11:00 a.m. - Noon, Touch-a-Truck: Meet a Humane Law Enforcement Officer, learn about their vehicle, equipment and how they help animals in Loudoun County.
- 11:00 a.m. - 5:00 p.m., Guided Tours: Guided tours of the new facility on the hour.
- 12:00 p.m., Busy Buddies: Join LCAS staff for animal enrichment activities and learn about the importance of keeping pets' minds busy! Volunteers of all ages are welcome.
- 4:00 p.m., Critters & Crafts: Kids of all ages are invited to the community room for a fun craft and animal activity!

### **Directions to the New Facility**

All visitors to the new Loudoun County Animal Services facility must access the site from Sycolin Road in Leesburg. From Sycolin Road, drivers should enter on Crosstrail Boulevard, pass by Segra Field and Bolen Park to Kincaid Boulevard, and finally to Adoption Drive. Guests are asked to park along Kincaid Boulevard.

NOTE: The new facility currently cannot be accessed via Kincaid Boulevard from Battlefield Parkway because the road is not yet open to through traffic north of Adoption Drive. GPS may direct you to this unopened route and therefore visitors are encouraged to follow the directions listed above and access the new facility from Sycolin Road. The Waze app provides correct guidance via Sycolin Road.

### **About the New Facility**

The new, 21,450-square-foot facility includes an animal shelter, replacing the existing shelter in Waterford. The new facility will serve as the operational headquarters of LCAS and will be the first public shelter in the United States to meet 100% of the Association of Shelter Veterinarians Animal Shelter Guidelines, the gold standard for animal sheltering.

The new facility also expands many of the existing services provided at the current animal shelter, including pet adoptions; humane law enforcement; housing of stray, abandoned, or relinquished companion animals; dog license sales; volunteer opportunities; dispatch services; educational programs; and pet retention counseling. In addition, for the first time, the new facility will feature a veterinary clinic and surgical suite for medical treatment of shelter pets.

### **Recreational Marijuana Became Legal in Virginia on July 1**

### VDOT 2021 Repaving and Resealing

VDOT has released their [map of roads that will be resurfaced in 2021](#). The exact dates for the road work are unknown at this time, as it is dependent on weather and contractor schedules. Resurfacing projects can last from a few days to a few weeks, depending on the size of the project.

## **COVID-19 Cases Increasing in Loudoun County; Health Officials Encourage Unvaccinated to Seek Vaccine**

Health officials report that over the past month, the number of new cases of COVID-19 have increased significantly in Loudoun County, in Virginia and throughout the United States, fueled by the coronavirus Delta variant.

Loudoun County is now averaging about 30 cases per day, up from about four cases per day in June. At the same time, Loudoun's percent positivity rate has increased from less than 1% to over 3% over the past few weeks. The vast majority of newly infected people are unvaccinated and include individuals in all age groups.

Health officials also have noted that among Loudoun residents who are vaccinated, the most likely risk factor for COVID-19 infection is another infected member of their household who is unvaccinated.

The Health Department strongly recommends that everyone age 12 years and older get a COVID-19 vaccine as soon as possible. Vaccine is free for everyone and widely available from many vaccine providers throughout Loudoun County.

Health officials strongly encourage anyone who is not yet fully vaccinated to continue wearing a mask in all public settings and to continue social distancing to protect yourself and others in the community. Everyone who is sick for any reason should stay home and get tested for COVID-19 if you exhibit [symptoms](#) or may have come in contact with a person who has COVID-19. ## **Walk-in Service Available at Loudoun COVID-19 Vaccination Clinic**

Effective July 27, the hours of operation at the county's Dulles Town Center clinic will change slightly. The clinic will continue to be open three days per week for walk-in vaccinations; however, the clinic will open one hour later on Tuesdays and close three hours earlier on Fridays.

## **Loudoun County Clinic to Close Permanently August 24**

As demand for COVID-19 vaccine from Loudoun County continues to decrease and as more providers in the community continue to offer COVID-19 vaccine, Loudoun County is adjusting the hours of operation at its Dulles Town Center clinic effective Tuesday, July 27, 2021. In addition, the clinic will close permanently on the evening of Tuesday, August 24, 2021.

## **COVID-19 Vaccination Clinic Hours Effective July 27 – August 24**

- Monday: Closed
- Tuesday: 4:00 – 6:30 p.m.
- Wednesday: Closed
- Thursday: Closed
- Friday: 9:30 a.m. – 12:00 p.m.
- Saturday: 9:30 a.m. – 12:00 p.m. (closed Aug. 14)
- Sunday: Closed

Please note that the clinic will be closed to the general public Saturday, August 14, for a closed vaccination event.

## **Second Doses of Vaccine**

The county will continue to provide first and second doses of COVID-19 vaccine through the regularly scheduled hours on Tuesday, August 24; however, individuals who receive their first dose within 21 days (Pfizer) or 28 days (Moderna) of the clinic's closure must receive their second dose from another COVID-19 vaccine provider.

Pfizer:

- People who receive their first dose of Pfizer vaccine on or before August 3, may receive their second dose by the time the clinic closes on August 24.
- People who receive their first dose of Pfizer vaccine between August 6 and August 24 must receive their second dose at a location other than the Dulles Town Center clinic. Loudoun County will provide information to these individuals on where to receive their second dose.

Moderna:

- People who receive their first dose of the Moderna vaccine on or before July 27 may receive their second dose by the time the clinic closes on August 24.
- People who receive their first dose of the Moderna vaccine between July 30 and August 24 must receive their second dose at a location other than the Dulles Town Center clinic. Loudoun County will provide information to these individuals on where to receive their second dose.

## Get a COVID-19 Vaccine

Anyone age 12 and older who has not yet received a COVID-19 vaccine is encouraged to receive one as soon as possible. People may walk into the county's COVID-19 vaccination clinic at Dulles Town Center, 21090 Dulles Town Circle, Sterling, without an appointment to receive a COVID-19 vaccine. Anyone under 18 must be accompanied by a parent or legal guardian.

## **Vaccine Safety and Efficacy**

COVID-19 vaccines continue to be safe and effective. New vaccines are typically studied in adults first, and then gradually include younger age groups. This is a standardized process intended to study a new vaccine in the safest way possible. Pfizer-BioNTech's request to expand use of the vaccine to 12- to 15-year-olds is based on data from [a clinical trial of 2,260 adolescents that showed](#) that the vaccine was safe and effective in this age group.

## **Requesting a Vaccination Record**

It is important that parents and everyone who receives a COVID-19 vaccine keep the vaccination card received at the time of vaccination. The Loudoun County Health Department does not provide vaccination records. If you lose the vaccination card and need a record of your vaccination, individuals who created VAMS accounts may obtain a copy of your record in the VAMS system by logging into your account at [vams.cdc.gov](https://vams.cdc.gov). In addition, you can contact VDH for a record by [submitting a request form online](#).

## **After Vaccination**

The CDC has published [\*\*guidance for fully vaccinated people\*\*](#); however, the CDC also recommends that even people who are fully vaccinated keep taking precautions in public places. The Loudoun County Health Department encourages Loudoun residents who received a COVID-19 vaccine to continue taking the steps that help prevent the spread of COVID-19, including:

- Avoid crowds of people.
- Stay 6 feet away from others who do not live in your household at all times until the CDC and VDH change these recommendations.
- Wear a face covering when in public to protect yourself and others
- Wash hands frequently.
- Avoid non-essential travel, particularly with unvaccinated people who do not live in your household.
- Avoid visiting unvaccinated people who are at [\*\*increased risk of severe illness or death from COVID-19\*\*](#).

It includes the construction of one flex-industrial office building and the associated parking lot. The building will be similar to those on the north side of Russell Branch Parkway along Ashbrook Place and Atwater Drive. Building construction will commence in the near future.

The developer will construct the remaining asphalt path on the northeastern side of Russell Branch Parkway from Savin Hill Drive to Ashbrook Place.





This project, at the southwest corner of Ashburn Village Boulevard and Waxpool Road, was approved by the Board of Supervisors in December 2019 as a rezoning from 1 residential unit per acre to 24 residential units per acre. Up to 254 residential units will be built. The developer is installing a series of sidewalks and trails to connect the area to the Metro station. The developer also dedicated around 70 acres of parkland to the County. Clearing of existing site vegetation has begun. Utility installation and road construction will commence soon.







By-right uses are allowed without approval from the Board of Supervisors. Building exterior shell and retaining wall/site work construction is underway and will continue for the foreseeable future.



[This project](#), located at the southwest corner of the Route 7/Route 28 interchange, was approved by the Board of Supervisors on April 20, 2021. The project is an alteration to the previously approved Kincora zoning and consists of allowing an additional 1,000 multi-family housing units (158 of which are attainable housing units), an additional 575,000 square feet of non-residential uses, approval of the two museum uses (NMISO and NVSC), and moves the Children's Science Center to a larger, 5-acre site backing to the Broad Run.

This project, approved by the Board of Supervisors in December 2002, allows for the construction of up to 6,000 residential units and up to 9,750,000 square feet of non-residential uses. The newest section of the project to be developed is near the intersection of Croson Lane and Old Ryan Road. There, Toll Brothers is building three bedrooms, two bathroom condos. Over the course of this project's build-out, the developers will install transportation and pedestrian improvements in the area.

These projects, located throughout Loudoun's "Data Center Alley," were approved by the Board of Supervisors in 2018 and 2019. Sidewalks and/or asphalt trails have been installed along the road frontages as part of these projects. Construction will last for the next several months.



### One Loudoun 2018

This project, at the southwest corner of Marblehead Drive and Loudoun County Parkway, was approved by the Board of Supervisors in November 2019 as a rezoning from commercial center to residential, to allow for the construction of 44 two-over-two multifamily units. Site preparation, utility placement, and construction have begun. The developer will construct a pedestrian bridge over Beaverdam Run on the west side of Loudoun County Parkway.



### One Loudoun 2021

ZCPA-2021-0002

The developers of One Loudoun have submitted a zoning amendment application to add an additional 1,954 multi-family residential units (including 98 attainable housing units) in the currently undeveloped sections of the community south of Route 7 and west of Loudoun County Parkway. The application is currently in the Loudoun County planning and zoning staff review process. The application has not yet been scheduled to appear before the Planning Commission nor the Board of Supervisors.



### Rivana at Innovation Station

ZMAP-2021-0003

**No Change**

This application is for a 103-acre transit-oriented development on the border of Loudoun and Fairfax counties.

The current plans for the Loudoun section of Rivana include: Nearly 2,000 multifamily housing units; 1.8 million square feet of Class-A office space; A 185,000-square-foot retail village; A 265-room boutique hotel; A network of green and public spaces, including an 11-acre park. Phase 1A is scheduled to open for tenants in 2024. The property is bounded by Route 28, the Dulles Toll Road, Innovation Avenue, and the county line with Fairfax.





The project includes the construction of 18 single family homes with associated parking spaces, roadways, and sidewalks. This project was allowed by-right, which means a property owner has the right to construct and subdivide their land into certain uses without having to submit an application before the Board of Supervisors for approval. Current building demolition has occurred at the project location and site clearing/preparation has begun.



**Waterside / Waterside North**

**No Change**

This project was approved by the Board of Supervisors in 2015 and encompasses most of the land bordered by the Innovation Avenue to the south, Route 28 (Sully Road) to the west, Old Ox Road to the north, and the Loudoun-Fairfax county line to the east. The project consists of filling in the recently closed quarry to create a centerpiece lake surrounded by high-density, high-rise spaces of residential, retail, commercial, cultural, and office uses. An application is under review to amend proffer triggers and the development layout.



### Children's Science Center

This project includes the construction of a [regional science center](#) through a multi-party agreement. **Barrister Drive**  
This project constructs an extension of Barrister Drive, from the existing terminus south of Loudoun County Parkway, to the east under the Dulles Greenway, then turning north to connect to the future Shellhorn Road extension. The

### Davis Drive Extension

The Davis Drive extension project constructed a four-lane, undivided roadway between Old Ox Road and the existing road that previously terminated at Transdulles Plaza. North designed the improvements, provided right-of-way and easements, and funded the construction. This project completes a major north-south alternative to Route 28.

### Davis Drive/Sterling Boulevard Intersection Improvements

### Farmwell Road Intersection Improvements **No Change**

Intersection Improvements along Farmwell Road, from Ashburn Road to Smith Switch/Waxpool Roads, are at 60% design plans. 100% design completion has been delayed until fall 2021 due to the discovery of newly placed underground utilities in the project area. Construction for the project is scheduled to begin in 2023 and end in fall 2025. The Board of Supervisors endorsed [the major project design elements](#) at its May 4th business meeting. Utility relocation activities continued and are substantially complete except for one utility. Finalization of the storm water management strategy and drainage report continued. In the next quarter, the advertisement package for contractor bids will be advertised in June 2021. Construction begins late 2021.



## **Metro Silver Line**






**Route 7 Corridor Study**  
The [draft study](#) examined existing and projected future conditions along Route 7, between Dranesville Road at the Fairfax County line to the Route 28 interchange. The study included an evaluation of the history of recent crashes, an analysis of existing traffic operations along the corridor, and travel demand forecasts. ### **Route 7 Additional Eastbound Lane Widening (from Loudoun County Parkway to Route 28)**


This project provides for the planning, design, right-of-way acquisition, and construction of an additional travel lane along eastbound Route 7 between the Loudoun County Parkway entrance ramp and the Route 28 exit ramp, to provide four continuous lanes between the two interchanges. The project is budgeted for \$6.2 million beginning with design in 2025 and construction completed in 2034.



### **Shellhorn Road and Sterling Boulevard Extension**

This project constructs an extension of Shellhorn road from the existing terminus at Loudoun County Parkway through to the existing Sterling Boulevard interchange at Route 28. Portions of the Shellhorn Road extension will follow the existing alignments of Lockridge and Moran Roads. The project is currently in the design stage and public comments are being accepted.



### **Waxpool Road Intersection Improvements I No Change**

This project funds intersection improvements and turn lanes at Waxpool Road and Pacific Boulevard, intersection improvements and turn lanes at Waxpool Road and Broderick Drive, and intersection improvements and turn lanes at Waxpool Road and Loudoun County Parkway.

Right-of-way authorization, land acquisition, and utility relocation are ongoing in coordination with VDOT. Construction is expected to begin in 2021. Project updates and information can be viewed [here](#).



### **Waxpool Road Intersection Improvements II No Change**

[A study](#) was completed on the safety of intersections along Waxpool Road from Demott Drive to Faulkner Parkway. Construction of the traffic signal at Demott Drive and Waxpool Road has begun. The Board allocated up to \$300,000 to install a four-way stop at the intersection of Ashburn and Waxpool Roads. Signage and brush trimming will occur at the intersection of Shellhorn and Waxpool Roads. A roundabout is slated to be installed at the Faulkner Parkway intersection by the Waxpool Crossing developer.
