Dear Broad Run Friends and Neighbors,

This month has been tough for the Broad Run community and Loudoun County as a whole. After learning of two sexual assaults that occurred in Ashburn high schools, I am devastated. As an educator for LCPS and a mother whose sons graduated from Broad

Run High School, I am devastated that a safe environment was not provided for our students, and that parents and children are now frustrated and concerned. I hope that whatever policies need to be changed, are changed, and I am confident that they will. However, there has been a lot of mis-information spread surrounding these incidents, and I encourage everyone to make sure you are receiving information from reliable sources. If you have any ideas or thoughts about what has occurred, please know that my line of communication is always open.

That being said, I would like to take a moment to introduce our new School Board Member for the Broad Run District: [Andrew Hoyler](#)! A brief write-up from Mr. Hoyler is included below, and I look forward to working with him during his time on the School Board.

An issue I have heard about multiple times from Broad Run constituents is the lack of nearby glass recycling options in Ashburn. Although glass is able to be recycled at your curb along with other recyclables, it is best recycled alone with similar glass items. I am pleased to say that for the Board of Supervisors meeting on November 3rd, I have submitted [an initiative](#) to have Loudoun's Department of General Services determine the cost and location of placing a purple glass recycling bin in the 20147 ZIP code of Ashburn. My hope is that within the next few months, county staff will return with a site and price determination so that we can have a more convenient option to recycle glass in the Broad Run District.

I also want to highlight a position that is available on the Loudoun County Transit Advisory Board representing the Broad Run District. This board works to advise the Board of Supervisors and Loudoun transit staff on how to improve the County's public transportation system. If you are interesting in holding this position, please apply through the link in the newsletter below.

Lastly, a few other items of interest that are in this addition of the Broad Run Bulletin. On Tuesday is a general election here in Virginia for our three executive offices and the House of Delegates. The Broad Run District is split between two House of Delegate districts, so please make sure to check your sample ballot before going to the polls on Tuesday. As always, there are updates on all the land use and transportation projects in the district. Additionally, there is

guidance from the Health Department and Dr. Goodfriend on how to ensure a healthy celebration of Halloween this year. I hope everyone can take some time this weekend to enjoy fall and have a safe and pleasant Halloween!

November 2, 2021 General Election Information

A general election will be held in Loudoun County on Tuesday, November 2, 2021. All registered voters in Loudoun County are eligible to vote in the general election. Offices on the ballot will include Governor, Lieutenant Governor, Attorney General, and seats in the Virginia House of Delegates. Three county government bond questions will also be on the ballot. Know When to Vote

Polls in Loudoun County will be open from 6:00 a.m. to 7:00 p.m., Tuesday, November 2, 2021.

Early voting continues in Loudoun through Saturday, October 30. Locations and hours for early voting are online at loudoun.gov/voteearly.

Absentee ballots may be dropped off at [more than one dozen locations in Loudoun](#) through October 30. If returned by mail, ballots must be postmarked no later than November 2. Voters may also drop off their ballots at the [Office of Elections and Voter Registration](#) (750 Miller Dr., SE, Leesburg) or any polling place up to 7:00 p.m. on November 2.

Note: Voters who have requested and received an absentee ballot by mail, but who then change their mind and want to vote in person, must bring the ballot with them to the polling place. This will likely also cause a longer-than-normal wait time for the voter because of the process involved in surrendering the ballot.

Know Where to Vote

Most voters will cast their ballots at their normal polling location. Anyone who is not sure about where to vote may check their voter registration card or look up their polling place and related information online at vote.elections.virginia.gov. A list of polling places in Loudoun is available at loudoun.gov/polls. Also, curbside voting is available at all polling places for individuals who have mobility issues.

Bring Identification and a Face Covering

Voters will be asked to show an [**acceptable form of identification**](#), such as a Virginia DMV-issued driver's license. Voters who do not have an acceptable form of ID can sign an ID statement affirming their identity and they will be able to vote a regular ballot. Due to the COVID-10 pandemic, voters are required to wear a face covering when entering a polling place.

Halloween Guidance: Outdoor Trick-or-Treating in Small Groups

Loudoun County offers COVID-19 prevention guidance for celebrating Halloween this year. Outdoor trick-or-treating: Yes; Indoor parties: No.

The signs of Halloween are all around us - pumpkins, decorations, costume pop-up shops and children asking if they can go trick-or-treating this year. If you're planning to celebrate Halloween or other fall occasions, such as Dia de los Muertos, health officials advise that outdoor activities involving small groups, such as trick-or-treating in your neighborhood, are the safest. However, we all still need to take precautions against the spread of COVID-19.

"Any type of activity should be planned with the knowledge that all children under the age of 12 have not yet been vaccinated against COVID-19," said Loudoun County Health Director Dr. David Goodfriend. "I would discourage indoor parties, particularly if not everyone is vaccinated. Any parties involving children under age 12 or include individuals who are not vaccinated should be small and outdoors."

Dr. Goodfriend recommends:

- Trick-or-treating outdoors in small groups or hosting a small outdoor gathering.
- Incorporating a face covering into a child's costume (over the age of 2).
- If giving out candy, consider individual bags to hand out or a contactless option such as a candy chute.
- Washing your hands before going trick-or-treating or handing out candy. Hand sanitizer should be used while trick-or-treating or handing out candy when soap and water aren't available.
- Maintaining physical distancing from people not in your household or who have not been vaccinated.

Flu Shot/COVID-19 Vaccine

Other ways to protect yourself and your family include getting a flu shot before Halloween. "We encourage everyone to get a flu shot as soon as possible because it takes about two weeks for the flu vaccine to be fully effective. Unless told otherwise by your doctor, everyone 6 months and older should consider being vaccinated for the flu," said Dr. Goodfriend.

Dr. Goodfriend also encourages everyone above the age of 12 who has not already received a COVID-19 vaccine to get vaccinated as soon as possible.

COVID-19 and flu vaccines can be administered at the same time. Both are available at medical offices and pharmacies including, but not limited to, CVS, Giant Food, Harris Teeter, Safeway, Walgreens, Walmart and Wegmans. Flu vaccine is not available at the county site.

In addition to vaccination, to help curb the spread of COVID-19, the Health Department recommends everyone:

- Wear a mask in indoor public settings
- Stay 6 feet away from people who do not live in your household
- Cover your coughs and sneezes
- Wash your hands frequently
- Stay home when sick
- Avoid contact with sick people
- Know the [signs and symptoms of COVID-19](#) and remember to get tested if you're symptomatic, or if potentially exposed to COVID-19, regardless of your vaccination status.

Board of Supervisors Adopts Unmet Housing Needs Strategic Plan

The Loudoun County Board of Supervisors has adopted the Unmet Housing Needs Strategic Plan (UHNSP), which is designed to help the county and its partners improve housing access, quality and affordability for all families. The plan identifies strategies and actions to address unmet housing needs in a systematic and comprehensive way with integrated programs. The plan also creates housing targets over the short term and the long term.

Plan Objectives

The UHNSP has five objectives with specific strategies and key actions that will help the county address housing needs:

- Establish a coordinated, collaborative and integrated housing network.
- Secure land resources needed to address unmet housing needs.
- Obtain viable funding sources.
- Provide incentives, establish priorities and increase access to affordable housing.
- Implement policy changes to support affordable housing production and preservation.

These five objectives and their associated key actions provide a comprehensive approach to begin to address the affordability gaps that exist in the county. This approach is based on research, best practices and Loudoun County's specific housing needs and housing market.

Attainable Housing Goal

The UHNSP sets an attainable housing goal for 2040 of 16,000 units; this goal falls in line with the land use planning policies of the [Loudoun County 2019 Comprehensive Plan](#), which calls for 20 percent of forecasted new Loudoun housing to be affordable housing. This would add 8,200 new affordable housing units to the supply by 2040. An additional 7,800 affordable housing units would be developed from existing housing.

Developing the Plan

The Board of Supervisors initiated the process of developing the UHNSP in September 2019 with public participation as a key element. In addition to comments made directly to members of the Board of Supervisors, members of the public were encouraged to attend community meetings about the plan and respond to an online survey on housing, community development needs and fair housing issues.

Loudoun to Offer J&J and Moderna COVID-19 Booster Doses in Addition to Pfizer to Eligible Groups

The Virginia Department of Health (VDH) has authorized local health districts to begin administering booster doses of the Johnson & Johnson (J&J) and Moderna COVID-19 vaccines for certain individuals as recommended by the Centers for Disease Control and Prevention (CDC), and authorized by the Food and Drug Administration. House of Delegates 2022 Session Page Program

The Page Program curriculum has been updated and now includes more educational, professional and leadership components in the 2022 year. The goal will be for House pages to develop and practice skills in leading others while serving those around them.

2021-2022 Step Up Loudoun Youth Competition

Registration for this year's Step Up Loudoun Youth Competition is open until December 17, 2021 and costs \$25 per participant. Held annually since 2010, the Step Up Loudoun Youth Competition is a program of Loudoun Youth, Inc., in partnership with the Morven Park Center for Civic Impact and the Youth Advisory Council. 
Community blood supply in Northern Virginia is critically low.

Dominion Powerlines Proposal and Public Meeting

Dominion Energy is holding a Virtual Community Meeting on Thursday, November 18, 2021 at 5:00pm regarding a proposal to install power lines across Route 28. The proposal involves running galvanized steel, tower transmission lines from an existing power substation at the southwest corner of the Gloucester Parkway/Pacific Boulevard intersection to serve the three new data centers being constructed at Dulles Town Center. The substation, along with new transmission infrastructure, is needed to accommodate load growth and to maintain reliable electric service in the area. Proposed routes for this double circuit transmission line are estimated to be 1.5 miles to 2.5 miles long, and if approved, will connect transmission lines at the BECO Substation to the new DTC Substation east of Route 28. Intersection Improvements along Farmwell Road, from Ashburn Road to Smith Switch/Waxpool Roads, are at 60% design plans. 100% design completion has been delayed until spring 2022 due to the discovery of newly placed underground utilities in the project area. Construction for the project is scheduled to begin in 2023 and end in fall 2025. The Board of Supervisors endorsed [the major project design elements](#) at its May 4th business meeting. Supervisor Glass worked with the Ashburn Village HOA to minimize

George Washington Boulevard/Route 7 Overpass **No Change**

[This VDOT project](#) provides for construction of a bridge over Route 7 connecting George Washington Boulevard in the north with Russell Branch Parkway in the south. This project has a budget of \$27.3 million, financed with federal and state funds. In this quarter, right-of-way acquisition activities continued. Utility relocation activities continued and are substantially complete except for one utility. Finalization of the storm water management strategy and drainage report continued. The construction contract was



Loudoun County Parkway Widening **No Change**

This project provides for the widening of Loudoun County Parkway (Route 607) from four to six lanes between Ryan Road (Route 772) and Shellhorn Road (Route 643), and the construction of turn lanes at the intersections. Construction of the roadway improvements are proffer conditions of the Silver District West development; however, the proffer requires the County assist the developer in acquiring right-of-way at a cost of \$2.7 million. Construction of the widening is

- **Demott Drive and Mooreview Parkway:** Traffic signal operational in late 2021
- **Mooreview Parkway and Old Ryan Road:** Traffic signal operational by late 2021
- **Shellhorn Road and Hartley Place:** Crosswalk installation and turn movement limitations completed in 2025


estimated to begin within the next year with construction completed within twenty-four months after commencement of the project.



Moorefield Boulevard Extension No Change

This project provides for the developer-funded design and widening of Moorefield Boulevard from Mooreview

to get 7000-series railcars safely back into service. Trains will continue operating every 15-20 minutes on the Red Line and every 30-40 minutes on all other lines. Silver Line service will continue to operate between Wiehle-Reston East and Federal Center SW only. Customers are encouraged, where it makes sense for them, to use Metrobus service as an alternative. Old Ox Road Widening

Parkway to Old Ryan Road, and the construction of a traffic signal at Moorefield Boulevard and Mooreview Parkway. This project also includes construction of a county-funded traffic signal at Moorefield Boulevard and Old Ryan Road. The Moorefield Boulevard/Old Ryan Road traffic signal is also at 30% design stages and is expected to be at 100% design in fall 2021 after a delay. The developer-funded traffic signal at Moorefield Boulevard and Mooreview Parkway is anticipated to be installed by the end of summer 2021 with installation beginning in spring 2021. Design of this traffic signal is 100% complete.




**Prentice Drive Extension
No Change**

This project provides for the design, right-of-way acquisition, and construction of the widening of Old Ox Road from four to six lanes from Route 28 to the county line. Currently, this project is a proffered project by the developers of the Waterside community as part of its transportation contributions. However, after unexpected and inflated costs, the developer has [asked Loudoun County](#) to take over the remainder of the project. County takeover of this project was recommended for approval by the Planning Commission.




Route 7 Additional Eastbound Lane Widening (from Loudoun County Parkway to Route 28)
No Change

This project provides for the design, right-of-way acquisition, and construction of a new segment of Prentice Drive in Ashburn and Sterling from Lockridge Road to Loudoun County Parkway. The roadway will be a four-lane roadway with turn lanes, on-road bike lanes, and sidewalks. Design completion is currently estimated for summer 2023. Route 7 Corridor Study No Change
The [draft study](#) examined existing and projected


This project provides for the planning, design, right-of-way acquisition, and construction of an additional travel lane along eastbound Route 7 between the Loudoun County Parkway entrance ramp and the Route 28 exit ramp, to provide four continuous lanes between the two interchanges. The project is budgeted for \$6.2 million beginning with design in 2025 and construction completed in 2034.



Route 28 / Dulles Toll Road Interchange Study

Completed in spring 2021, a study was performed to assess traffic movements and safety measures at the interchange between Route 28, the Dulles


conditions along Route 7, between Dranesville Road at the Fairfax County line to the Route 28 interchange. The study included an evaluation of the history of recent crashes, an analysis of existing traffic operations along the corridor, and travel demand forecasts. Shellhorn Road and Sterling Boulevard Extension **No Change**

This project constructs an extension of Shellhorn road from the existing terminus at Loudoun County Parkway


Toll Road, and the Dulles Greenway (also encompassing the interchanges between Route 28 and Innovation Avenue and Old Ox Road). The study identified a preferred "mega project" that will address much of the congestion and safety concerns along this corridor. Waxpool Road Intersection Improvements I No Change

This project funds intersection improvements and turn lanes at Waxpool Road and Pacific Boulevard, intersection improvements and turn lanes at Waxpool Road and Broderick Drive, and intersection improvements and

through to the existing Sterling Boulevard interchange at Route 28. Portions of the Shellhorn Road extension will follow the existing alignments of Lockridge and Moran Roads. Waxpool Road Intersection Improvements II No Change

A [study](#) was completed on the safety of intersections along Waxpool Road from Demott Drive to Faulkner Parkway. Construction of the traffic signal at Demott Drive and Waxpool Road is underway. The Board allocated up to

turn lanes at Waxpool Road and Loudoun County Parkway. Right-of-way authorization, land acquisition, and utility relocation are ongoing in coordination with VDOT. Construction is expected to begin in 2022. Project information can be found [here](#) and [here](#).
