Investing in Transportation

Washington & Old Dominion (W&OD) Trail Bridge over Sterling Boulevard: A virtual meeting will be held Wednesday, March 23rd from 6:00 – 7:00 pm to learn more, ask questions and provide input about the project. Members of the public must [sign up in advance](#) to ask questions during the event by March 22nd at 12:00 pm. Online participants may also send questions to the project team as Q&A messages, which will be answered during the meeting as time allows.

The proposed project provides for the design and construction of a W&OD pedestrian/bike bridge over Sterling Boulevard (Route 846). Sterling Boulevard is Loudoun County's only four-lane roadway that crosses the W&OD Trail. When complete, the pedestrian/bike overpass will separate pedestrians, bicyclists, horseback riders, and other users of the W&OD Trail from roadway traffic on Sterling Boulevard.



Route 690 Traffic and Safety Improvement Study: The online public comment period to gain input on the Hillsboro Road (Route 690) Traffic and Safety Improvement Study is

open through March 23rd. To watch a recorded presentation and submit a comment, visit the [project page](#).

Loudoun County is conducting a study to proactively examine travel conditions and analyze current and future traffic volumes along Hillsboro Road. The study's recommendations will identify any operational or safety improvements that would be needed to accommodate the changes in future travel patterns of this roadway.

Limited Access Control Change at Planned Crosstrail Boulevard Extension: The online public comment period on the proposed changes to limited access control on Route 267/Dulles Greenway that will result from the extension of Crosstrail Boulevard from Sycolin Road to the Dulles Greenway is open through March 30th. The configuration of the break/opening in limited access control must be adjusted to accommodate the planned extension of Crosstrail Boulevard from Sycolin Road to the Dulles Greenway and to close access to Shreve Mill Road between the Dulles Greenway and Sycolin Road. The Crosstrail Boulevard Extension project provides for the design and the construction of a new four-lane, median-divided road between Sycolin Road and the Dulles Greenway interchange. It includes a four-span bridge over the south tributary to Sycolin Creek and shared-use paths on both sides of the new road.
