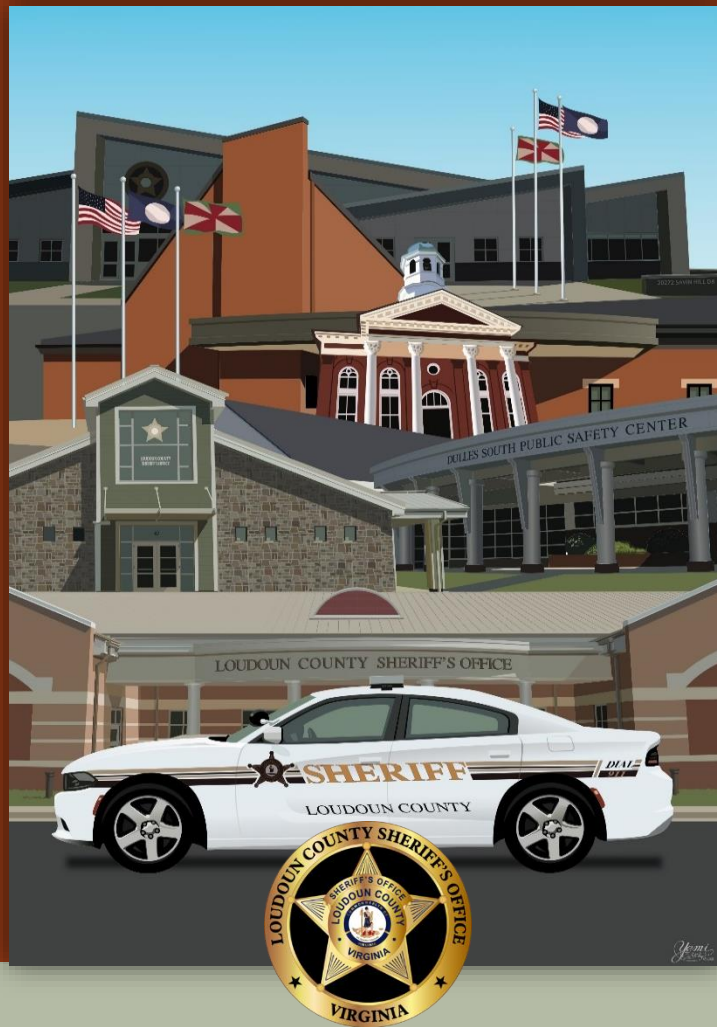
**BACKGROUND:** The Sheriff's Office compiles various reports to ensure information dissemination to senior staff and affected personnel of significant incidents, crime analysis and traffic issues. Because many of these reports contain sensitive and confidential information, they are not released outside of the department. Additionally, State law governs the dissemination of records, criminal history and other law enforcement information and provides penalties for improper release. To inform the public, a brief activity summary that complies with applicable law is prepared daily by the Sheriff's Office Media Relations and Communications Section and disseminated to the media, the Board of Supervisors, and other interested parties.

The statistics summarized in the Sheriff's Significant Incident Report and submitted quarterly to the Board of Supervisors are Significant Incidents, Continuing Trends, Part 1 Crimes, and Agency Highlights.

### **SIGNIFICANT INCIDENTS**

#### **Shooting Suspect Arrested**

July 1, 2022

A 17-year-old from Sterling was charged on July 1 in connection with the June 11 shooting of three people on N. Fillmore Avenue.

The juvenile was charged with one count of Attempted Aggravated Murder, three counts of Malicious Wounding, and four counts of Use of a Firearm During the Commission of a Felony.

LCSO Deputies initially responded to the area of N. Fillmore Avenue near Fletcher Road shortly after 7:30 p.m. on June 11 where an adult female victim was located suffering gunshot wounds. Two additional victims who were suffering minor injuries later returned to the scene. All three victims were later released from the hospital.

#### **Three Charged in Over \$250,000 Embezzlement Scheme**

July 27, 2022

Three men have been charged in connection with an embezzlement scheme where they created employees through a third-party temp agency and falsified timesheets for a total of \$257,086.

In May 2022, representatives from Beckstrom Electric learned of possible embezzlement from their company by an employee. Through the course of the investigation, detectives with the Loudoun County Sheriff's Office Financial Crimes Unit determined that two employees with the electrical company conspired with the owner of R Gonzales Sheet Metal, LLC and 3RG and Systems, LLC, a third-party temp agency that provides temporary part-time workers. The three created fake employees and began charging wages via timesheets to Beckstrom Electric for workers that were never on the job site. The scheme started in December 2020 and continued until it was discovered in May 2022.

During the investigation, detectives also determined that the three suspects were stealing scrap copper from job sites and selling it to local scrap metal dealers for a total of \$46,823.

The three suspects were arrested in July 2022 following the conclusion of the investigation.

#### **Homicide Suspect Arrested**

August 15, 2022

On August 14, 2022, Deputies responded to the 45100 block of Waterpointe Terrace in Ashburn, for the report of an injured person. Upon arrival deputies located an adult male who was assaulted and suffering from life-threatening injuries. The victim subsequently passed away as a result of his injuries. Detective quickly obtained suspect information and on August 15, 2022, deputies from the Frederick County, Maryland, Sheriff's Office (FCSO) assisted the Loudoun County Sheriff's Office and successfully executed a search and seizure warrant and detained the suspect, Ever Cruz, age 24, from Ashburn, Virginia. Cruz has been charged with Second Degree Murder.

## **Bank Robbery Suspect Sentenced to 25 Years in a Federal Prison**

August 24, 2022

The United States Attorney's Office for the Eastern District of Virginia announced that the suspect arrested following an LCSO investigation into a January 2021 Sterling bank robbery was sentenced to 25 years in federal prison for brandishing a firearm during the robbery he committed less than a year after being released from prison for a previous string of armed bank robberies.

According to court documents, between 2007 and 2008, Amobi Chibuza Agu, 37, committed seven-armed bank robberies in the Eastern District of Virginia and the District of Maryland. Court records show Agu was convicted in federal court of armed bank robbery and brandishing a firearm during and in relation to a crime of violence in 2008 and was sentenced to prison, where he remained until March 2020.

According to court filings, on the morning of January 2, 2021, Agu robbed the Bank of America located in Dulles Crossing Plaza in Sterling. During the course of the robbery, Agu brandished a handgun at a bank teller and an unarmed security guard. More from the United States Attorney's Office here: <https://bit.ly/3clBI2H>.



## **Daughter Charged in the Shooting Death of her Father**

September 7, 2022

LCSO Deputies responded to a home in the 42200 block of Fording Branch Court shortly after 10 p.m. on September 7 for a reported shooting inside a home. Jeffrey A. Carroll of Leesburg was located deceased inside the home.

Alicia R. Carroll, 28, was taken into custody by responding deputies a short distance away from the home.

Carroll is charged with Second-Degree Murder, Use of a Firearm During the Commission of a Felony and Shooting in the Commission of a Felony. She is being held at the Loudoun County Adult Detention Center on no bond.

## **Herndon Man Charged with Second-Degree Murder, Grand Larceny in Death Investigation**

October 1, 2022

Mario R. Hernandez-Navarrate, 19, of Herndon is facing charges of second-degree murder and grand larceny following the death investigation of a Leesburg man.

The Loudoun County Sheriff's Office responded to a residence in the 21000 block of Evergreen Mills Road Friday after receiving a check the welfare call. An adult male was found deceased inside the home. The investigation was conducted in coordination with the Office of the Chief Medical Examiner and the manner of death was determined to be homicide.

The victim has been identified as 62-year-old Carroll T. Davis, Jr. of Leesburg. The suspect and the victim were known to each other and there are currently no other persons of interest in this investigation.

Hernandez-Navarrate was apprehended Friday after he was involved in a vehicle crash in the victim's vehicle in Fairfax County. He was arrested by the Virginia State Police on unrelated charges. He remains held at the Fairfax County Adult Detention Center on no bond.

## Loudoun County Sheriff's Office AWARDS

### Members Receive 2022 Public Service Awards

September 20, 2022

Members of the LCSO were recognized on September 20 by the United States Attorney's Office of the Eastern District of Virginia (EDVA-Alexandria Division) at the 2022 Public Service Awards for their roles in two multi-jurisdictional investigations that led to successful federal prosecutions.

Sgt. Duane Rosa accepted an award on behalf of the LCSO in an investigation that began in Loudoun County, Virginia in 2017. The multi-year investigation led to the largest seizure of illegal drugs in the history of Loudoun County and dismantled a transnational drug trafficking organization tied to the Sinaloa Cartel. Due to the sensitive nature of the work of the detective involved in the investigation, their photo and name are not included.

Detective Michael Rivera was recognized for his work with the Fairfax County Police Department, the US Postal Service, and the IRS in investigating into a counterfeit COVID-19 stimulus checks scheme. According to court documents, a Reston man stole U.S. mail addressed to more than 150 individuals in Fairfax and Loudoun Counties between approximately December 2019 and August 2020. The mail he stole included bank statements, credit cards, credit card statements, W-2 forms, and more than \$700,000 in checks, including a COVID-19 stimulus payment and checks, used to create counterfeit checks.

### LCSO Investigator Receives Virginia Homicide Investigator of the Year Award

October 6, 2022

Congratulations to Detective Tonmy Rodriguez, the recipient of the 2021 Virginia Homicide Investigators Association's (VHIA) "Homicide Investigator of the Year" award. Det. Rodriguez was recognized for his outstanding efforts as the lead Detective on a homicide in Loudoun County. The case spanned several months and involved a complex, multi-jurisdictional investigation which ultimately led to the arrest of two men.





“I am proud of Detective Rodriguez’s efforts to investigate and bring to justice those who were responsible for this heinous crime against a member of our community. This was an immensely complex case that required a lot of thoroughness, time, and effort on Detective Rodriguez’s part, and his hard work and diligence paid off,” said Sheriff Mike Chapman.

## **LCSO Detective Recognized as Domestic Violence Project Partner of the Year**

September 30, 2022

Sgt. Nancy Johnson was recognized as Domestic Violence Project Partner of the Year at the 6th Annual Corks for a Cause benefiting LAWS Loudoun Abused Women's Shelter/Domestic Violence & Sexual Assault Services.

Sergeant Johnson joined the LCSO in October of 1996 and is the Domestic Violence Unit Supervisor in the Criminal Investigation Division. The unit reviews all domestic-related incidents reported to the LCSO and works to ensure survivors stay safe.



The LCSO is part of a coordinated community response, called Loudoun DART, whose mission is to connect families with the services and resources available to them in Loudoun. The Corks for a Cause fundraiser was hosted by Breaux Vineyards.

### **Private School Safety Summit**

August 17, 2022

The Loudoun County Sheriff's Office held its first ever Private School Safety Summit at the LCSO Ashburn Station. Representatives from numerous private schools were in attendance. Attendees listened to presentations on response to active violence incidents, school security assessments, the School Resource Officer program, and patrol response to school incidents.

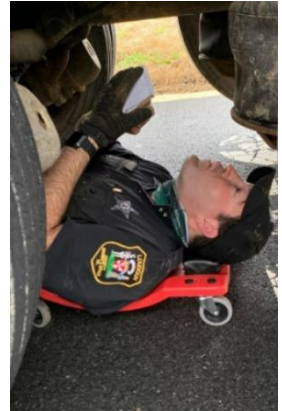


## Commercial Vehicle Enforcement Operation

August 24, 2022

Members of the Fairfax County Police Department and the Fauquier County Sheriff's Office assisted the LCSO Motor Carrier Safety Unit, with a commercial motor vehicle enforcement operation on Belmont Ridge Road in Ashburn. Of the 31 trucks inspected, 14 were taken out of service for violations such as defective tires, defective suspension, defective brakes, and unsecured loads.

Members of the LCSO Motor Carrier Safety Unit are responsible for detecting and inspecting unsafe commercial motor vehicles. Members of this unit have received certification from the Federal Department of Transportation to perform these duties.



## Pulling for a Cause

September 17, 2022

LCSO members, family and friends helped the LCSO on September 17 at the Dulles Plane Pull for Special Olympics. LCSO's participation in this year's event was coordinated by Detectives Rachel Burnett and Lindsey Sayre following 20 years of coordination by Captain TJ DeLitta.



The event involves twenty-five member teams from law enforcement and the private sector competing to see how quickly they can pull a plane. The LCSO raised \$6,500 for Special Olympics Virginia placing 9th out of 98 teams for fundraising.

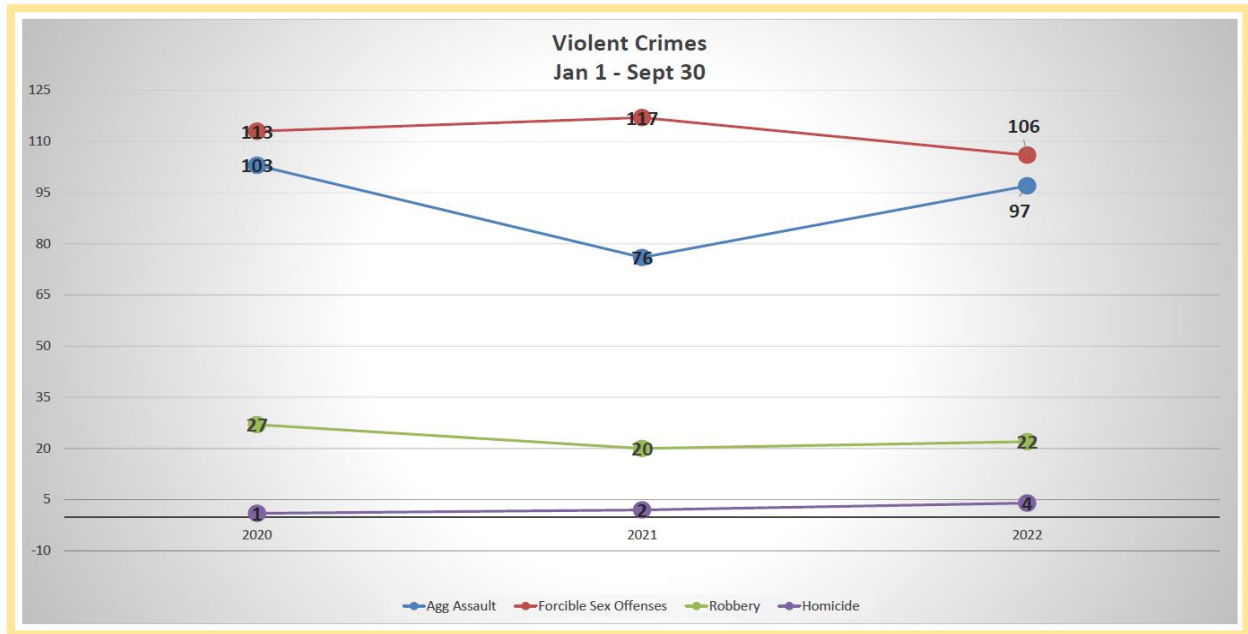
## COUNTYWIDE CRIME STATISTICS

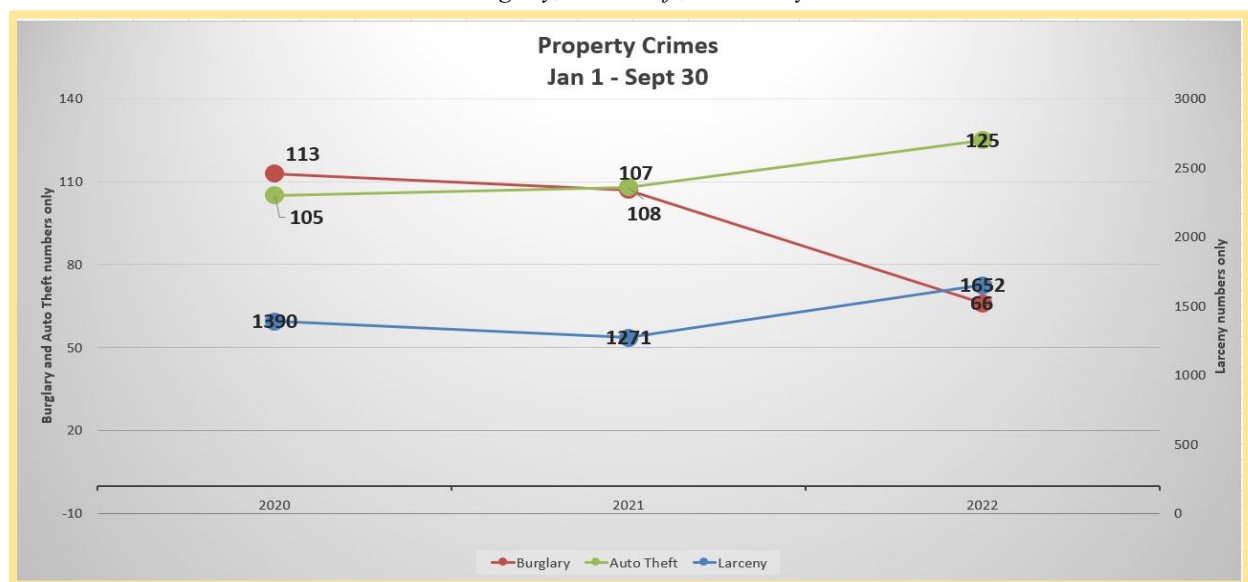
### VIOLENT CRIMES: January 1 – September 30, 2022

## Loudoun County Sheriff's Office COMMUNITY POLICING ACT DATA

Traffic stop data from the Loudoun County Sheriff's Office is available online as part of the Virginia Community Policing Act. The Virginia Community Act requires that each time a local law-enforcement officer or State Police officer stops a driver of a motor vehicle the officer collect the following data based on the officer's observation or information provided to the officer by the driver:

- (i) the race, ethnicity, age, and gender of the person stopped;
- (ii) the reason for the stop;
- (iii) the location of the stop;
- (iv) whether a warning, written citation, or summons was issued or whether any persons were arrested;
- (v) if a warning, written citation, or summons was issued or an arrest was made, the warning provided, violation charged, or crime charged;
- (vi) whether the vehicle or any person was searched; and
- (vii) whether any person used physical force against any officers and whether the law-enforcement officer or State Police officer used physical force against any person.

### Significant Incidents:

#### Ashburn Man Arrested for Multiple Offenses

July 26, 2022

Deputies responded to the Costco, 21300 block Price Cascades Plaza, Sterling, for a reported larceny in progress. When two deputies confronted the subject, Sady Ashkar, he began to resist the deputies. Ashkar continued to resist and assaulted the two deputies as they were attempting to place him under arrest. At one point the subject tackled a deputy, grabbed the deputy's taser, and threw it. He also attempted to grab the deputy's holstered firearm. Other deputies responded and Ashkar was placed under arrest.

Sady Ashkar, 32 of Ashburn was served on multiple warrants for assault on law enforcement and rescue personnel, attempting to disarm a law enforcement officer, resisting arrest, and larceny/shoplifting-related charges.

#### McDonald's Robbery Arrest

August 3, 2022

Shortly before 11 p.m. on August 3, a silver Chevrolet sedan pulled up to the drive-thru window to complete an order at the McDonald's located at 275 Free Court. A rear seat passenger in the vehicle made a cash payment but then asked to order another item. As the order was being processed, the subject exited the vehicle, reached through the drive-thru window, and grabbed the cash drawer before fleeing the scene in the car.

Two suspects in the robbery have been identified and are being held in Montgomery County, MD.

#### Seven Subjects Charged for Assault and Robbery

September 15, 2022

LCSO Deputies responded to the 21300 block of Windmill Parc Drive, Sterling, for a report of a group of young adults fighting in a parking lot. One of the subjects reportedly had brandished a stun gun. Prior to law enforcement's arrival, the altercation had stopped, and multiple subjects had left the area. One teenager was found to be injured after being assaulted by multiple subjects and was later taken to a local hospital for treatment. A cell phone was also reportedly taken from a female during the incident and was recovered.

The seven subjects ranged in age from 18-21 with charges of Assault by Mob and Robbery.

# LCSO Investigating Increased Car Thefts from Dealerships – WJLA (ABC 7 News)

September 21, 2022

“The Loudoun County Sheriff’s Office is doing special outreach to car dealerships this week, trying to raise awareness about a recent string of thefts.

Investigators say a growing number of cars are being stolen right off the dealerships’ lots.

"In the last month, we've had an increase in thefts from car dealerships," said Captain David Hill with the Loudoun County Sheriff's Office. "So, in relation to that, we're coming out here to conduct increased education and crime prevention efforts to try to teach dealerships techniques and strategies to better protect their fleets." ### Significant Incidents:

#### Massage Therapist Arrested for Sex Offenses Committed During Massages

July 27, 2022

A 20-year-old massage therapist was arrested and charged July 7 for sex offenses he committed while performing massages on two female victims at a business in Ashburn.

Patrick Erlandsen of Leesburg was charged following an investigation by the Detectives with the LCSO Special Victims Unit with two counts of Aggravated Sexual Battery and one count of Attempted Object Sexual Penetration. The charges stem from two separate incidents at The NOW Massage located on Thorndike Street in Ashburn. The first incident was reported on July 2 and occurred the previous day, with the second incident occurring on July 7, 2022.

#### Ashburn Man Charged with Unlawful Filming / Child Pornography

July 30, 2022

Detectives began investigating a complaint involving an employee of the CVS on Ruby Drive in Leesburg who was taking photos (“upskirting”) of a female customer

While detectives were investigating this case, they discovered multiple files of child pornography on his cellular phone.

Aruj Shrestha, 19 of Leesburg was charged with seven counts of Possession of Child Pornography (felony) and one count of Unlawful Filming (misdemeanor). Shrestha turned himself into the LCSO and is being held at the Loudoun County Adult Detention Center on no bond.

#### Larceny from Vehicle Arrest

September 20, 2022

Deputies responded to the 43400 block of Postrail Square, Ashburn, for a report of two people going into cars. Deputies located the subjects and upon making contact, a male subject fled. Deputies were able to locate him a short distance away. The second subject, a female, also fled the area on foot and remains outstanding. The male subject was carrying a backpack and deputies located items taken from vehicles inside.

Joseph M. Edwards, 18 of Ashburn was charged with 11 counts: six counts of Fraud - Theft of Credit Card, two counts of Larceny, two counts of Vehicle Tampering, and one count of Obstruction of Justice.

### Significant Incidents:

#### Fatal Traffic Crash

August 20, 2022

LCSO responded to Pleasant Valley Road and Detrick Way in South Riding to assist the Loudoun County Combined Fire Rescue Systems after an adult female passenger reportedly exited a moving vehicle and suffered life-threatening injuries. A preliminary investigation found the driver of a 2013 Ford box truck was traveling northbound on Pleasant Valley Road south of Detrick Way. At that time, the driver and an independent witness in the area reported the victim jumped out the front passenger door of the truck as the vehicle was moving. She was taken to a local hospital where she died.

#### LCSO Assists Cabarrus County Sheriff's Office in Arrest for Sexual Exploitation of a Minor

August 24, 2022

Cabarrus County Sheriff's Office Media Release: On 6/12/2022, Detectives with the Cabarrus County (North Carolina) Sheriff's Office received a report involving the Sexual Exploitation of a Minor. The parents of a thirteen-year-old female found that an adult male was engaging in sexual conversation with the juvenile utilizing an instant messaging social platform. An investigation was initiated, and it was discovered that the adult male was sending/capturing images of child pornography and sending the images back to the juvenile victim. The suspect was identified as Joshua Spencer Howard. A Warrant for Arrest for First Degree Sexual Exploitation of a minor was issued on 8/22/2022.

During this investigation, Detectives with the Loudoun County Sheriff's Office in Leesburg, Virginia assisted Detectives with the Cabarrus County Sheriff's Office. On 8/24/2022 Detectives with Cabarrus County Sheriff's Office traveled to Loudoun County, Virginia to participate in a search warrant at the suspect's home. Cabarrus County Detectives alongside Loudoun County Sheriff's Office conducted a search warrant on a residence located in Chantilly, Virginia. Once the search warrant was executed, Joshua Spencer Howard was arrested on the North Carolina warrant for arrest. Joshua Spencer Howard was processed at the Loudoun County Adult Detention Center located in Leesburg, VA. Currently, Joshua Spencer Howard is under a no bond hold and is awaiting extradition to Cabarrus County.

### Significant Incidents:

#### Carjacking Arrest

August 20, 2022

Collin R. Guilford, of Greenville, North Carolina was charged after a crash involving a stolen vehicle out of Fairfax and attempting to carjack several vehicles.

#### Vehicle Crash / Assault on Law Enforcement Officer / Wanted Person

September 14, 2022

Deputies responded to the 17500 block of Harmony Church Road, Hamilton for a report of a single vehicle crash. As deputies arrived at the location and began talking with the two subjects. One of the subjects, Andrew Hill, began to walk away from the scene and as the deputy was attempting to detain him, the subject assaulted the deputy.
