BACKGROUND: The Loudoun County Sheriff's Office compiles a variety of reports to ensure information dissemination to senior staff and affected personnel of significant incidents, crime analysis and traffic issues. Because many of these reports contain sensitive and confidential information, they are not released outside of the department. Additionally, State law governs the dissemination of records, criminal history and other law enforcement information and provides penalties for improper release. To inform the public, a brief activity summary that complies with applicable law is prepared daily by the Sheriff's Office Media Relations and Communications Section and disseminated to the media, the Board of Supervisors, and other interested parties.

The statistics that are summarized in the Sheriff's Significant Incident Report and submitted to the Board of Supervisors on a quarterly basis are Significant Incidents, Continuing Trends, Part 1 Crimes and Agency Highlights.

*Crime statistics are based on reports submitted to RMS as of January 19, 2023, for the period of January 1 – December 31, 2022 (UCR Reporting). *

SIGNIFICANT INCIDENTS

Ronald Roldan Pleads Guilty to Second Degree Murder for Killing Bethany Anne Decker in January 2011

November 18, 2022

Ronald Roldan entered a guilty plea to second-degree murder. Bethany Anne Decker was five months pregnant when she went missing on January 29, 2011. Bethany's body has not been found. Sentencing for Roldan is set for February 21, 2023. The LCSO Cold Case Unit, established in 2012, has done an extensive amount of work on this case and all of our cold cases – we never give up.



Hamilton Man Charged in Domestic Related Homicide

January 2, 2023

A Hamilton man has been charged with Second-Degree Murder stemming from a domestic-related stabbing that occurred early this morning at a residence in Hamilton.

Shortly before 6 a.m., Loudoun County Deputies responded to the 17000 block of Twinoaks Place for a reported stabbing. Upon arrival, deputies located 62-year-old David Brown inside, suffering from life-threatening injuries. Mr. Brown was pronounced deceased at the scene.



His son, 24-year-old Angus Brown of Hamilton, was taken into custody by responding deputies near the home without incident and was immediately charged.

Brown is charged with Second-Degree Murder and Shoot, Stab, Cut or Wound in the Commission of a Felony. He is being held at the Loudoun County Adult Detention Center without bond.

Second Person Charged in Connection with June 2022 Shooting on N. Fillmore Avenue

January 6, 2023

A Reston man has been arrested and charged in connection with the June 11, 2022, shooting of three people on N. Fillmore Avenue in Sterling.

On January 5, 2023, Isaias Lainez-Alvarado, 19, of Reston, was arrested at a residence in Reston and charged with six felony charges. Lainez-Alvarado has been charged with three counts of Use of a Firearm in Commission of a Felony and three counts of Malicious Wounding.

Lainez-Alvarado was transported to the Loudoun County Adult Detention Center, where he was ordered held without bond.

Another person, a juvenile from Sterling, was arrested and charged in June 2022 for the same incident. The teenager was charged with one count of Attempted Aggravated Murder, three counts of Malicious Wounding, and four counts of Use of a Firearm During the Commission of a Felony.

LCSO Deputies initially responded to the area of N. Fillmore Avenue near Fletcher Road shortly after 7:30 p.m. on June 11, 2022, where an adult female victim was located suffering gunshot wounds. Two additional victims also suffered minor injuries and later returned to the scene. All three victims were later released from the hospital.

The LCSO would like to thank the United States Marshals Service and the Fairfax County Police Department for their assistance in arresting Lainez-Alvarado.

Crash Fatalities Up in 2022

January 1 - December 31, 2022

Fatal crashes in Loudoun County were up 113% over 2021. In 2022, there were 17 fatal crashes, four of them being alcohol related. Deputies will continue enforcement of our roadways and we continue to partner with organizations such as WRAP and MADD.

In December, the LCSO Motor Units began a special operation; Saturation Areas for Enforcement (SAFE). The operation focuses on conducting enhanced traffic enforcement on Loudoun County roadways including reducing reckless driving, speeding, drunk driving, and other risky behaviors.

As part of the LCSO's further commitment, a deputy has been assigned to each station to handle traffic complaints and concerns.

Loudoun County Named Safest County in Virginia by Metropolitan Washington Council of Governments

Released October 31, 2022

The Annual Report on Crime & Crime Control evaluates crime trends in the metropolitan Washington for 2021 and regional initiatives by law enforcement to combat crime.

Loudoun County ranked number one in Virginia and number two in the region for Part I crimes at 5.3 per 1,000 people. The Frederick County Sheriff's Office in Maryland came in first at 4.9 per 1,000 people. Following the Loudoun County Sheriff's Office was the City of Manassas Park at 10.5 per 1,000. This clearly shows the LCSO as a leader in crime prevention in the region.

The LCSO is proud of our continued commitment to the citizens of Loudoun County.

COMMUNITY POLICING ACT DATA

Traffic stop data from the Loudoun County Sheriff's Office is available online as part of the Virginia Community Policing Act. The Virginia Community Act requires that each time a local law-enforcement officer or State Police officer stops a driver of a motor vehicle, the officer collect the following data based on the officer's observation or information provided to the officer by the driver:

- (i) the race, ethnicity, age, and gender of the person stopped;
- (ii) the reason for the stop;
- (iii) the location of the stop;
- (iv) whether a warning, written citation, or summons was issued or whether any persons were arrested;
- (v) if a warning, written citation, or summons was issued or an arrest was made, the warning provided, violation charged, or crime charged;
- (vi) whether the vehicle or any person was searched; and
- (vii) whether any person used physical force against any officers and whether the law-enforcement officer or State Police officer used physical force against any person.

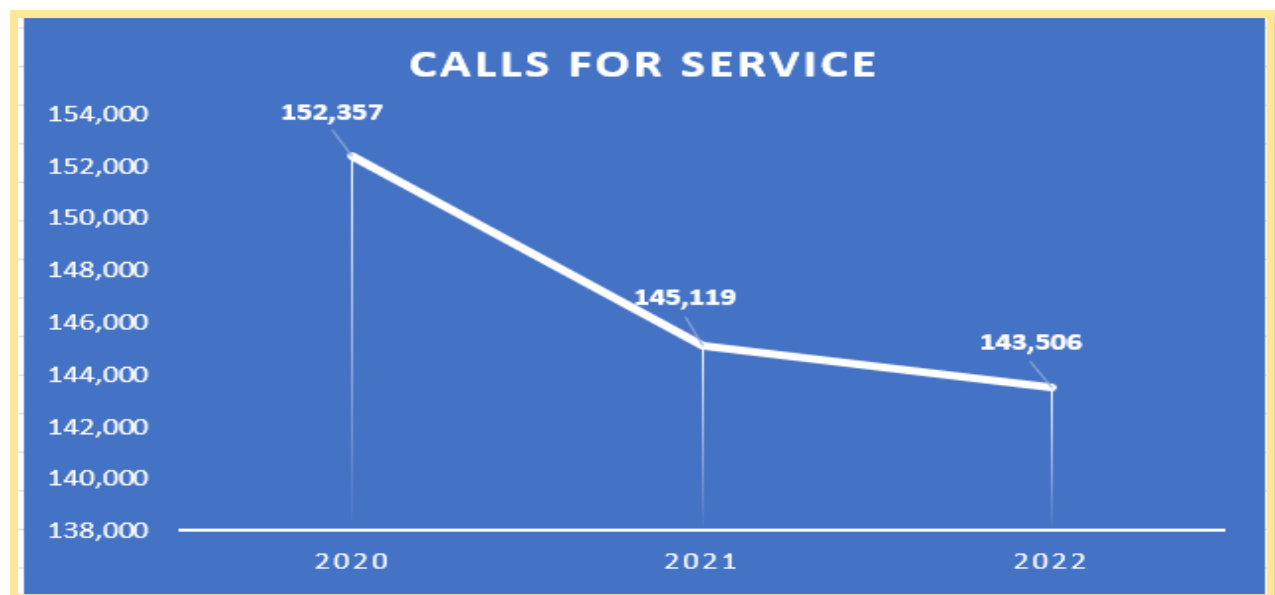

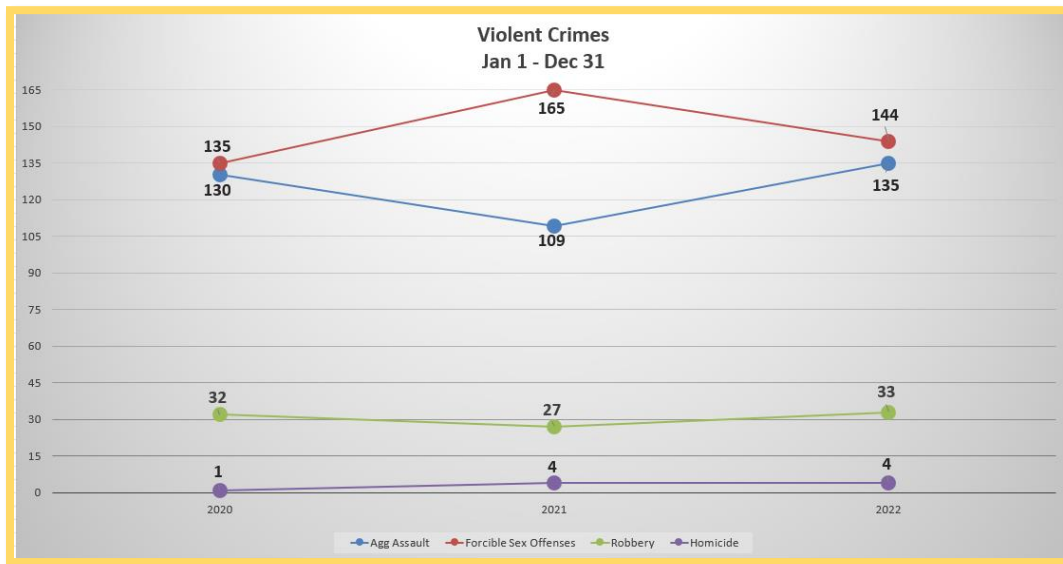

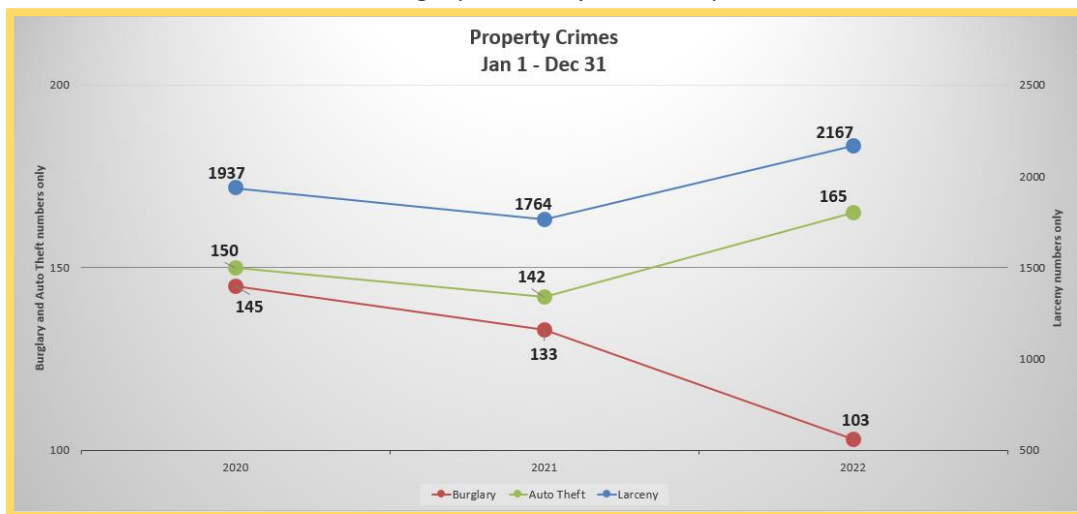
VIOLENT CRIMES: January 1 – December 31, 2022

Eastern Loudoun Station Significant Incidents:

LCSO Investigating Robbery in Sterling

November 27, 2022

Shortly before 7:30 pm on November 27, 2022, a female entered the Family Dollar store in the 300 block of Enterprise Street, Sterling. At one point, she walked up to the counter, displayed a firearm, and demanded money before leaving the store.

The subject is described as a White female, slim build, wearing a black hat, black mask, oversized blue and black plaid flannel jacket, black jeans, and black boots. This case remains under investigation.

Malicious Wounding

December 2, 2022

Deputies responded to 21820 Penny Oak Terrace, Sterling for a report of a stabbing. Safa Murtaza, age 30, of Sterling became upset with a family member and threw a knife at him. When deputies arrived, they performed life saving measures on the victim. The victim was transported to a local area hospital and later released. The suspect was charged with Assault and Malicious Wounding.

Vape Store Larcenies

November 30, 2022

On November 30, Detective Roque was conducting a follow-up at Loudoun Tobacco, reference a previous larceny. As he parked his vehicle, Det. Roque observed four juvenile males who appeared to be casing the business. Two of the males were wearing the same sneakers from a larceny incident the day before. Det. Roque remained in his vehicle, observed the suspects, and relayed information to dispatch.

Detective Roque witnessed the subjects run from the store when they heard the sirens of the incoming patrol units. Deputies were able to detain three of the subjects. The subjects may be responsible for multiple larcenies from vape shops in the area. All the subjects are juveniles.

Ashburn Station Significant Incidents:

Daycare Employee Charged with Child Abuse

November 7, 2022

On November 7, 2022, at approximately 5:00 pm., the LCSO responded to a local area hospital for a report of an infant suffering from life-threatening injuries. Detectives with the Loudoun County Sheriff's Office Special Victims Unit conducted an investigation into the incident and determined that the injuries occurred while the infant was in the care of an employee at the Winwood Children's Center, 43200 block Hay Road in Ashburn.

On November 18, Shabana Saleem, age 50, of Ashburn was arrested and charged with Child Abuse and Neglect. Furthermore, Shabana Saleem did not render aid to the infant after the injuries.

Commercial Burglary Series at DC United Performance Center

August - October 2022

Four burglaries occurred during overnight hours between August and October at the DC United Performance Center. The Suspects took DC United and Washington Spirit merchandise. Deputies were able to make arrests after the suspects were seen on security cameras. The investigation led to additional arrests with nine felony warrants served and a large amount of the merchandise returned.

Commercial Burglary at PC Mobile

August 21, 2022

A sledgehammer was used to force entry into the PC Mobile store and a large amount of electronics were taken. The suspects were identified through committing similar crimes around the region. The LCSO worked with the Calvert County Sheriff's Office, Prince George's County Police, Pennsylvania State Police, Hanover (PA) Police, Manassas City Police, and Homeland Security Investigations. The Ashburn Station Detective assisted with search warrants that were executed in two locations in Prince George's County (MD). Multiple suspects have been arrested and vehicles, evidence, cash, narcotics, weapons were located and seized. Federal, state, and local charges are pending.

Dulles South Significant Incidents:

Residential Burglaries

December 9-14, 2022

Three residences on Valiant Drive, Woodbine Farm Drive, and Winter Lane area were forcibly entered and items were taken. These cases remain under investigation.

Burglary of Dunkin Store

October 28, 2022

The suspects broke the drive-thru window of the Dunkin on Lizzio Center Drive and entered the business. Money was taken from the cash register. Through an investigation, this case was connected to other Dunkin burglaries in Virginia, Maryland, Pennsylvania, New Jersey, and Maine. Multiple suspects were arrested in New Jersey. This case remains under investigation.

Arlington Man Charged with Multiple Felony Offenses Including Abduction

October 25, 2022

On October 25, shortly before 8:00 p.m., deputies responded to the 25000 block of Hartwood Dr., Chantilly, for a report of an abduction. The preliminary investigation revealed that the juvenile victim was forced into their car at gunpoint by a man wearing a mask.

Detectives discovered that the suspect was known to the victim, and detectives worked closely with the Arlington County Police Department to locate and arrest him shortly after 9:00 a.m.

The suspect has been identified as Joshua Patino, 20, of Arlington. Patino has been charged with Abduction, Use of a Firearm in the Commission of a Felony, Brandishing a Firearm, Preventing the Summoning of Law Enforcement, Unlawful Use of a Mask, and Assault and Battery.

Larcenies from Motor Vehicles

September 20 – October 3, 2022

Over this time, multiple vehicles were entered, and items were taken including wallets, credit cards, and 5 firearms. Detective Brown identified two suspects from Prince George's County in Maryland and warrants were issued and the subjects were arrested. Both subjects are currently in jail.

Station Traffic Deputy

Each of the four stations have a deputy assigned to handle traffic complaints. Master Deputy Rudolph is assigned to the Dulles South Station and has been working with government officials, businesses, and residents to address parking and traffic complaints. Some of the concerns include parking complaints on Pebble Run Circle, tractor trailers parking in the turning lanes on Dulles West Boulevard and abandoned vehicles on Rockhaven Way.

Western Loudoun Significant Incidents:

Robbery & Assault

October 12, 2022

Two unidentified male subjects entered the gas station while displaying a wooden tire thumper and a black & green bat. One of the suspects jumped the counter and assaulted the cashier with the tire thumper, and the other suspect successfully emptied one of the cash registers. They left in a grey or silver sedan, possibly a Chevy Malibu or Toyota Camry/Corolla, driven by a 3rd subject.

Robbery

October 29, 2022

This incident was not reported to the LCSO until November 7, 2022. An employee of the gas station and convenience store reported that two unknown subjects dressed in all black, to include ski masks and gloves, had entered the store on October 29 with a black metal baseball bat and demanded the clerk to open the register. The clerk handed over cash, and the suspects also demanded the employees' cell phones before leaving the store. The cell phones were located outside the store on the ground, undamaged. The store owner did not want the incident investigated any further.

Residential Burglary

November 18-20, 2022

Entry was made into the residence on Braemar Place in Leesburg by breaking the door glass while the resident was out of town. Jewelry and cash were taken. This case remains under investigation.

Residential Burglary

December 4-16, 2022

While the residents were out of town, unknown subject (s) kicked in the back door of a residence on Winning Colors Place in Leesburg and stole jewelry, a firearm, and two firearm safes. This case remains under investigation.

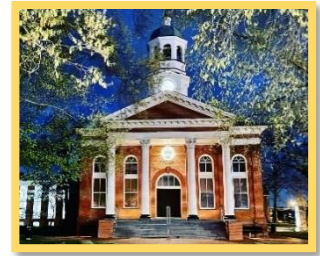

COURT SERVICES DIVISION



The Court Services Division provides both Court Security and Civil Enforcement functions at the Loudoun County Courts Complex and around Loudoun County. Court Security maintains safety for all persons entering and working in the court complex by utilizing screening procedures as well as providing public escorts when necessary. Additionally, the Civil Enforcement section executes both criminal and civil documents issued by the judicial courts and county offices according to Virginia Code.

Treasurer's Tax Summons are issued once a year during the month of May and served by the Civil Enforcement Unit. The court hearing dates for these summonses are set in June to afford the citizens of Loudoun County the opportunity to resolve the matter.
