### **Dear Broad Run Friends and Neighbors,**

As we move into March, the Board of Supervisors will begin our process of analyzing the proposed budget and approving a property tax rate for the next year. The current budget proposal consists of a real estate property tax rate of \$0.87 per \$100 in assessed value. This is 2 cents below the current tax rate of \$0.89, but the average tax bill in Loudoun would still increase by \$302 a

year due to rising assessments. I have not predetermined a tax rate I will support before moving through the analysis process. However, I will weigh all aspects of funding for necessary county programs against the effects of inflation and other costs on the taxpayer to arrive at a budget that best serves Loudoun County and the Broad Run District. The Belmont Chase Commercial II special exception application will be deferred to the Planning Commission's March 28 Public Hearing. Those who were planning to attend the February 28 public hearing are still welcome to do so. Public input for both meetings is available during a 6:00 pm speaking session. Those who would like to speak at the meeting during public input have the option to provide comments in-person or via the phone. The Top Golf lighting special exception will also appear before the Planning Commission at the March 28 Public Hearing. This application is to revise previously approved lighting at the Loudoun Top Golf to install four lighting poles within the facility's field range area.

Additionally, earlier this month, I participated in a community meeting for a proposed AT&T Cell Tower behind the Ashburn Sheriff's Station in the One Loudoun community. I have heard from several residents and welcome continued engagement on this proposal. However, I would like to clarify that an official application has not yet been submitted with the county. If submitted, there will be opportunities for public input during both the Planning Commission and Board of Supervisors review stage. I would continue to communicate any updates on an application through my newsletter in the land use section and through the One Loudoun HOA. This month I had the pleasure of participating in three exciting events. Last week, the Loudoun County Sheriff's Office held its 2022

Awards and Recognition Ceremony to recognize the day-to-day efforts of agency members for their service and dedication to the community. 

## Budget

County Administrator Tim Hemstreet presented a proposed budget for the Loudoun County government to the Board of Supervisors for Fiscal Year 2024 (FY 2024), which begins July 1, 2023. The budget totals \$4.2 billion in appropriations for the county government and Loudoun County Public Schools (LCPS).

### **Proposed Budget**

The proposed budget has been prepared at a real property tax rate of \$0.87 per \$100 of assessed value, which is 2 cents below the current real property tax rate of \$0.89 per \$100 of assessed value. While the proposed tax rate for FY 2024 is lower than the current tax rate, the proposed rate is 6.5 cents above the overall equalized rate of \$0.805, which is the rate at which the average real property owner's tax bill would remain flat year over year. The homeowner's equalized tax rate is \$0.83. This means that while the proposed tax rate is lower than the current tax rate, the average homeowner's tax bill would increase if the proposed tax rate is adopted by the Board of Supervisors.

The proposed budget executes the planned reduction in the general personal property tax rate from \$4.20 per \$100 of assessed

value to \$4.15 per assessed value for tax year 2023. This reduction is part of a strategic effort to ensure a diverse revenue base. As vehicles are assessed at the general rate, vehicle owners in the county can expect some relief on their vehicle tax bills.

"In accordance with the Board's guidance, the proposed budget provides for the opening of new facilities, base budget adjustments, supports the county's Capital Improvement Program (CIP) and compensates employees at a market rate," Hemstreet said.

The FY 2024 proposed budget includes:

- \$14.3 million in base budget adjustments to continue to provide core services.
- An increase of \$27 million for employee compensation, which consists of:
  - \$14.5 million to provide a 6% merit increase for the general county workforce.
  - \$4.6 million for a one step-increase and a 3% adjustment for uniformed Fire and Rescue personnel, for an average pay increase of 6%.
  - \$6.4 million for a one-step increase and a 6% adjustment for uniformed Sheriff's deputies, for an average pay increase of 9%.
  - \$1.5 million for a hiring and retention bonus program.
  - The addition of 40 positions to open new facilities and support the county's CIP.
- \$6.5 million for affordable housing, which continues the dedication of the equivalent of one-half cent of the real property tax rate to affordable housing needs.

### **Increase Options**

At the direction of the Board of Supervisors, Hemstreet also prepared two "increase options" for consideration. Both options include a real property tax rate that is one-and-a-half cents higher than the proposed budget, which would be \$0.885 per \$100 of assessed value. This tax rate, if adopted, would generate an additional \$19.4 million for the Board's consideration. These options are intended to help identify which resource needs by the county and Loudoun County Public Schools could be funded, if adopted.

- **Increase Option #1:** Under this option, the county government would split the net new local tax funding with LCPS at a 60/40 rate.
- **Increase Option #2:** Under this option, the county government would retain the additional revenues generated by the higher real property tax rate.

### School Board Budget Request

The Loudoun County Public Schools (LCPS) requested a total of more than \$1.1 billion dollars in local tax funding for FY 2024. Hemstreet's proposed budget includes an increase of \$69.1 million in local tax funding over last year but leaves a gap of \$6.2 million from the School Board's adopted budget.

In addition, due to an error in the Commonwealth of Virginia's revenue calculations, the resulting revenue shortfall of up to \$7.4 million could prompt the School Board to ask for additional funding.

### Factors Shaping the Proposed Budget

The proposed FY 2024 budget was developed in a challenging economic climate. Significant factors influencing development of the budget include:

- Forecasted Economic Conditions: The forecasted rates of growth in employment for Loudoun County as well as the nation, state and region are positive, but expected to be lower than 2022. This weaker forecasted growth reflects the downside risk associated with a potential recession.
- Population Growth: Although the number of residents added annually has slowed, the county's population continues to grow and is expected to increase by nearly 120,000 new residents through 2050, which will continue to bring new and increased demands on county programs and services.
- Real Property Portfolio: The forecast for higher interest rates is anticipated to lead to slowdowns in residential construction and a flattening of residential assessment values, as well as potential decline in commercial assessment values and changes in assessment methodologies enacted by the Virginia General Assembly. The FY 2024 proposed budget's revenue

outlook is based on this potential commercial property decline in value to best manage the risk to revenue collection in the second half of FY 2024.

- Evolving Local Tax Revenue Composition: The proposed FY 2024 budget makes progress toward the tax revenue policy recommendations from county staff that the Board of Supervisors bring balance to the General Fund's tax revenue composition. Under the policy, real property tax revenue should approach 60% of total General Fund local taxes in the coming years. For FY 2024, the proposed budget calls for nearly 53% of General Fund local tax revenue to come from real property tax revenue. A decade ago, more than two thirds of General Fund tax revenue was generated by real property tax. For the past several years, taxes from personal property, especially computer equipment, have been the largest funding mechanism to support the county's expenditure growth.

### **Capital Improvement Program (CIP)**

The Amended FY 2023-2028 CIP, which includes both county and school projects, totals approximately \$3.5 billion for the six-year planning period. The category with the largest expenditure percentage is transportation projects at 36%, followed by county projects at 35% and school projects at 29%.

FY 2024 is an “amendment year” for the CIP, so it reflects the priorities identified by the Board of Supervisors in the FY 2023 budget process. For FY 2024, renovation and renewal projects continue to be an important part of the CIP for both the county government and the schools.

New county projects include a Crisis Receiving and Stabilization Center, which addresses a critical need for behavioral health intervention services in the community.

The CIP also reflects the county's ability to leverage state and federal funding for transportation projects such as the Sycolin Road-Loudoun Center Place to Crosstrail Boulevard project. It also includes funding for the design and construction of bus shelters along the local, fixed-route bus stops.

School projects include the full replacement of Park View High School rather than a renovation as well as renovations and additions to Banneker and Waterford Elementary Schools and increased funding for school security improvements.

### **Tax Rates Summary**

The proposed budget is balanced at the real property tax rate of \$0.87 per \$100 of assessed value and a personal property tax rate of \$4.15. Under the proposed budget, the average homeowner in Loudoun County would have a real property tax bill increase of \$302, or about \$25 per month, in tax year 2023.

Hemstreet has advertised a maximum real property tax rate of \$0.89, which provides the Board of Supervisors with flexibility to consider critical needs in the increase options and address the LCPS gap caused by the Commonwealth's revenue calculation error.

The Board of Supervisors will determine the final tax rates and related budget policy decisions during March budget work sessions with final adoption of the FY 2024 budget expected at the Board's business meeting April 4, 2023.

### **Public Participation**

There are several ways in which members of the public may participate in the budget process, including Board of Supervisors public hearings, email, voice messages and social media. The Board will hold three public hearings on the proposed FY 2024 budget. The hearings are scheduled for:



### Loudoun County Business Tax Deadline is March 1

Loudoun County Commissioner of the Revenue Robert S. Wertz Jr. recently issued notices of business tax filing requirements to business owners for tax year 2023. The notice provides the necessary account number to enable taxpayers to report by March 1, 2023, their calendar year 2022 gross receipts at [loudoun.gov/efile](http://loudoun.gov/efile). ## **Fire Safety Tips**

Smoke alarms that are properly installed and maintained play a vital role in reducing fire deaths and injuries. If there is a fire in your home, smoke alarms provide the critical first warning and give you time to get out. Remember these tips:

- Test your alarms monthly by pushing the test button.
- Replace batteries in all smoke alarms at least once a year. If an alarm “chirps”, warning the battery is low, replace the battery right away.
- Replace all smoke alarms when they are 10 years old or sooner if they do not respond properly.
- Smoke alarms should be located inside every bedroom, outside each sleeping area and on every level of the home, including the basement.

- Have a home escape plan so everyone knows what to do if the smoke alarm sounds. Practice your plan!

As more and more products are using lithium ion and lithium polymer batteries, fire departments across the Country are seeing an increase in fires caused when these batteries malfunction. When lithium batteries are damaged or fail, they can overheat,

catch on fire, and even lead to explosions. Following these easy tips can keep you safe:

- ALWAYS follow the manufacturer's instructions for charging and storage.
- Use the correct battery, cord and power adapter and ensure cords and wires are not damaged or worn.
- Monitor batteries while charging and do not overcharge the device or device battery.
- Keep batteries and devices at room temperature.
- Charge and store batteries away from anything flammable. Never charge a battery or device under your pillow, on your bed, or near a couch.

## **2023 Real Estate Assessments Available Online**

Loudoun County Commissioner of the Revenue Robert S. Wertz Jr. announces that Loudoun County real estate assessments for tax year 2023 are now available online at [loudoun.gov/parceldatabase](http://loudoun.gov/parceldatabase). Printed assessment notices will be mailed to property owners the week of February 6, 2023. These assessment notices, which are not tax bills, communicate to property owners the value of their real property as of January 1, 2023, and are reflective of real estate market activity that occurred during 2022. The assessed value in conjunction with the tax rate to be set by the Board of Supervisors in April provides the basis for real

estate tax bills that will be due on June 5 and December 5. Property owners who believe their assessments are incorrect may file an Application for Review with the Commissioner online at [loudoun.gov/reaa](http://loudoun.gov/reaa) by March 10, 2023. Thereafter, appeals may be made to the Board of Equalization until June 1. [Read More.](#)

### **Commissioner of the Revenue to Hold Real Estate & Car Tax Relief Seminars**

Loudoun County homeowners 65 or older or with disabilities who are below established income and wealth limits may benefit from a reduction in the amount of property taxes they pay on their homes and cars. Qualified applicants for real estate relief must have a

gross combined income less than \$77,000 and net worth less than \$920,000. Up to \$10,000 in income of a spouse or relative residing in the home is excluded from the income calculation for real estate relief. Program participants saved over \$8.4 million in real estate and vehicle property taxes in tax year 2022. [Read More.](#)



### Ashbrook Place ZMAP-2018-0004

#### No Change

This project, at the eastern corner of Ashbrook Place and Russell Branch Parkway, was approved by the Board of Supervisors in December 2019. The approval was for a rezoning from industrial park to residential to allow for the construction of 190 multifamily units. Sewer installation and road construction have begun. The developer will construct the remaining asphalt path on the northeastern side of Russell Branch Parkway from Savin Hill Drive to Ashbrook Place. Unit construction and sales are currently underway.



### Ashbrook Place Lot 4 ZCPA-2021-0006

#### No Change

This project consists of reducing a building setback along Route 7 from 300 feet to 200 feet in order to construct an already allowed flex-industrial office building. The proposed building would be built over an existing parking lot between Route 7 and 20098 Ashbrook Place, Ashburn.

This application was approved by the Board of Supervisors at its September 14th Public Hearing after receiving a unanimous Planning Commission recommendation of approval and having no outstanding land use issues from Loudoun County planning and zoning staff.



### Ashburn Crossing Phase II No Change

This project, on land bound by Loudoun County Parkway to the east, Gloucester Parkway to the south, and Ashby Ponds to the west, is being constructed by-right (without Board of Supervisors approval). The project consists of building three flex-industrial buildings and a gas station on the vacant land at the site. The flex-industrial buildings will be identical to the existing buildings directly to the north. Two of the three buildings are currently in the framing process with foundation pouring underway for the third building along Gloucester.



### Ashburn Station / The Regency ZMAP-2018-0010 No Change

This project, at the southwest corner of Ashburn Village Boulevard and Waxpool Road, was approved by the Board of Supervisors in December 2019 as a rezoning from 1 residential unit per acre to 24 residential units per acre. Up to 254 residential units will be built. The developer is installing a series of sidewalks and trails to connect the area to the Metro station, and dedicating around 70 acres of parkland to the County. Sidewalk installation, road construction, and building framing is currently underway.



### **Belmont Chase, Regency at SPEX-2022-0012**

This project, on land in between Claiborne Parkway, Ashburn Road, and Russell Branch Parkway, was approved by the Board of Supervisors in March 2018, and allows for 105 age restricted townhomes, along with 34,000 square feet of retail space. The developer has also submitted a special exception application for a gas station to be built in the commercial section. The drive-thru restaurant portion of this application has been removed. This application is scheduled to appear at the March 28 Planning Commission public hearing.






At the request of Supervisor Glass and Supervisor Turner, the Board has approved and funded the design and construction of an asphalt trail under Ashburn Road, on the north side of Beaverdam Run, connecting the existing trails in Ashburn Village and Ashburn Manor. The Board allocated \$112,000 to complete the project, which is currently in the design stages. A study was also completed to determine the best way to add pedestrian facilities crossing Beaverdam Run from the north and south. An approximately \$4 million pedestrian bridge on the west side of Ashburn Road was determined the best option.



### No Change

This project includes the construction of a regional science center through a multi-party agreement. The Science Center will be built on an approximately 5-acre site backing to the Broad Run at the Kincora development.

Currently, the land is in the final stages of being transferred from the developer to the center. Loudoun is contributing \$15 million, and the Commonwealth of Virginia is contributing \$40 million, of the \$75 million cost of the project. Construction is estimated to begin in 2022 with the center opening by early 2024.


### Ashburn Road Improvements No Change

[A study \(PDF\)](#) was completed in 2020 on driver and pedestrian safety along the corridor of Ashburn Road between Gloucester Parkway and Farmwell Road/Ashburn Farm Parkway. The Board has allocated over \$300,000 for engineering and construction of the identified short-term solutions (page 12): additional signage, pavement reconfiguration, and new pavement markings. Construction of the short-term improvements began in spring 2022, including the raised median, bike lane "Sharrows", and stamped/painted asphalt.



### Barrister Drive No Change

This project constructs an extension of Barrister Drive, from the existing terminus south of Loudoun County Parkway, to the east under the Dulles Greenway, then turning north to connect to the future Shellhorn Road extension. The construction is being funded by the builder of the Silver District West development as a transportation proffer with the project approval. Construction will not be completed for several years. 
### **Belmont Ridge Road Widening No Change**

[This project](#) provides for the widening of Belmont Ridge Road from two to four lanes from Truro Parish Drive to Croson Lane. Construction began in early spring 2022 with project completion estimated for summer 2024, weather permitting. Storm sewer pipe installation, wet utility construction, and demolition work is currently underway. Portions of future southbound lanes between Truro Parish Drive and Alford Road have been paved.



### **Croson Lane Widening No Change**

This project provides for the widening of Croson Lane to a four-lane, median-divided roadway from Claiborne Parkway and Old Ryan Road. Design plans have reached 30% with environmental investigations and utility coordination underway. Plans are being developed to redesign the traffic signal planned at the intersection with Mooreview Parkway. A virtual community meeting is tentatively scheduled for **Thursday, April 20, 2023, at 6:00pm.**




### **Davis Drive Extension and Bridge No Change**

This project provides for the extension of Davis Drive from its existing terminus at Old Ox Road, south, to Innovation Avenue. The project also calls for Davis Drive to extend further south from Innovation Avenue to cross the Dulles Toll Road and intersect with Sunrise Valley Drive in Herndon. The Waterside developer will build the portion of Davis Drive from Old Ox Road to Innovation Avenue with the County building the bridge. The extension will be four lanes with sidewalks on both sides and will not open for many years.




### **Davis Drive/Sterling Boulevard Intersection Improvements No Change**

On July 6, 2021, the Board of Supervisors accepted the improvements identified in [a study](#) of pedestrian and vehicular improvements [along Davis Drive, in Sterling](#), from West Church Road to South Sterling Boulevard. The bike lanes installation on Davis Drive was performed by VDOT as part of a regularly scheduled repaving in summer 2021. The additional improvements estimated to cost \$2.3 million will be discussed during budget deliberations in March 2023.



### Farmwell Road Intersection Improvements **No Change**

Intersection Improvements along Farmwell Road, from Ashburn Road to Smith Switch/Waxpool Roads, are at 90% design plans. 100% design completion has been delayed until winter 2023 due to delays in utility identification. Construction for the project is scheduled to begin in winter of 2025 and end in fall 2026. The Board of Supervisors endorsed [the major project design elements](#) at its May 4th business meeting. Supervisor Glass worked with the Ashburn Village HOA to minimize impacts along along the project section south of Fultonham Circle.



### George Washington Boulevard/Route 7 Overpass **No Change**

Work is underway to extend George Washington Boulevard (Route 1050) from Research Place south to Russell Branch Parkway via a new bridge over Route 7 (Harry Byrd Highway) to reduce congestion and improve accessibility for drivers, bicyclists and pedestrians. The \$30.6 million project is financed with federal, state and Loudoun County funding. The project is scheduled for completion in mid 2024. There also may be some traffic impacts in the area, but at least one lane in each direction of these roads will remain open at all times. Visit the [project](#)





### Loudoun County Parkway / Dulles Greenway Interchange **No Change**


This project provides for improvements to be made to the interchange with Loudoun County Parkway and the Dulles Greenway, including design, utility relocation, and construction. Design has not yet begun as this project has not yet been fully funded but has been identified for future funding. The cost estimate for these improvements is slated to be around \$20 million.


### Loudoun County Parkway Widening **No Change**

This project provides for the widening of Loudoun County Parkway (Route 607) from four to six lanes between Ryan Road (Route 772) and Shellhorn Road (Route 643), and the construction of turn lanes at the intersections and shared use paths on each side. Construction of the widening has begun and will be completed in 2024 by the Silver District West developer.



### **Old Ox Road Widening No Change**

**This project** is on hold after the Board of Supervisors voted on December 7th, 2021 to take over this project from the Waterside developer. The developer experienced increased costs and was unable to complete the project. The project provides for the design, right-of-way acquisition, and construction of the widening of Old Ox Road from four to six lanes from Route 28 to the Loudoun County/Fairfax County line at Rock Hill Road.



### **Prentice Drive Extension No Change**


This project provides for the construction of a new segment of Prentice Drive in Ashburn and Sterling from Lockridge Road to Loudoun County Parkway. The roadway will be a four-lane roadway with turn lanes, on-road bike lanes, and sidewalks. Design completion is currently estimated for summer 2023. ### Route 7 Additional Eastbound Lane Widening (from Loudoun County Parkway to Route 28)


#### No Change

This project provides for the planning, design, right-of-way acquisition, and construction of an additional travel lane along eastbound Route 7 between the Loudoun County Parkway entrance ramp and the Route 28 exit ramp, to provide four continuous lanes between the two interchanges. The project is budgeted for \$6.2 million beginning with design in 2025 and construction in 2034.




### Route 7 Corridor Study No Change

The [draft study](#) examined existing and projected conditions along Route 7, between Dranesville Road at the Fairfax County line to the Route 28 interchange. The study included an evaluation of the history of recent crashes, an analysis of existing traffic operations along the corridor, and travel demand forecasts. The Board of Supervisors confirmed alternative 4 as the preferred configuration in October 2021.



### **Route 28 / Dulles Toll Road Interchange Study No Change**

Completed in spring 2021, a study was performed to assess traffic movements and safety measures at the interchange between Route 28, the Dulles Toll Road, and the Dulles Greenway (also encompassing the interchanges between Route 28 and Innovation Avenue and Old Ox Road). The study identified a preferred "mega project" that will address much of the congestion and safety concerns along this corridor. View the unfunded study findings [here](#).




### **Shellhorn Road and Sterling Boulevard Extensions No Change**

[This project](#) constructs an extension of Shellhorn road from the existing terminus at Loudoun County Parkway through to the existing Sterling Boulevard interchange at Route 28. Portions of the Shellhorn Road extension will follow the existing alignments of Lockridge and Moran Roads. The project is currently in the design stage and will be constructed in segments. ### **Waxpool Road Intersection Improvements I *No Change***

This project funds intersection improvements and turn lanes at Waxpool Road and Pacific Boulevard, intersection improvements and turn lanes at Waxpool Road and Broderick Drive, and intersection improvements and turn lanes at Waxpool Road and Loudoun County Parkway. Right-of-way authorization, land acquisition, and utility relocation are ongoing in coordination with VDOT. Construction is expected to begin in 2023. ### **Waxpool Road Intersection Improvements II *No Change***

[A study](#) was completed on the safety of Waxpool Road from Demott Drive to Faulkner Parkway. The Board has allocated \$300,000 to install a four-way stop at the intersection of Ashburn Road and Waxpool Road as a temporary solution before a traffic signal is installed by 2025. A roundabout will be installed by the end of 2023 at the Faulkner Parkway intersection. All missing links are being filled in the entirety of the corridor.
