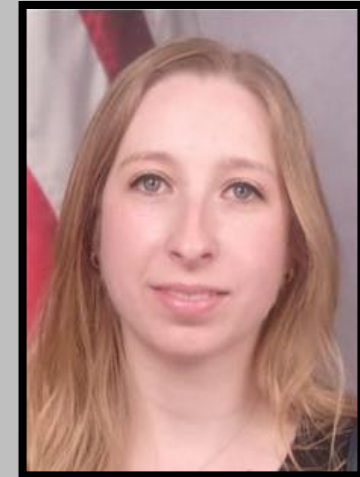

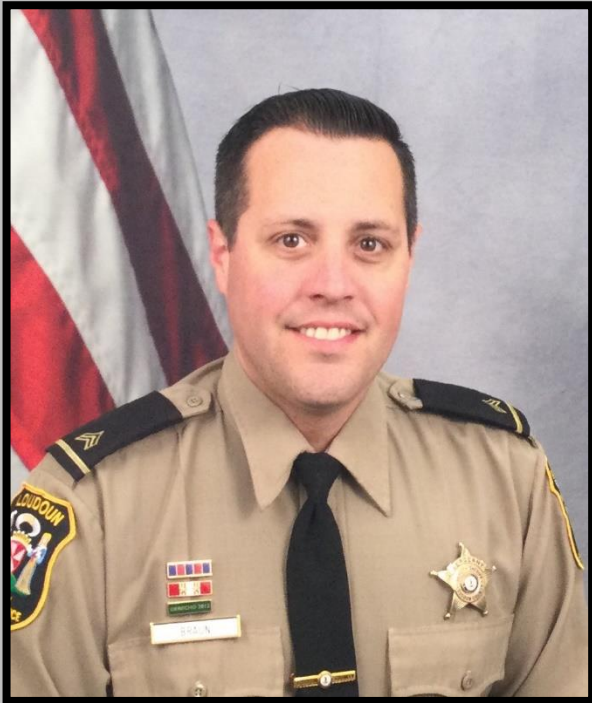

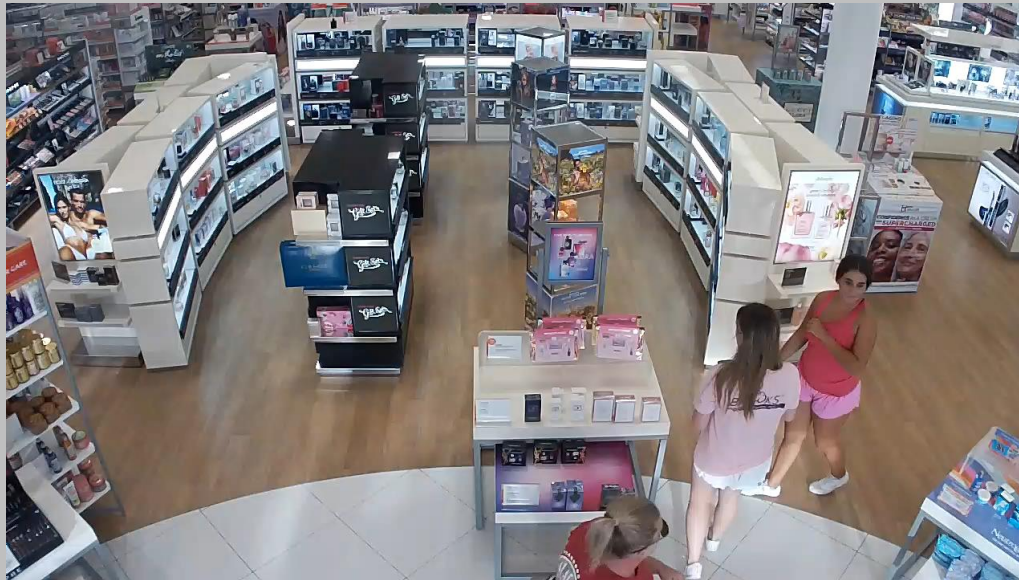

- ❑ Regional concern where individuals and groups/crews steal large quantities of merchandise. Store policy dictates no interference, other stores are following suit and reported to law enforcement after the fact. Main issue is this provides a great opportunity and ease to criminals.
- ❑ Mission is providing awareness and support to businesses to hinder criminal opportunity, preventing future occurrences. Further investigate and charge violations under the Code of Virginia.

In May, unknown subject(s) stole credit cards from an unlocked vehicle in Aldie. These cc were used in multiple transactions at 3 CVS in Maryland, store footage captured suspect above purchasing visa gift cards. Obtained transaction history, which was largely used in the Alexandria area (Lowe's specifically).

One of these gift cards was also used at the Alexandria DMV to renew a vehicle registration. LCSO partnered with VA DMV law enforcement and uncovered an additional suspect/associate as the DMV teller. Iris Arevalo, used her position to illegally renew the registration using one of the gift cards.
