

This month we celebrate Earth Day and Arbor Day. I hope everyone was able to take action for our environment and help protect our natural resources. I was proud to present the Board of Supervisors Proclamation for Earth Day to our Parks Recreation department last Saturday at the beautiful Banshee Reeks Park!

Earlier this month, the Board of Supervisors funded my feasibility study for multi-modal paths along Algonkian Parkway. I look forward to recommendations on how we can improve connectivity with paths that are suitable for bicycles, strollers, bladers and keep our pedestrians and children safe on the paths maintained by our homeowners' associations. The six-mile stretch could connect to Route 7 on the Fairfax side and create a safe path to the mall and hopefully eventually the W&OD trail on the other side.

The University Center Lakeview application passed unanimously, which will bring nearly 600 much-needed homes to the area just northeast of One Loudoun. I worked closely with the developers to earmark the first \$2.7 million in capital facility funds from the project to Phase 2 of Bles Park






First Annual Loudoun Take Back the Night

Environmental Forum

The Loudoun Environmental Commission is hosting the Energy and Environment Forum on Thursday, May 11, 2023, from 5:30pm - 8:00pm at the Academies of Loudoun. The forum will feature information stations where members of the public may learn about ongoing activities in the areas of energy and the environment and provide comments. Topics will include: The Loudoun County Energy Strategy; Energy Equity; Solar Ordinances; Tree Protection; Wildlife Corridors; Watershed Management.

The forum is intended to be an annual event to provide members of the public with the opportunity to learn more about these topics and provide comments on what the county's role should be in regard to energy and environmental sustainability. The public's comments will be shared with the Board of Supervisors during the Environmental Commission's annual update to the Board.

Loudoun County Treasurer H. Roger Zurn Jr. reminds taxpayers that the deadline for payment of the first-half personal property tax is Friday, May 5, 2023. Options for payment include:

STATUS: APPROVED

The University Center Lakeview application was forwarded to the BOS with a recommendation of approval from the Planning Commission. The application proposes to rezone the property to R-24 for the development of up to 597 multifamily units (both

STATUS: RECOMMENDATION/DECISION

Lennar Multifamily Communities has filed plans for a multifamily development to build 485 homes on the 19.33-acre site currently home to Blue Mount Nursery.

multifamily stacked and multifamily attached) with 10% of the unit count as affordable. The application was approved at the April 18 Board of Supervisors Business Meeting.

The application was heard at a Planning Commission Public Hearing on Wednesday, March 28th and was forwarded to a Planning Commission Work Session on May 11 for further deliberation.

STATUS: ACTIVE

Bles Park

STATUS: APPROVED

The application was to establish a Bles Park Master Plan to expand the existing park and its amenities, including trails, pickleball courts, an off-leash dog park, four soccer fields, and a kayak launch.



The Villas at Cascades

STATUS: APPROVED

This application is to allow the development of 178 multi-family stacked residential units. The developers are currently in the site plan processing stage of the project. They expect to break ground towards the end of this year with the first units delivering approximately a year later (or late 2024). A \$160,000 school contribution has also been made with the expectation those funds will be used for the playground area at Meadowland Elementary.
