

The board agreed to allocate \$90,000 to hire a consultant for the mapping project which staff said would be delayed about a year in their last assessment. This should result in a Comprehensive Plan Amendment (CPAM) that will specify areas of the county where new data center development will be restricted. While I have a strong desire to complete all projects in our planning and zoning workplan, I believe the community is most concerned about ongoing data center development and would like to see the board take action.

# **Community Dialogue to Counter Hate**

**Dominion Energy Community Meeting Tonight**

## Reminder that Dominion is hosting an in-person community meeting at Broad Run High School now, from 5-8pm on their proposed transmission line project in Loudoun County. I encourage all residents with input, concerns, or questions to

attend that meeting and make their voice heard. If you cannot make it to the meeting, you can contact Dominion directly at 888-291-0190 or <u>powerline@dominionenergy.com</u>.

Dominion Energy is moving forward with a project to construct high-capacity transmission lines across Loudoun County to respond to energy needs in the area. Over the last month, Dominion Energy has sent postcards by mail to Loudoun residents with information about the proposed project. The route currently being reviewed is either on the north or south side of Route 7 (see map). Alternative routes that were considered but rejected are on the Dulles Greenway and along the Washington & Old Dominion Trail.

I have concerns regarding above-ground transmission lines along Route 7 and will oppose any plans that bring above-ground high powered transmission lines to the Algonkian District. The final decision on this project will be subject to review and approval by the State Corporation Commission (SCC). ## Accelerated CPAM for Data Center Mapping

At the June 20th Board of Supervisors Business Meeting, I made a motion that was approved 5-4 by the Board of Supervisors to authorize funding of a consultant to complete the Comprehensive Plan Amendment (CPAM) portion of the Data Center Design Standards and Location Project. This CPAM would restrict data centers in specific Place Types. We were informed by staff that this project was facing delays until 2025. Based on my staff's research, commissioning a consultant on the project would accelerate the CPAM by up to a year.

I have heard extensive complaints from Algonkian residents about data centers and concerns about their proliferation throughout the county. The Data Center Design Standards and Location Project is meant to address these concerns by explicitly restricting the locations where they are permitted "by-right" or through legislative applications. While the BOS cannot change existing data centers or legislative applications already underway, we have the ability to act to restrict future applications. It is important to me that the county enact formal policies that actively restrict data center development in areas of the county where they are not suitable, such as near residential neighborhoods.

You can read the staff item on the project <u>here</u>. County staff will return to the Board of Supervisors at a future meeting to formally initiative the CPAM with a detailed project plan. Staff estimates the timeline to be 9-10 months to completion once the project is initiated.

## Planning Commission Recommends Approval of Zoning Ordinance Rewrite

## New Draft of Proposed Zoning Ordinance is Online



On June 8, 2023 the Planning Commission voted to forward the Draft Zoning Ordinance to the Board of Supervisors with a recommendation for approval. The Planning Commission held more than 20 work sessions since August 2022 and considered the comments of thousands of residents. The new zoning ordinance intends to reflect the county's Comprehensive Plan and include new district regulations. The Zoning Ordinance is the bedrock policy document that is used to regulate development of all types in Loudoun County.

The next step in the Zoning Ordinance Rewrite project is for the Board to review the recommendation of the Planning Commission. The Board is likely to hold a public hearing on the Planning Commission's recommended ordinance later this summer and consider potential revisions to ordinance text during a series of work sessions before ultimately adopting a new Zoning Ordinance that will replace the county's existing ordinance. The Planning Commission's Draft Zoning Ordinance will be published on the county's website in advance of a Board of Supervisors public hearing. The date of the public hearing will be announced once it is scheduled.

My office will extensively review the recommended Zoning Ordinance and encourage all members of the public to share feedback on the proposal. Once a public hearing and meetings deliberating on the Zoning Ordinance Rewrite are set, my office will advertise them to the public.

## Resident Curator Agreement Approved with Loudoun Freedom Center

Loudoun Freedom Center to serve as Resident Curator for historic Union Street School property

The Loudoun County Board of Supervisors has approved a lease agreement with the Loudoun Freedom Center for the historic Union Street School property. The Union Street School property, located at 20 Union St. NW in Leesburg, becomes the first county property included in the county's Resident Curator Program. This significant partnership between the county and the Loudoun Freedom Center aims to preserve African American history & culture and make accessible the full understanding of the rich heritage of Loudoun County and the significant contributions of the African American community. Under the terms of the Resident Curator Program and the lease agreement, the Loudoun Freedom Center will serve as the curator for the property, taking responsibility for the dayto-day operation, maintenance and security of the facility.

## In-Person Services for WIC Program Resumed with New Leesburg Office Open



The Loudoun County Health Department is resuming in-person services for the Women, Infants, and Children (WIC) Program by appointment in a phased approach. The WIC office had been closed to in-person services during the pandemic. Additionally, the county has opened a second office, located in Leesburg, providing options in both Ashburn and Leesburg. WIC is a supplemental food program that offers nutritional counseling and education to pregnant or lactating women, infants, and children five years old and younger who meet income, medical and/or nutritional eligibility requirements.

Virtual WIC services are available by appointment at both offices at the following hours: 8am - 4:30pm on Mondays, Tuesdays, and Thursdays; 8am - 6pm on Wednesdays; 8am - 3pm on Fridays.

Phased Schedule of Operations:

- July 6: Expand to additional in-person services on Tuesdays and Thursdays.
- August 9: Full services available in-person Monday-Thursday.
- Fridays will be reserved for virtual appointments.



**STATUS: APPROVED** 

The University Center Lakeview application was approved by the Board of Supervisors at the April 18 Business Meeting. The **Dogwood Farm Station** 

STATUS: RECOMMENDATION/DECISION application will re-zone the property to R-24 for the development of up to 597 multifamily units (both multifamily stacked and multifamily attached) with 10% of the unit count as affordable. The application also included a proffer of \$2.7 million to fund Bles Park Phase 2 improvements. Lennar Multifamily Communities has filed plans for a multifamily development to build 485 homes on the 19.33-acre site currently home to Blue Mount Nursery. The application was deliberated on by the Planning Commission at a Work Session on May 11 and was forwarded to another Work Session on July 13.



## **Cascades Marketplace**

#### **STATUS: ACTIVE**

The team at Willard Realty are busy meeting with (and signing) prospective tenants. Make sure to visit their website for updates and to provide feedback, <u>here</u>. The application proposes to re-zone the Cascades Marketplace into a mixed-use development of new housing and retail. The application was heard by the Planning Commission at a Public Hearing on June 27. The application was forwarded to a Work Session for further deliberation.



## **Bles Park**

### **STATUS: APPROVED**

The application was approved to establish a Bles Park Master Plan to expand the existing park and its amenities, including trails, pickleball courts, an off-leash dog park, four soccer fields, and a kayak launch.



## The Villas at Cascades

## **STATUS: APPROVED**

This application is to allow the development of 178 multi-family stacked residential units. The developers are currently in the site plan processing stage of the project. They expect to break ground towards the end of this year with the first units delivering approximately a year later (or late 2024). A \$160,000 school contribution has also been made with the expectation those funds will be used for the playground area at Meadowland Elementary.
