Leesburg - This sector includes the Town of Leesburg and everything East of Rt. 15 and West of Belmont Ridge Road. Leesburg is the only town in this area. N/W - Is the North Western part of the County that includes everything North of Rt. 7 (business Rt. 7 in towns), and everything West and North of the Town of Leesburg.

S/W - Is the South Western part of the County that includes everything South of Rt. 7 (business Rt. 7 in towns), and everything West of Rt. 15.
