This school year, I

am excited to be back to in-person teaching at Sanders Corner Elementary School, where I will continue as a special education teacher's assistant.

This August I had the pleasure of holding a Town Hall meeting with the Broadlands. I had a great discussion on county initiatives, transportation and land use projects occurring in the Broad Run District, and other topics affecting their community. I am also scheduled to meet with the Village of Waxpool community on Tuesday at 6:30pm. Additionally, this month the Ashburn Library celebrated their 20<sup>th</sup> anniversary! It was great to see the many families who came out to commemorate an important occasion and to learn the origins of one of our beloved community spaces. The Ashburn Library has many exciting events and programs for people of all ages, which can be found [here](#). This month, I also attended the Virginia Association of Counties (VACo) County Officials' Summit in Richmond. The Summit offers an opportunity for local officials all across the Commonwealth to gather and discuss shared issues among our jurisdictions. As a member of the VACo Education Steering Committee, a topic we discussed during our meeting was the statewide public school systems funding shortfall from the Virginia Department of Education that occurred earlier this year. The Board of Supervisors has already pledged to make up that funding shortfall through our end of year fund balance in December.

There is one transportation project update that I would like to bring to your attention. Traffic signals at the intersections of Mooreview Parkview and Croson Lane, and Mooreview Parkway and Claude Moore Drive/Wynridge Drive, are scheduled to become fully operational in a couple of days. All drivers should be cautious when driving through both intersections over the next couple of days while the lights are flashing and before they become "full color". If there are no lights, drivers should continue to treat the intersection as a four-way stop. However, if the lights are flashing

yellow then drivers can proceed with caution, and if the lights are flashing red, then drivers must treat the signal as a stop sign.

I also have updates to a few land use items in the Broad Run. [The Broadlands 104](#) and [Commonwealth Center](#) applications are scheduled to appear at the Planning Commission's September 14<sup>th</sup> Work Session for further review. The Loudoun Station land use application is scheduled to appear at the Planning Commission's September 26 Planning Commission Public Hearing for the first round of public input. This application is to reduce the number of trees in the landbay fronting Ashburn Metro Drive.

Finally, Dominion Energy will hold another community meeting on its proposal to install powerlines down Route 7 in order to meet increased demand for energy. The public meeting will be held this Tuesday, August 29, from 5:30pm to 8:00pm at Belmont Ridge Middle School (19045 Upper Belmont Place, Leesburg 20176). ## Public Comment on Greenway Toll Increase Request Now Open; SCC Hearing Set

The Virginia State Corporation Commission (SCC) has opened its public comment opportunity and scheduled hearings on an application ([Case # PUR-2023-00089](#)) from the owners of the Dulles Greenway requesting to increase the maximum tolls for most drivers to \$8.10 during peak hours, up from the current \$5.80, and \$6.40 during off-peak hours, up from \$5.25.

## **Written Comments**

Members of the public may submit written comments through January 24, 2024. Written comments regarding the Greenway's request for increased toll rates can be provided online through the [SCC's website](#). Written comments can also be submitted by U.S. mail to the Clerk of the State Corporation Commission, c/o Document Control Center, P.O. Box 2118, Richmond, Virginia 23218-2118. All comments must refer to case number PUR-2023-00089.

## **Register for Oral Testimony**

The SCC has also scheduled hearings regarding the Greenway's request for increased toll rates. The public witness session is scheduled to begin at 10:00 a.m., Tuesday, January 30, 2024, at 1300 East Main Street in Richmond. Public witnesses will testify by telephone.

Public witnesses who wish to provide oral testimony must pre-register by 5:00 p.m., Wednesday, January 24, 2024, in one of three ways:

The SCC allots each witness five minutes to provide testimony. A separate public evidentiary hearing will be held at 10:00 a.m., Wednesday, January 31, 2024, to receive testimony and evidence from the company, any respondents and the SCC staff. Although testimony from members of the public will not be accepted on January 31, 2024, the hearing will be open to the public. ## **Background**

Loudoun County has opposed toll rate increases requested by the operators of the Dulles Greenway, Toll Road Investors Partnership II (TRIP II), which filed its application for the authorization for an increase in the maximum level of tolls last month. The SCC is the entity that considers such requests.

TRIP II has requested a toll increase of 22% during off-peak hours (from \$5.25 to \$6.40) and a 40% increase during peak morning and afternoon hours (from \$5.80 to \$8.10). TRIP II claims the increases are necessary to meet its debt obligation; however, data shows that use of the Greenway is down because of its already high toll rate. Traffic on the Greenway decreased substantially during the COVID-19 pandemic and has not returned to pre-COVID levels.

To promote use of the Greenway by more motorists, Loudoun County has consistently supported changing the Greenway's toll structure to distance-based tolling while also lowering toll rates. The Greenway operator has the lawful ability to implement both changes now.

Virginia law enacted in 2021 provides objective criteria for evaluating toll increase proposals, including a requirement that proposed Greenway toll rates are "reasonable" to users in relation to the benefit they are deriving from using the road so that the rates do not "materially discourage" use of the road. Loudoun County believes TRIP II's proposed rates will further discourage the use of the Greenway. The SCC uses the objective criteria to evaluate toll rate increase proposals and Loudoun County supports the SCC review process.

In addition, Loudoun County has opposed any legislation that would potentially permit automatic toll rate increases each year of an unknown amount and an extension of the Greenway's operator's license for an unlimited period of time, which is not good for Loudoun residents. The county's opposition to automatic toll rate increase legislation and continued support of the SCC review process is intended to protect Loudoun residents who may choose to use the Greenway from arbitrary toll rate increases. Legislation supported by TRIP II pertaining to this matter was previously defeated by the Virginia State Senate twice on bipartisan votes.

## **Loudoun's New Online Land Management System is Live**

Loudoun County has launched its new online land management system, LandMARC (Land Management, Applications, Research, Coordination), which is designed to increase efficiency and transparency for Loudoun businesses and residents. The system is a

comprehensive online portal for accessing, managing, and maintaining Loudoun County's land-related information.

## LandMARC Overview

LandMARC leverages new technology and adds many new online capabilities to better serve the needs of the county's customers. Through an online portal, members of the public are now able to:

- Submit permit, land development and legislative land use applications.
- Submit electronic copies of plans and other required documentation.
- Track the status of applications and land development projects.
- Request pre-application and pre-submission meetings.
- Request inspections.
- Pay application fees.
- Access public records related to permits and plans.

The new system replaces outdated internal and publicly available systems, including e-Permits, LOLA (Loudoun Online Land Applications) and WAIRS (Web Automated Inspection Request System).

## Sign up for a LandMARC Account

LandMARC accounts are required to apply for a permit or plan, request inspections, or manage active projects. All customers must create new accounts to do business in the system. Information on how to sign up for an account is available at [Loudoun.gov/LandMARC](http://Loudoun.gov/LandMARC). Members of the public can search for and access public records related to permits and plans without an account.



## No Change

This project consists of reducing a building setback along Route 7 from 300 feet to 200 feet in order to construct an already allowed flex-industrial office building. The proposed building would be built over an existing parking lot between Route 7 and 20098 Ashbrook Place, Ashburn.

This application was approved by the Board of Supervisors at its September 14th Public Hearing after receiving a unanimous Planning Commission recommendation of approval and having no outstanding land use issues from Loudoun County planning and zoning staff.



This project, on land bound by Loudoun County Parkway to the east, Gloucester Parkway to the south, and Ashby Ponds to the west, is being constructed by-right (without Board of Supervisors approval). The project consists of building three flex-industrial buildings and a gas station on the vacant land at the site. The flex-industrial buildings will be identical to the existing buildings directly to the north. Two of the three buildings are currently in the framing process with foundation pouring underway for the third building along Gloucester.



## Belmont Chase, Regency at

**Ashburn Station / The Regency**  
**ZMAP-2018-0010**  
**No Change**

This project, at the southwest corner of Ashburn Village Boulevard and Waxpool Road, was approved by the Board of Supervisors in December 2019 as a rezoning from 1 residential unit per acre to 24 residential units per acre. Up to 254 residential units will be built. The developer is installing a series of sidewalks and trails to connect the area to the Metro station, and dedicating around 70 acres of parkland to the County. Sidewalk installation, road construction, and building framing is currently underway.



**ZMAP-2013-0003**

**No Change**

This project, on land in between Claiborne Parkway, Ashburn Road, and Russell Branch Parkway, was approved by the Board of Supervisors in March 2018, and allows for the construction of 105 age-restricted townhomes and 33,000 square feet of retail space. The construction of the age-restricted townhomes are still underway. The retail space has yet to begin construction. An application for a gas station and fast food restaurant were withdrawn and are not being considered anymore.

A site plan for a 1 million square foot data center campus along with an associated power substation has been submitted by CyrusOne Data Centers. CyrusOne bought the parcel in January 2023 for \$119 million. CyrusOne will meet with the Broadlands HOA Board at their meeting on October 17th to discuss the data center campus. Supervisor Glass has met with CyrusOne and is discussing architectural elements, landscaping, and noise attenuating measures in an effort to make the data center blend in with the neighborhood.



**Colonnade**

#### LEGI-2023-0024

This application, on land at the northeast corner of the Broadlands Boulevard and Van Metre Drive intersection, is to rezone 10 acres from office and industrial to residential. The proposal consists of 45 townhouse units, 30 condo units, and 88 apartment units, for a total of 163 residential housing units. The application will appear at the Planning Commission's September 14th Work Session for more review and negotiation with the applicant before being forwarded to the Board of Supervisors for a final vote.



Sidewalks and/or asphalt trails have been installed along the road frontages as part of these projects. Construction will last for several months after groundbreaking and site clearing occurs.



This application is on land south of Russell Branch Parkway, and north of the Broad Run, encompassing the former Ashburn North Park and Ride Lot. The applicant seeks to rezone from office park to residential to allow for the construction of 450 multi-family housing units, 25% of which would be attainable housing units. This application is currently in the staff review process. At the December 6th Business Meeting the Board agreed to sell the former Ashburn North Park and Ride Lot, provided the rezoning is approved at a later date.




### Gramercy District

This project is on land northeast of the Dulles Greenway between the Ashburn Metro Station and the Loudoun Station development. The project was approved in conjunction with the Loudoun Station development by the Board of Supervisors in December 2003. The two developments can construct up to 1,514 multi-family residential units and up to 1.8 million square feet of commercial, retail, and/or office space. Plans for the Gramercy District portion of the project are still in conceptual design stages with construction beginning several years from now.



### Innovation Gateway LEGI-2023-0027

This application is located on land bounded by Route 28 to the west, vacant land to the south, Shaw Road to the east, and hotels and the Sheetz gas station to the north. The application proposes to rezone the 24-acre parcel from a research and development park to allow for data centers and residential units. The application is currently scheduled to appear before the Planning Commission at its September 26th Public Hearing where it will either be forwarded to a Work Session for more review or to a Board of Supervisors Public Hearing.

### Innovation Multifamily ZMAP-2021-0007 **No Change**

This project is on land bound by the Fairfax County line to the east, Innovation Avenue to the south, and other parcels to the west and north. The application consists of rezoning 5 acres from one residential unit per acre to Planned Development-Town Center to allow for the construction of 415 multifamily residential units. The application was approved at the Board of Supervisors' November 15 Business Meeting in a 6-3 vote. The applicant will construct a neighborhood park on the parcel along with trails and lighting in the vicinity.

A change to the timeline for constructing a public plaza was approved on April 19th, 2022.

This project is on land south west of Shellhorn Road, and southeast of the Ashburn Home Depot, near the Ashburn Metro Station. An application to reduce the number of trees required on the landbay fronting Ashburn Metro Drive will appear at the Planning Commission's September 26th Public Hearing.

This project, approved by the Board of Supervisors in December 2002, allows for the construction of up to 6,000 residential units and up to 9,750,000 square feet of non-residential uses. The newest section of the project to be developed is near the intersection of Croson Lane and Old Ryan Road. There, Toll Brothers is building three bedrooms, two bathroom condos. The overall development's next phase, Southmoore, was announced in April 2022 (The Burn link).

In this application, the developers of One Loudoun have submitted a zoning amendment application to add an additional 1,745 multi-family residential units in the currently undeveloped sections of the community south of Route 7 and west of Loudoun County Parkway, and remove 785,000 square feet of non-residential uses.

The application was approved by the Board of Supervisors in a 7-2 vote. The developer will build several sidewalks and traffic signals in the immediate vicinity. The current HOA supported approval of the application.

### Ashburn Recreation and Community Center **No Change**








### W&OD Trail Crossing at Sterling Boulevard **No Change**


### Ashburn Road Improvements No Change

[A study \(PDF\)](#) was completed in 2020 on driver and pedestrian safety along the corridor of Ashburn Road between Gloucester Parkway and Farmwell Road/Ashburn Farm Parkway. The Board has allocated over \$300,000 for engineering and construction of the identified short-term solutions (page 12): additional signage, pavement reconfiguration, and new pavement markings. Construction of the short-term improvements began in spring 2022, including the raised median, bike lane "Sharrows", and stamped/painted asphalt.



### Barrister Drive No Change

This project constructs an extension of Barrister Drive, from the existing terminus south of Loudoun County Parkway, to the east under the Dulles Greenway, then turning north to connect to the future Shellhorn Road extension. The construction is being funded by the builder of the Silver District West development as a transportation proffer with the project approval. Construction will not be completed for several years. 
### Belmont Ridge Road Widening **No Change**

[This project](#) provides for the widening of Belmont Ridge Road from two to four lanes from Truro Parish Drive to Croson Lane. Construction began in early spring 2022 with project completion estimated for summer 2024, weather permitting. Storm sewer pipe installation, wet utility construction, and demolition work is currently underway. Portions of future southbound lanes between Truro Parish Drive and Alford Road have been paved.



### Croson Lane Widening

[This project](#) provides for the widening of Croson Lane to a four-lane, median-divided roadway from Claiborne Parkway and Old Ryan Road. Design plans have reached 30% with environmental investigations and utility coordination underway. Plans are being developed to redesign the traffic signal planned at the intersection with Mooreview Parkway. A virtual community public input meeting was held on Thursday, April 20. ### Davis Drive Extension and Bridge **No Change**

This project provides for the extension of Davis Drive from its existing terminus at Old Ox Road, south, to Innovation Avenue. The project also calls for Davis Drive to extend further south from Innovation Avenue to cross the Dulles Toll Road and intersect with Sunrise Valley Drive in Herndon. The Waterside developer will build the portion of Davis Drive from Old Ox Road to Innovation Avenue with the County building the bridge. The extension will be four lanes with sidewalks on both sides and will not open for many years.



### Davis Drive/Sterling Boulevard Intersection Improvements **No Change**

On July 6, 2021, the Board of Supervisors accepted the improvements identified in [a study](#) of pedestrian and vehicular improvements [along Davis Drive, in Sterling](#), from West Church Road to South Sterling Boulevard. The bike lanes installation on Davis Drive was performed by VDOT as part of a regularly scheduled repaving in summer 2021. The additional improvements estimated to cost \$2.3 million will be discussed during budget deliberations in March 2023.



### Farmwell Road Intersection Improvements

Intersection Improvements along Farmwell Road, from Ashburn Road to Smith Switch/Waxpool Roads, are at 90% design plans. 100% design completion has been delayed until spring 2023 due to delays in utility coordination. Construction for the project is scheduled to begin in winter of 2025 and end in fall 2026. The

Board of Supervisors endorsed [the major project design elements](#) at its May 4, 2022 business meeting.

Supervisor Glass worked with the Ashburn Village HOA to minimize impacts along along the project section south of Fultonham Circle.

### George Washington Boulevard/Route 7 Overpass

Work is underway to extend George Washington Boulevard (Route 1050) from Research Place south to Russell Branch Parkway via a new bridge over Route 7

(Harry Byrd Highway) to reduce congestion and improve accessibility for drivers, bicyclists and pedestrians. The project is scheduled for completion in mid 2024. There also may be some traffic impacts in the area, but at least one lane in each direction of these roads will remain open at all times. 
### Loudoun County Parkway / Dulles Greenway Interchange **No Change**

This project provides for improvements to be made to the interchange with Loudoun County Parkway and the Dulles Greenway, including design, utility relocation, and construction. Design has not yet begun as this project has not yet been fully funded but has been identified for future funding. The cost estimate for these improvements is slated to be around \$20 million.



### Loudoun County Parkway Widening

This project provides for the widening of Loudoun County Parkway (Route 607) from four to six lanes between Ryan Road (Route 772) and Shellhorn Road (Route 643), and the construction of turn lanes at the intersections and shared use paths on each side. Construction of the widening opened last week. A traffic signal at Loudoun County Parkway and Claude Moore Drive is being approved.



### Old Ox Road Widening

This project is on hold after the Board of Supervisors voted on December 7th, 2021 to take over this project from the Waterside developer. The developer experienced increased costs and was unable to complete the project. The project provides for the design, right-of-way acquisition, and construction of the widening of Old Ox Road from four to six lanes from Route 28 to the Loudoun County/Fairfax County line at Rock Hill Road. VDOT is performing a study of the corridor to identify additional possible improvements.



This project provides for the construction of a new segment of Prentice Drive in Ashburn and Sterling from Lockridge Road to Loudoun County Parkway. The roadway will be a four-lane roadway with turn lanes, on-road bike lanes, and sidewalks. Phase two of this project has been delayed due to adjustments in the County's Capital Improvement Program. ### Route 7 Additional Eastbound Lane Widening (from Loudoun County Parkway to Route 28)

This project provides for the planning, design, right-of-way acquisition, and construction of an additional travel lane along eastbound Route 7 between the Loudoun County Parkway entrance ramp and the Route 28 exit ramp, to provide four continuous lanes between the two interchanges. The project is budgeted for \$6.2 million, and completion has been accelerated by a year due to adjustments in the County's Capital Improvement Program.




### Route 7 Corridor Study No Change

The [draft study](#) examined existing and projected conditions along Route 7, between Dranesville Road at the Fairfax County line to the Route 28 interchange. The study included an evaluation of the history of recent crashes, an analysis of existing traffic operations along the corridor, and travel demand forecasts. The Board of Supervisors confirmed alternative 4 as the preferred configuration in October 2021.



### Route 28 / Dulles Toll Road Interchange Study **No Change**

Completed in spring 2021, a study was performed to assess traffic movements and safety measures at the interchange between Route 28, the Dulles Toll Road, and the Dulles Greenway (also encompassing the interchanges between Route 28 and Innovation Avenue and Old Ox Road). The study identified a preferred "mega project" that will address much of the congestion and safety concerns along this corridor. View the unfunded study findings [here](#).




### Shellhorn Road and Sterling Boulevard Extensions **No Change**

[This project](#) constructs an extension of Shellhorn road from the existing terminus at Loudoun County Parkway through to the existing Sterling Boulevard interchange at Route 28. Portions of the Shellhorn Road extension will follow the existing alignments of Lockridge and Moran Roads. The project is currently in the design stage and will be constructed in segments. This project will now be accelerated one year due to adjustments in the County's Capital Improvement Program. ### **Waxpool Road Intersection Improvements I *No Change***

This project funds intersection improvements and turn lanes at Waxpool Road and Pacific Boulevard, intersection improvements and turn lanes at Waxpool Road and Broderick Drive, and intersection improvements and turn lanes at Waxpool Road and Loudoun County Parkway. Right-of-way authorization, land acquisition, and utility relocation are ongoing in coordination with VDOT. Construction is expected to begin in 2023. ### **Waxpool Road Intersection Improvements II *No Change***

[A study](#) was completed on the safety of Waxpool Road from Demott Drive to Faulkner Parkway. The Board has allocated \$300,000 to install a four-way stop at the intersection of Ashburn Road and Waxpool Road as a temporary solution before a traffic signal is installed by 2025. A roundabout will be installed by the end of 2023 at the Faulkner Parkway intersection. All missing links are being filled in the entirety of the corridor.
