BACKGROUND: The Loudoun County Sheriff's Office (LCSO) compiles a variety of reports to ensure that information is appropriately disseminated to command staff, affected personnel, the Board of Supervisors and other stakeholders, and the public about significant incidents, crime, and traffic matters. Some of these reports contain sensitive or confidential information, so they are not released outside of the LCSO. Additionally, the dissemination of certain records, criminal history, and other law enforcement information is governed by state law, which includes penalties for improper release.


Consistent with these considerations, the LCSO's Daily Incident Report summarizing notable activities and organized by the LCSO's regional stations is published each weekday by the LCSO's Media Relations and Communications Section and disseminated to the Board of Supervisors, the news media, and other interested parties.

These activities along with additional information are also compiled each quarter into the LCSO's Significant Incident Report that is presented to the Board of Supervisors following the end of the respective quarter. It includes agency highlights; awards and recognition; community outreach; generally significant incidents; community policing data; countywide calls for service; countywide crime statistics; significant incidents and crime statistics specific to each of LCSO's four regional stations; court services statistics; and corrections statistics.

Crime statistics are based on reports submitted to RMS as of April 17, 2023, for the period of January 1 – March 31, 2023 (UCR Reporting).

Loudoun County Sheriff's Office AGENCY HIGHLIGHTS

The Loudoun County Sheriff's Office (LCSO) continues to perform as the premiere local law enforcement agency in Northern Virginia and the Washington, D.C., metropolitan region, and is pleased to provide this quarterly report.

The LCSO currently employs approximately 650 sworn and 202 civilian personnel, and manages law enforcement, community engagement, courts, and corrections activities as the largest full-service Sheriff's Office in the Commonwealth of Virginia.

The LCSO's efforts are succeeding by every meaningful metric, and Sheriff Mike Chapman is committed to continually raising the bar and collaborating with all interested stakeholders.

The Metropolitan Washington Council of Governments has reported that Loudoun County has the lowest serious crime rate as reported by any law enforcement agency in Northern Virginia, a rate that is down 47% over the past 12 years.

LCSO continues to be a regional leader in mental health training and related programs for our personnel. Most deputies are certified in Crisis Intervention Training, and many in advanced training. School Resource Officers (SROs) are among our most experienced deputies and have additional training to enhance their interactions with young people and adult members of the Loudoun County Public School community.

Citizen satisfaction with the performance of LCSO in keeping them safe continues to be extraordinarily high as measured by independent research. The most recent survey by the International City/County Management Association shows overall satisfaction at approximately 90%. At the same time, LCSO continues to strive for improvement, and solicits both compliments and complaints from the public through social media, our web site, and in person. Sheriff Chapman personally reviews much of this input for awareness and follow-up.

While recruitment of new, first-time deputies and transfers from other law enforcement agencies is an ongoing challenge, LCSO is faring better than our regional counterparts thanks to the agency's national reputation for excellence, its positive engagement with stakeholders, and the opportunities afforded for job enrichment and professional development. LCSO's compensation and benefits are generally competitive, and we have not had to rely on large cash incentives like Washington, D.C., and other jurisdictions to recruit talented individuals. Even without this, 56% of LCSO's new hires in 2022, and 31% over the past six months, have previous law enforcement experience.

and Route 9. The deputies responded to dozens of calls that day and even helped cut trees away from power lines and remove trees from roadways. Working with patrol units, the traffic team was able to reroute traffic safely, including multiple tractor-trailers, and reopen the roadways.

The LCSO is elated to welcome Deputy First Class Camron Gentry back after being shot multiple times in January 2021.

On January 2, 2021, DFC. Gentry responded to the Walmart at Dulles Crossing Plaza in Sterling for a suspected shoplifter. While taking the suspect in custody, the suspect pulled out a gun and shot two security guards and DFC. Gentry. DFC Gentry was shot multiple times and spent 43 days in the hospital, where he underwent numerous surgeries.

This is an incredible story of survival and bravery as DFC Gentry continues to recover from his injuries. The LCSO is proud to witness DFC Gentry return to work and to support him through his recovery process.

DFC. Gentry continues to exhibit the same bravery in his recovery as he did the night he was seriously injured. He is currently assigned to the Training Division.

LCSO Graduates One Member from Professional Executive Leadership School

The Loudoun County Sheriff's Office graduated one member of the agency's leadership staff from the 52nd session of the Virginia Police Chiefs Foundation Professional Executive Leadership School (PELS).

First Lieutenant Joshua Brumbaugh, a 13-year veteran of the agency, graduated on March 16, 2023, from the intensive three-week leadership education program. Lt. Brumbaugh serves as the Assistant Station Commander for the Dulles Station of the Field Operations Division.

The PELS program is conducted in cooperation with the University of Richmond. This program is designed for individuals who currently serve in command/executive-level positions within their agencies. The curriculum is liberal arts/humanities-based and focused on the study of leadership at an advanced level. The objective of this program is to acquaint participants with best practices in leadership, challenge them to reflect upon their own leadership



competency, and examine ways of achieving both personal and professional growth.

DFC. Gentry and DFC. Ewing Receive Best of Virginia Sons of the American Revolution Award

Congratulations to DFC. Camron Gentry and DFC. Charles Ewing for being selected as the 2022 Best Virginia SAR Nominee for Heroism and Life Saving.

DFC. Gentry and DFC. Ewing were recognized last Friday by the Sergeant Major John Champe Chapter of the Sons of the American Revolution Virginia Society.



The citation for Heroism honoree DFC. Gentry reads in part; "Deputy First Class Camron Gentry's actions on January 2, 2021, in the face of extreme danger, and without regard to his own personal risk, quickly engaged an armed suspect while placed between innocent citizens and the violent suspect. With this selfless action, Deputy First Class Gentry was struck multiple times with rounds from the suspect's firearm which rendered him physically unable to continue to engage the suspect. While suffering from potentially fatal wounds, was able to compose himself enough, despite these serious wounds, to advise dispatch with critical details of the violent confrontation and need for immediate assistance for the other wounded and himself."

The citation for Life Saving honoree DFC. Ewing reads in part; "DFC Charles Ewing responded to a call on January 2, 2021, for a fellow Deputy with a suspect that was being detained which escalated into a violent confrontation with the suspect firing multiple rounds at the Deputies and private citizens." It went on to read; "DFC Ewing then calmly took immediate measures to render emergency aid to DFC. Gentry by applying two tourniquets to his life-threatening wounds and

then assisted other first responders with the additional wounded. Medical professionals have credited DFC Ewing actions for saving DFC Gentry's life."

Congratulations to both of you for receiving this prestigious state award.

<u>Virginia Senate and House Commend Sheriff Mike Chapman as National Sheriff of the Year</u>

March 17, 2023

The Virginia Senate and House of Delegates passed resolutions last month commending Loudoun

County Sheriff Mike Chapman for receiving the 2023 Ferris L. Lucas "Sheriff of the Year" award from the National Sheriffs' Association (NSA).



The chief patrons of Senate Resolution 166 and House Resolution 457 were

Senator Jennifer Boysko (D-33rd) and Delegate Dave LaRock (R-33rd), respectively. Both resolutions passed unanimously on February 24, 2023, and NSA will officially present the award to Sheriff Chapman at its Annual Conference in June.

LCSO Participates in Loudoun County Public Schools (LCPS) Fentanyl Awareness

Forums March 29, 2023

The LCSO participated in six LCPS-hosted awareness forums on fentanyl and other opioids in February and March.

"Fentanyl is a particular danger due to its extreme toxicity, low cost of production, and availability in many easily disguised forms," said Loudoun County Sheriff Mike Chapman. "Here in Loudoun County, we are committed to keeping it out of our communities and schools, and to working with our partners to ensure greater awareness and treatment options," he added.

There have been four fatalities out of nine opioidrelated overdoses in Loudoun County so far this year. Four of those overdoses were juveniles.



Loudoun County Crochet & Knit Clubs Donate to Soft Interview Room

April 3, 2023



The Leesburg and Cascades Senior Center and St. John's Prayer Shawl Crochet and Knit Clubs stopped by the LCSO to drop off toys, blankets, and shawls. These items will be used in the LCSO soft interview room.

In 2021, the LCSO partnered with Project Beloved: The Molly Jane Mission to create a soft interview room for victims of violent crime. The soft interview room is located at the LCSO headquarters in Leesburg. The room includes comfortable chairs, wall decorations, rugs, and soft lighting funded by Project Beloved. Soft

interview rooms are part of a Trauma-Informed Care (TIC) response and create a space that is comfortable for victims and witnesses to feel physically and emotionally safe. Detectives with the LCSO trained in interviewing victims of trauma will utilize the room when talking with victims of traumatic crimes.

We are honored to add these crocheted items to the room to provide comfort for those who need it the most.

Loudoun County Sheriff's Office SIGNIFICANT INCIDENTS*

Suspect Arrested After Stabbing

February 5, 2023

On Sunday, February 5, 2023, at approximately 12:00 am, deputies responded to the 21800 Towncenter Plaza in Sterling, for a report of a male suffering from stab wounds. Upon arrival, deputies located the victim in the parking lot suffering from multiple stab wounds. Deputies provided immediate lifesaving aid to the victim before he was transported to a local area hospital for treatment.

The suspect remained on scene and was taken into custody.

William J. Addison, 36, of no fixed address, was arrested and charged with Aggravated Malicious Wounding and Stabbing in the Commission of a Felony. Addison was transported to the Loudoun County Adult Detention Center where he is being held on no bond.

Ronald Roldan Sentenced for Killing Bethany Anne Decker in January 2011

February 21, 2023

Ronald Roldan was sentenced to serve 12.5 years for killing Bethany Anne Decker. In a January 9, 2023, recorded interview with the LCSO and the Office of the Commonwealth's Attorney, Roldan admitted he put Bethany's body in a Christmas tree disposal bag and put it in the apartment complex trash compactor.

Bethany Anne Decker was five months pregnant when she went missing on January 29, 2011. Bethany's body has not been found. The LCSO Cold Case Unit, established in 2012, has done an extensive amount of work on this case, especially Detective Mark Bush.



High Value Jewelry Robbery

February 25, 2023

On February 25, 2023, at approximately 9:10 pm, deputies responded to the 45600 block of Dulles Eastern Plaza (Dulles Town Crossing) in Sterling, for a report of an armed robbery. The victims reported that while parked in a vehicle, multiple subjects ran up, broke the windows, and removed multiple cases containing a significant amount of jewelry imported from India. During the robbery, one of the suspects held a knife to one of the victims' throats.

It was reported that there were at least three suspects involved. One of the suspects is described as a White male, wearing a green ski mask, gloves, and a black hooded jacket. The suspects fled the area in a grey or white SUV driving toward Nokes Boulevard.

One of the victims sustained minor injuries and was treated at the scene. This case remains under investigation.

LCSO Charges Leesburg Man in Shooting at Dulles Town Center Mall

April 2, 2023

The Loudoun County Sheriff's Office has arrested and charged a Leesburg man involved in a shooting at the Dulles Town Center Mall Food Court this morning.

Alan W. Colie, 31, was arrested and charged with aggravated malicious wounding, use of a firearm in the commission of a felony and discharging a firearm within a building. The shooting resulted from an interaction between the victim and Colie in the food court.

LCSO received the first call reporting that a shooting had occurred at the Dulles Town Center mall at approximately 11:57 AM, and deputies quickly responded, arriving on the scene within three minutes of the call. Deputies immediately entered the mall and took the suspect into custody at approximately 12:02 PM. One adult male victim was found



outside the mall with a gunshot wound to the abdomen. The victim was treated for injuries by deputies and members of the Loudoun County Combined Fire and Rescue System (LC-CFRS) and transported to a local hospital for treatment. At this time, it does not appear that the suspect and the victim were known to each other.

LCSO deputies also checked the entire mall to ensure no other suspects or victims were present. Dulles Town Center management closed the mall for the remainder of the day.

<u>Furgan Syed Found Guilty of First-Degree Murder, Statutory Burglary, and Use of a</u> <u>Firearm in the Commission of a Felony</u>

April 14, 2023

Furqan Syed has been found guilty after a two-week jury trial for the December 2021 murder of Najat Chemlali Goode.

Najat Chemlali Goode was killed in her Ashburn home on December 30, 2021. After the murder, Furqan Syed fled to Dubai. In March 2022, Syed was arrested in a coordinated effort with the U.S. Marshal's Service, U.S. Customs and Border Protection, U.S. Homeland Security Investigations, U.S. Diplomatic Security Service, U.S. Department of Justice's Office of International Affairs, the Abu



Dhabi Police, and detectives with the Loudoun County Sheriff's Office.

Syed will be sentenced on July 13, 2023.

Traffic stop data from the Loudoun County Sheriff's Office is available online as part of the Virginia Community Policing Act. The Act requires that each time a local law enforcement or State Police officer stops a driver of a motor vehicle, the following data is collected based on the officer's observation or information provided by the driver:

- (i) the race, ethnicity, age, and gender of the person stopped;
- (ii) the reason for the stop;
- (iii) the location of the stop;
- (iv) whether a warning, written citation, or summons was issued or whether any persons were arrested;
- (v) if a warning, written citation, or summons was issued or an arrest was made, the warning provided, violation charged, or crime charged;
- (vi) whether the vehicle or any person was searched; and
- (vii) whether any person used physical force against any officers and whether the lawenforcement officer or State Police officer used physical force against any person.




The graph below shows LCSO service data for Loudoun County from January 1 to March 31, 2023, compared to the same period in 2021 and 2022.



Sterling Woman Charged in Stabbing

April 7, 2023

LCSO Arrests Two Suspects in Burglary

February 11, 2023

The Loudoun County Sheriff's Office (LCSO) arrested two men in connection with a burglary in Aldie at an electrical storage yard on Dominion Energy property.

On February 11, 2023, at 12:38 am, deputies responded to the 26000 block of Auburn Farm Road for a report of two males cutting a fence on an area of Dominion Energy property that is leased to another entity. Deputies quickly arrived on scene and were able to locate the two suspects who had breached the storage yard and place them in custody. A bag with wire cutters was recovered at the location.

While the incident remains under investigation, all indications point to the subjects being there to steal copper wire. Dominion Energy officials confirmed there was no breach of an adjacent Dominion Energy Substation.

Christopher J. Macmillan, 51, and Joshua L. Settle, 38, both from Manassas, were charged with Possession of Burglary Tools, Attempted Larceny, Trespassing, Destruction of Property, and Conspiracy to Commit Larceny.

This case gained national attention due to the recent arrest of two people who planned to attack a power grid in Baltimore.









Operations – FY2023 YTD & Q3 Incident Analysis

The Loudoun County Combined Fire and Rescue System has responded to a total of 26,771 incidents between July 1, 2022, and March 31, 2023, of which 20,260 were EMS incidents and 6,511 were fire incidents. Charts 1 – 4 below display a breakdown of third quarter FY2023 calls by incident disposition (EMS v. Fire), most dispatched EMS incident types, and most dispatched Fire incident types.










Operations - Incident Response by Area

Firefighters and Animal Control Rescue

On January 19, 2023, Loudoun County Fire and Rescue units from Sterling Park and Animal Control responded to an animal rescue. A dog, "Knox", had the pad of its paw stuck in the driver's sidestep of a tractor trailer. The step had a small hole that the pad and two nails fell into while attempting to get into the tractor trailer. The step was removed off the tractor trailer which allowed the owner and dog to step down to the ground for easier access to remove the metal from the paw. Animal Control arrived on the scene and was able to work with the dog's owner to assist in comforting the dog. Several tools were utilized to cut the step away from the paw. Once the paw was free, Animal Control transported the dog to a nearby vet for evaluation.



Fire at Old West Park Club House



Monday, January 23, 2023, Fire and Rescue personnel were dispatched for a possible building fire at the Old West Park Club House. Leesburg PD arrived on scene advising smoke coming from the structure. Units arrived with a 2 story in the front, 3 story in the rear, abandoned commercial structure with light smoke showing from side alpha. Crews located a small fire on the inside of the building on floor 1. The fire was extinguished quickly, and primary/secondary searches were completed with negative results.

Fire in Downtown Leesburg Displaces Two Residents

On Thursday, January 26, 2023, Loudoun County Fire and Rescue crews were dispatched for a house fire at 3 Royal Street in Leesburg shortly after noon. 911 callers reported smoke and fire from the roof of a single-family home. Units arrived on scene to find heavy fire from the rear of the home and all occupants located safely outside.

The LCFR-FMO investigators estimated the damages at \$396,000 for both the structure and contents. There were no injuries to firefighters or civilians. Two adults have been displaced and are staying locally with family.



Firefighters Rescue Resident in Early Morning Fire



On February 6, 2023, units responded to a reported house fire on Thrush Road in Sterling.

Firefighters encountered heavy smoke and fire conditions from the rear of the structure. While the crews worked to extinguish the fire, rescue personnel forced entry into the home to search for trapped occupants. One unconscious adult victim was rescued but eventually succumbed to his injuries. Several unresponsive pets were also rescued from the home. Animal Services responded to assist with two dogs and one cat that did not survive.

An investigation by the Fire Marshal's Office determined that the house fire was caused by a malfunctioning lithium-ion battery pack. The Fire

Marshal estimated the dollar loss at \$351,000 for both the structure and contents.

LCFR Fire Marshal's Office Makes Arrests in Connection to Clubhouse Drive Fires (Leesburg)

On March 16, 2023, the Loudoun County Fire and Rescue Fire Marshal's Office (LCFR-FMO) arrested three individuals in connection with a January 23, 2023, arson fire that occurred at 59 Clubhouse Drive in Leesburg. The structure, formerly operated as the Clubhouse for Westpark Golf Club, was the subject of an ongoing investigation of other fires that occurred around January 9th of this year. While under surveillance, suspects were identified and a digital forensics analysis was completed, which supported the issuance of search warrants and arrest warrants by the Loudoun County Magistrate's Office. All three individuals are being held at the Loudoun County Adult Detention Center and are awaiting arraignment.

Smoke Alarm Plays Critical Role in Sterling Fire

Monday, March 20, 2023, at 3:40 p.m., a 911 call reporting a structure fire at a home on Thrush Court in Sterling was reported.

When firefighters arrived on the scene, they discovered a one-story, singlefamily house with significant fire showing from the front and rear. One adult occupant had self-evacuated and was located outside the home. Firefighters quickly knocked down the bulk of the fire from the exterior before making their way inside. Crews performed search and rescue operations and extinguished the remaining fire.

The Fire Marshal's Office investigation determined the fire was accidental in nature due to combustible materials being stored in close proximity to a heating appliance (water heater). Dollar loss has been estimated at \$310,200.00 for the structure and \$186,120.00 for contents.



Awards, Kudos, and Accolades

Training Graduates

On January 5, 2023, volunteer system members were joined by friends and family, along with members of LC-CFRS leadership, Loudoun County Administration, and the Loudoun County Board of Supervisors at a ceremony to recognize their accomplishments and milestones.

- 47 students completed the Emergency Medical Technician-Basic (EMT-B) course
- 10 students completed the Firefighter I-II course
- 10 students graduated the Emergency Medical Technician Paramedic (EMT-P) program

In addition to their full-time jobs, schooling, and family obligations, the graduates dedicated countless hours over the last six months to their training and have achieved Loudoun County, Commonwealth of Virginia, and National Certifications.

Loudoun Fire Chief and Firefighter Receive Honors

Two Loudoun first responders were among honorees from across Virginia that received awards at an official ceremony in February. Governor Glenn Youngkin announced the recipients of the 2022 Governor's Fire Service Awards as part of the annual Virginia Fire Chiefs Association Expo and Symposium in Virginia Beach.

System Chief Keith Johnson was awarded the Virginia Fire Chief's Association's Glenn A. Gaines Leadership Legacy Award. This annual award recognizes an individual for superior leadership and actions that have elevated the fire service profession within the Commonwealth of Virginia through mentoring, teaching, and sharing outstanding contributions. This award highlights Chief Johnson's many contributions to the fire service in Virginia and a legacy that invokes innovation, pride and compassion in his duties as Fire Chief and as an outspoken advocate for the health and safety of citizens and first responders.





Firefighter/EMT Meaghan Gruber was awarded "Firefighter of the Year" for her heroic actions during a house fire in which a teenager and a fellow firefighter were rescued. In March 2022, Meaghan responded with others to a house fire in Purcellville where her quick search located a 15-year-old girl in a 2nd floor bedroom and seamlessly coordinated the rescue with her team. Firefighter Gruber has also received recognition with awards such as LCFR's Walking Heart for successful resuscitation. She always seeks to positively impact those around her, both in the community and in her fire and rescue family.

LCFR Promotions Celebrated

On February 13, 2023, leadership from Loudoun County Fire and Rescue held a ceremony honoring the promotional achievements of many of our first responders. Members of the Board of Supervisors and Loudoun County Administration joined along with friends, family, and peers to celebrate each of these individual milestones. All levels of operations personnel, 911 communicators, and Fire Marshal's staff were celebrated. The occasion also allowed for the official swearing in of Assistant Chief Travis Preau and Deputy Chief Todd Lupton by Gary Clemens, Clerk of the Circuit Court of Loudoun County.





Community Event

On February 11, 2023, members of Fire Station 27 (Kirkpatrick Farms) attended Lightridge High School's Unified Basketball game. The Unified Basketball team consists of students with disabilities and partner



athletes for support. Students had been learning about emergencies and the role of first responders in class and wanted to invite the firefighters/EMT's to their game! The players



worked very hard on their invitation letter which their coach, Ms. Alyssa Hembree, shared to Capt. Michael Ciaburri. The students were most impressed that they had the support and presence of "the cool firefighers/EMT's" at their game!

LCFR Assistant Chief Accepted to Fire Service Executive Development Institute (FSEDI)



Assistant Chief of Support Services and Volunteer Administration Travis Preau has been accepted into the Fire Service Executive Development Institute (FSEDI). This program is a year-long leadership-development program, created and implemented by the IAFC, to provide new and aspiring chiefs with the tools they need to have successful and productive tenures. The group meets three times throughout the year, shares information between sessions, and continues their learning process using an on-line community. Their on-site sessions were held at the National Conference Center in March 2023.

LCFR Promotes Two Deputy Chiefs



In March, Battalion Chief Jason Collins was promoted to Deputy Chief of Special Operations & Emergency Preparedness. In his new role, Chief Collins will provide management and oversight of Special Operations program and staff, including the Hazardous Materials, Technical Rescue, and Swift Water/Boat Operations programs as well as provide management and oversight of Emergency Preparedness within Loudoun County Fire and Rescue.

Battalion Chief Justin Green was promoted to Deputy Chief of Communications and Support Services in March. Chief Green's position is responsible for overseeing the Loudoun County Emergency Communications Center (ECC), supporting the Computer Aided Dispatch System (CAD) and Geographic Information Systems (GIS), Loudoun's Public Safety Technology Group, Uniformed Fire Officers program and communications and technology support services for the Loudoun County Combined Fire and Rescue System.



Loudoun's Fire and Rescue System Honors 2022 Awardees

On March 27, 2023, the LC-CFRS held their Annual Awards and Recognition Ceremony to honor Loudoun's first responders, staff, and citizens who made dramatic contributions to the life and safety of our community. Local first responders, their families and friends gathered to celebrate the accolades of all the awardees. Chair Phyllis Randall expressed her gratitude to all the honorees. The LC-CFRS senior staff congratulates the honorees that received an award for their achievements.

LCFR Retirements

On February 28, 2023, we congratulated Robert "Scottie" Edmonds on his retirement after 36 years of dedicated service to Loudoun County and the residents of this community. Scottie was instrumental in helping to transition the LC-CFRS across multiple radio platforms.

Health, Safety, Facilities and Fleet

On March 22, 2023, the Health, Safety and Wellness team hosted members of Saville-Occupational Health as they toured our Training Academy's facility to better understand not only what we do, but how we do it. Clinicians and staff from Risk Management were able to get a first-hand look at firefighter PPE and learned about the risk of occupational exposures that firefighters face each day in the performance of the job. This information will help inform cancer screening and prevention efforts.

Volunteer Programs Division



On Saturday, March 25, 2023, the Aldie Volunteer Fire Department hosted a VFIS Emergency Services UTV/ATV Operations Safety Training Course taught by Aldie VFD. There were 15 participants within the System that attended.

The purpose of the class was to train on the safe use and operations of Emergency Services-Owned UTV's and ATV's. The course had classroom instruction, skill stations, followed by practical training on some of the mountain trails in Aldie.

On March 15, 2023, the Purcellville Volunteer Fire Company (PVFC) announced their 100th year of service to the citizens of Purcellville and surrounding areas. PVFC was established in 1923 after the Town of Purcellville endured a series of disastrous fires, the first in 1900 and then two more in 1914, which virtually wiped out the business district, depriving the Town of much of its earliest architectural heritage, and ever since its founding in 1923, the PVFC has been dedicated to protecting the community and providing top-quality fire and emergency medical services.

On February 5, 2023, a drive by parade was given to William Muncaster who has Downs Syndrome. William's father had passed away on January 31, 2023, and his funeral and burial were the day before. William had mentioned to his family that he had heard about a drive by parade and would like one. With the assistance of family, friends and community members, a parade of hundreds of vehicles drove by the Muncaster residence to wish William a Happy Birthday. Fire and Rescue units from Hamilton Fire, Hamilton Rescue, Purcellville Fire and Purcellville Rescue participated in the parade, as E605 and a unit from the LCSO led the parade. Some vehicles blew horns, while others stopped to give hugs or give William cards and presents.

Fire Marshal's Office Employee Honored

SUBJECT: SIGNIFICANT INCIDENT REPORT/Q3 FY2023/Department of Animal Services

BACKGROUND: Attached is a significant incident summary report for the Department of Animal Services (LCAS). This report provides the Board of Supervisors with comparative statistics and information for the third quarter of FY 2023 (January - March 2023). The information includes departmental programs and services, including humane law enforcement activities (historically referred to as "animal control activities"), animal sheltering data, adopter survey information and volunteer activities. Additionally, information regarding key activities and/or incidents that occurred during the third quarter of FY 2023 is provided in the paragraphs below.

FY23 Q3 - LCAS Programs and Events

LCAS Humane Education - On and Off-Site Programs

In the 3rd quarter, LCAS held forty-two humane education programs. LCAS visited after-school programs, adult day centers, and local elementary and middle schools and libraries to present humane education programs. Topics included dog safety, wildlife, pet care and animal body language. LCAS humane educators worked closely with other programs and educators in the county to present engaging, relevant and community specific materials.



LCAS continued the 'Reading to Cats' program at the shelter. This program teaches the public about cat body language and behavior while they sit with and read to cats at the shelter. In addition to providing companionship, comfort, and attention to the cats, it promotes cat ownership and adoption in our community. Also, the humane education program hosted a series of "Critters and Crafts" activity sessions for children. Each session focused on learning about a pet or wildlife in Loudoun County and included a fun activity and/or craft as well. Critters and Crafts continue to have all sign-up slots filled. This quarter, LCAS Humane Education held an "Animal Care Class" for middle school students. This four-

part class taught participants about animal care, different needs for various species, and basic medical and behavioral knowledge as well. The Animal Care Class was filled with a waitlist.

LCAS Volunteer Program

During the 3rd quarter, LCAS volunteers gave 4,962 hours. Volunteers attended numerous events, including mobile pet pantries, to help staff offer low-cost services and raise awareness of Animal Services in Loudoun County. Volunteers assisted with in-shelter educational events and programs, helped with Puppy Yoga classes and supported staff during the influx of dogs experienced by the shelter in the third quarter. Volunteers continue to perform administrative tasks while training in and supporting more involved shelter programs and tasks such as low-cost clinics, spay/neuter day recovery.



LCAS Foster Program

During the 3rd quarter, foster families provided 1,707 hours of care involving neonatal kittens with and without mothers, and medical cases involving a variety of species. LCAS saw a substantial local influx of dogs arriving at the shelter, including those with additional medical or behavioral needs. LCAS fosters assisted with providing shortterm foster homes and field trips for these incoming dogs.





LCAS Community Programs, Events & Outreach

Low-Cost Clinics

LCAS hosted three low-cost clinics during the 3rd quarter. These clinics utilized a drive-up clinic approach and offered vaccination services, dog licenses and microchipping, on a walk-in, drive-through basis to all members of the community. Shelter staff and volunteers were on hand to answer questions, provide services, assist with dog licensing, and create a positive experience for members of the community. Clinics continue to run at maximum capacity with a total of 225 animals coming through the clinics.

Outdoor Cat Low-Cost Spay/Neuter Clinics

LCAS continued holding low-cost spay/neuter clinics for outdoor cats. These clinics aim to reduce the number of stray kittens and feral cats in the county and offer residents an affordable option for fixing these cats. All cats attending the clinics are spayed/neutered, vaccinated, microchipped and ear tipped.



Guinea Pig-nic and Bunny Hop

During the 3rd quarter, LCAS held an event aimed at increasing interest in small animal adoption and ownership while also providing small animal owners in the community a resource for education, nail trims and socialization. The Guinea Pig-nic and Bunny Hop event offers free nail trims, information sessions on basic medical care, training and fostering, activities for children and chances for community members to interact with adoptable small animals. The event continues to grow each year with 151 people attending the 2023 event.



Group Walks

To assist the increased population of dogs in the kennels, LCAS started an "Afternoon Group Walks" program. The program invited members of the public to come and take the adoptable dogs out on an afternoon walk, offering the dogs a fun afternoon out of the kennels, while increasing their exposure to potential adopters and helping them develop skills such as leash walking, walking in a group and down sidewalks as well. All Afternoon Group Walk sessions were filled.





BISSELL Pet Foundation Transport

During the 3rd quarter, LCAS participated in a transport effort with other local area shelters and the BISSEL Pets for Life Foundation. LCAS took in 14 cats and one dog from this flight from shelters in under-resourced areas.





Pet Pantry Program

The Pet Pantry Program is a joint effort between Loudoun Hunger Relief, the Humane Society of Loudoun County, and LCAS to ensure residents in need of pet support can keep their pets during temporary times of financial distress. Each month, LCAS delivers pre-made dog and cat food kits for distribution through Loudoun Hunger Relief. This quarter, Loudoun Hunger Relief continued to see a demand for pet food due to COVID-19. In addition to supplying the regular pantry location, LCAS has started supplying two mobile pantry efforts in Sterling to meet the demand for pet food. Also, 1,291 kits were packed and delivered weighing a collective total of over 7,500 lbs. This program is currently fully supported by donations from the community and support from the Humane Society of Loudoun County.


Humane Law Enforcement


On March 7, 2023, the Board of Supervisors adopted a new section of Chapter 612, Dogs and Other Animals, of the Codified Ordinances of Loudoun County that prohibits ownership of certain exotic and venomous species of animals that present a risk to public health and safety. The new section of the ordinance also prohibits the breeding of such animals. Virginia law already restricts private ownership of many other wild and exotic animals. The ordinance does not impact entities that are licensed or permitted through the Virginia Department of Wildlife Resources or other state or federal agencies to house restricted species. The amended ordinance allows current owners of the listed animals to keep them but requires registration of these animals through a process the county will establish by May 8, 2023. Staff will provide an update about the registration after it closes in the next significant incident summary report.


On February 16, 2023, the Loudoun County Sheriff's Office (LCSO) requested Humane Law Enforcement Officers (HLEO) respond to a residence in Round Hill where a welfare check was being conducted on a resident reportedly having a medical incident. Once inside, the deputies determined there were dozens of dogs being kept in deplorable conditions. Upon inspection it was determined there were over thirty dogs and cats in the residence . The investigation is ongoing by both LCAS and LCSO. Once the investigation is complete and staff can provide details, staff will provide an update in the next significant incident summary report.

Note: The data depicted in this report reflects specific categories of calls responded to by Humane Law Enforcement Officers (HLEOs). In addition to the calls reported, officers respond to a variety of other calls such as technical rescues, animal cruelty, pets in hot cars, stray roaming dogs and sick or injured companion animals.




