02/07/2024	Roundhill	Pop-Up Notice Computer Scam: The complainant reported that her computer froze and received a pop-up notice notifying her that she needed to call a phone number to unlock her computer. The complainant called the phone number and was asked to buy gift cards as a form of payment to resolve her computer issues. The complaint realized she was scammed after the gift card numbers were given. SO240002367

02/06/2024	Ashburn	Extortion Scam: The complainant reported that he sent photos to a person he met online. The person then began extorting him for money. SO240002308
02/07/2024	Ashburn	Law Enforcement Imposter Scam: The complainant reported receiving a phone call from a subject claiming to be a deputy from the Loudoun County Sheriff's Office (LCSO). The alleged deputy told her that she missed a jury duty and requested a payment to avoid an arrest. The complainant was directed to deposit money into a Crypto Coin Star kiosk. The complaint realized that she was being scammed when she called LCSO to confirm the name of the alleged deputy. SO240002388

Safety Tips / Announcements

EXTORTION SCAMS

The Loudoun County Sheriff's Office has received reports of people being targeted by extortion scams, to include dating apps. The scammers often pose as young women and target victims and request to exchange explicit photos.

In one scenario, the scammer tells the victim they will share the conversation and photos with family members and friends if they do not send money.

In another scenario, the victim is told to pay for the time with the "female". If the victim declines to pay, they receive a phone call through an app demanding money and threatening the victim and their family members. The caller sends violent images and provides information about the victim's family such as their names and address.
