**EI - Eastern sector that includes everything East of Rt. 28 and everything North of the Greenway. Sterling Park, Sugarland Run, Countryside, Lowes Island are examples of the towns in this area.**

**EII - Eastern sector that includes everything East of Rt. 15 and South of the Greenway and Ryan Road. South Riding, Arcola, Lenah are examples of towns in this area.**

**Ashburn - This sector includes everything East of Belmont Ridge Road, everything West of Rt. 28, and North of Ryan Road and the Greenway. Ashburn is the main town in this area.**

**Leesburg - This sector includes the Town of Leesburg and everything East of Rt. 15 and West of Belmont Ridge Road. Leesburg is the only town in this area.**

**N/W - Is the North Western part of the County that includes everything North of Rt. 7 (business Rt. 7 in towns), and everything West and North of the Town of Leesburg.**

**S/W - Is the South Western part of the County that includes everything South of Rt. 7 (business Rt. 7 in towns), and everything West of Rt. 15.**
