First-Half Personal Property Tax Deadline is May 6, 2024

Loudoun County Treasurer Henry C. Eickelberg reminds taxpayers that the deadline for payment of the first-half personal property tax is **May 6, 2024.**

Payments received or postmarked after May 6, 2024, will incur a 10% late payment penalty, **plus** an interest charge of 10% per year on both the unpaid taxes and all late payment penalties. Any personal property taxes that remain unpaid for more than 60 calendar days after the original due date will be charged an additional 15% penalty plus interest at 10%. Taxpayers who are having financial difficulties should contact the Office of the Treasurer's Collections Team at 703-771-5656 for assistance.

Payments can be made using electronic check (eCheck), VISA, MasterCard, American Express or Discover. Please note that there is a convenience fee added to credit card transactions. There is no fee for eCheck.
