



Bull Run Post Office Road Project and Rt. 50 Final Paving to Begin Next Week

I want to alert you to two upcoming projects that will have an impact on traffic over the next several weeks.

Beginning Monday, September 28th, **Bull Run Post Office Road will close** between Cedar Ridge Boulevard and the entrance to Cardinal Ridge Elementary School. The closure will be implemented between 7:00 am and 9:00 am Monday morning and last approximately 5 weeks. By closing the road to through traffic, VDOT and their contractor will be able to complete the drainage improvements and paving project 30 days sooner and save taxpayer dollars.

A detour will be put in place to direct traffic to Gum Spring Road. Residents that live on the closed section of Bull Run Post Office Road will be permitted special access during the project.

Also beginning Monday, Shirley Contracting will begin the **final paving of Rt. 50 between Rt. 28 and the Cub Run bridge.**

Traffic will be temporarily reduced to one lane between Rt. 28 and Pleasant Valley Fairfax from 8:00 pm to 5:30 am in sections while paving is underway.
