



Reminder: Dulles Direct Town Hall Meeting Monday, May 23

Don't forget that my second quarterly Dulles Direct Town Hall meeting of the year will be a joint community meeting with School Board Representative Jeff Morse hosted by the Dulles South Alliance. The Dulles South Alliance is an organization made up of area HOA's, businesses and stakeholders focused on Dulles South. The meeting will be held in the large meeting room at Gum Spring Library (24600 Millstream Drive in Stone Ridge) on Monday, May 23. Check-in begins at 6:30 pm and the program will start at 7:00 pm.

At the meeting, I'll give an update on Dominion's proposed power lines on Route 50 and the latest on the SCC case. I'll also recap the approved FY17 budget, provide updates on transportation projects that will be kicking off over the next several months, share the latest transportation developments and update you on the regional discussion on Metro. Finally, I will be discussing the beginning of the County's process to update our Comprehensive Plan. While that may not sound too exciting, the Comprehensive Plan is the underlying basis for all of the County's land use decisions, including residential development (which I know there is a lot of interest in).
