

Dear Leesburg Resident,

Thank you to all who attended the March on January 16th to honor Dr. Martin Luther King, Jr. It was the largest we have seen in 25 years. I want to thank the members of the "I Have A Dream Committee" and everyone who participated.

Congratulations to the residents and businesses in the Town of Leesburg for being recognized in the newly released research study by Wallethub as the 2017 Best Place to Raise a Family in Virginia. Leesburg ranked #2 in the Wallethub analysis that compared 82 communities statewide.

Budget

During February and March, the Board of Supervisors deliberates and adopts the Loudoun County FY 2018 budget. I've listed the public hearing and Board work session dates for your information. I hope you will attend one of the public hearings to voice your opinions.

At the January 11th Board meeting, the Board of Supervisors directed the County Administrator, Tim Hemstreet, to prepare the proposed FY 2018 budget at the estimated equalized real property tax rate. Mr. Hemstreet presented his proposed FY 2018 budget Wednesday, February 15th to the Board of Supervisors (please see the Your Tax Dollar at Work graphic below). The estimated equalized real property tax rate is \$1.135, the advertised rate is \$1.140 and the current tax rate is \$1.145. The homeowners' equalized tax rate is \$1.140. This rate would fund all needs and the LCPS budget in full.



Resident Survey

The results of the Loudoun County 2016 <u>survey of residents</u> were presented on February 7th. The purpose of the survey is to gather residents' opinions on County services, trends and key issues. The three most frequently mentioned benefits were location, including the proximity to DC, Loudoun County Public Schools and rural/open space/country. Growth and traffic were the two most frequently mentioned concerns. Overall, residents are very satisfied with county services and give high marks for Loudoun's quality of life. I want to thank the University of Virginia and staff for conducting an informative and statistically significant study of residents' needs and concerns.



Transportation

There will be a public information meeting on Thursday, March 2nd from 6:30 to 8:30 pm in the auditorium of the Leesburg Elementary School (323 Plaza Street NE) about the design and construction of the grade separated interchanges at Route 15 at Edwards Ferry and Fort Evans Roads. Please visit <u>VDOT's website</u> for a project overview and estimated timeline and costs.

The construction of Crosstrail Boulevard between Claudia Drive and Sycolin Road is on schedule. The design of the Crosstrail Boulevard extension between Kincaid Boulevard and Russell Branch Parkway may require the use of eminent domain. On January 3rd, the Board of Supervisors directed staff to diligently continue activities to acquire the right-of-way and easements needed to construct that segment of Crosstrail Boulevard by March 1st. If needed, the item will be forwarded to the April 2017 Board Public Hearing to initiate the eminent domain process to acquire properties.

I'd like to give an update on the Route 15 North improvements between Battlefield Parkway and potentially Lucketts or Point of Rocks. I attended a community meeting on January 30th. Citizens said there are three main issues that need to be addressed along this corridor: congestion, safety, and access for nearby residents and businesses who have to use Route 15. Roundabouts were discussed as a potential solution at the intersection of Route 15 business and the Route 15 bypass, Whites Ferry Road, Montresor Road, Spinks Ferry Road, Limestone School Road and Stumptown Road. Citizens suggested rumble strips in the middle of the road to prevent head-on collisions and grasspave, a permeable material, along the shoulders to reduce runoff and allow drivers to evade oncoming traffic. The County's consultant is planning to present the study to Board of Supervisors on April 4th and then convene a stakeholders group to review different plans.

Bus Routes

Loudoun County is seeking public input about new or modified bus routes and transit services through an <u>online survey</u>. You can also e-mail Paul Mounier at transitcomments@loudoun,gov to suggest a new route by March 1st. Survey responses are due March 31st.

Silver Line

I attended a staff presentation on the Financial Obligations of Loudoun Metrorail at the Transportation and Land Use Committee meeting on Friday, February 17th. As you may have heard, the cost of paying for metro has increased substantially. Please find the <u>staff presentation and report</u>. I've asked for updated and accurate projections so we know what we are dealing with regarding Loudoun's obligation. I also asked how the WMATA (Washington Metropolitan Area Transit Authority) compact defines a dedicated funding source to make sure our interpretation meets federal and state requirements. Staff will come back to the Board of Supervisors in April with updated projections and more information.

Please feel free to contact me or my Chief Legislative Aide with any issues or feedback. I look forward to meeting you at the budget public hearings.
