

Dear Leesburg Resident,

#### **Land Use**

On March 7th, a majority of the Board of Supervisors voted to reconsider the One Loudoun application. I did not support the motion to reconsider. I continue to be concerned about the number of residential units approved during this Board's term and in the past. The 2016 Resident Survey reported that citizens' number one concern is too much growth. I will not change my position on March 23rd when the Board takes a reconsideration vote on the 200 additional residential units proposed by One Loudoun.

#### **Preservation**

The Board unanimously supported Chair Randall's and my initiative to develop a cemetery preservation ordinance to protect existing and historic cemeteries and burial grounds during the land development process at the March 7th Board meeting. The Heritage Commission enthusiastically endorsed this effort. It is my desire to protect our heritage and save the burial grounds for enslaved people before they are forever lost to development.

On February 15th, I supported a minor special exception to increase the number of events permitted annually at Rust Nature Sanctuary. The expansion will make this property viable in the future. Leesburg residents consider the sanctuary a jewel and asset and the Northern Virginia Park Authority does a wonderful job keeping it wild and open to the public.

## **Budget**

The Board held <u>five budget work sessions</u>. The "equalized" tax rate is the rate at which the average homeowner's tax bill remains the same as last year. The proposed equalized tax rate for homeowners is \$1.140. I support the proposed real property tax rate of \$1.135, which fully funds the schools and funds many critical needs for the County like support for disabled residents and our veterans. This is also a tax cut for most residents. Any reduction in the tax rate below \$1.135 will have an impact on the schools by reducing the LCPS transfer from the County, resulting in a deficit between the School Board's requested funding and proposed budget. The schools have experienced significant funding cuts in years past and during this period of economic growth, I want to fund an increase in teacher pay, full-day kindergarten and other needs like new textbooks.

Last night, a majority of the Board voted to pass a tax rate of \$1.125, underfunding the schools by \$5.5 million. I did not support this motion. I will continue to advocate for full funding of our school system.

The Board voted to allocate \$5.265 million to fund LCPS bus purchases and \$3.8 million to fund turf fields at Heritage and Dominion High Schools. Congratulations to the Heritage High School Booster Club for their long and ultimately successful efforts to get artificial turf approved for the fall of 2017. This would not have happened this year without the persistence of Heritage and Dominion parents.

The Board voted to approve \$38,060 for the 0.47 FTE Veterans Coordinator in the FY 2018 Budget. At the request of our veterans, I requested that the County's part-time Veterans Affairs Coordinator position become full-time to help link veterans with both County government services and services provided by our VFW, American Legion, and other veterans' groups.

The Board voted to allocate \$600,000 of a requested \$1 million to expand contracts with supported employment and day support organizations like Every Citizen Has Opportunities (ECHO). ECHO helps place adults with intellectual and physical disabilities in jobs. It currently provides support to 100 people but has a wait list of 28 people.

Residents can speak at our Board Business Meeting on March 23rd during the public input session at 6:30 pm. Advanced sign-up is available until noon of the business meeting at 703-777-0200. The Board will adopt the FY 2018 budget and tax rate at the April 4th Business Meeting.

## Strategic Plan

The Board held a <u>special business meeting</u> on March 2nd to discuss staff's recommended work plan for the strategic focus areas identified at our September 16, 2016 Strategic Planning Retreat.

For the transportation focus area, I requested that there be better coordination related to commuter bus and public transportation options when looking at future applications for rezonings. I've heard from constituents that some bus routes are standing room only. I would like to see in the staff report the impact of a rezoning application on public transportation.

For the community health and wellness focus area, I asked about the needs of adults with disabilities. There is not enough housing and supportive services for these individuals. The County has a network of private and nonprofit providers like ECHO to address immediate and future needs but there is a backlog. The Board voted to increase spending for ECHO in the FY 2018 budget which will help but more will need to be done in the long-term.

For the growth management focus area, I requested an estimate of the operating costs for the education of students generated by a rezoning. The Board receives projections on the capital improvements required for a rezoning and I would like to address the additional operating costs in the staff report.

Staff will provide a biannual update on these initiatives. There will also be a Transit and Transportation Summit this summer and a Housing Summit in the fall. I will keep you informed about the dates and times of these events once they are scheduled.

#### **Transportation**

The VDOT public information meeting on March 2nd about the Route 15 interchanges at Edwards Ferry Road and Fort Evans Road was packed. There will be another opportunity to give input at the design public hearing to be scheduled. VDOT hopes to have the final designs endorsed by the Board and Leesburg Town Council later this year. You can see the three configurations under study at the Fort Evans Road interchange by visiting the <a href="VDOT website">VDOT website</a>. The layout of the Edwards Ferry Road interchange is largely set. This project does not have construction funding or a construction date yet.

Please take note of the two planned night closures at Route 7 & Belmont Ridge Road for the interchange construction. The first phase is scheduled to begin the night of Monday, March 27th and end on or about April 10th. During Phase 1, the Route 7 eastbound left turn lanes to Route 659 north and left through lane will be closed, beginning at 10:00 pm. Complete closures of Route 7 and Route 659 will occur at 20- minute intervals between 12:00 am and 5:00 am, Monday through Friday.

The second phase is scheduled on or about April 11th to April 20th. During Phase 2, the Route 7 eastbound left turn lanes onto Route 659 north and the Route 7 eastbound left and center through lanes will be closed, beginning at 10:00 pm. Route 7 and Route 659 closures will occur at 20-minute intervals between 12:00 am and 5:00 am, Monday through Friday. Loudoun County officials ask that motorists plan ahead to take alternate routes to avoid this area during the affected times. For more information, visit the County website.

# **Mayor Kelly Burk's Corner**

March is budget month. The Leesburg Town Council has been reviewing the budget since March 8th. This two-year budget proposes maintaining the present tax rate of 18.6 cents per \$100 of assessed value. With this suggested tax rate, some long overdue enhancements can be added, such as 3-person Public Works crew. Since 2000, the Public Works Department has had 27 employees. The road miles and population in Town have almost doubled since 2000, but Public Works has not added any new staff. Also, proposed to be added in the budget is a person for parks maintenance, a zoning inspector, closed captioning for Council, Planning Commission and BAR meetings, resident newsletters, and an information technology strategic plan. Additionally, the budget calls for a new special event, The Taste of Leesburg, and joining the National Main Street Program to help organize, revitalize and support downtown Leesburg businesses.

If you are interested in more information about the budget, please visit the Town website. The last public hearing is March 28th at 7 pm. You are welcome to speak to the Council and share your opinions and ideas. The Council will vote on the budget April 4th.


# Youth Connection




