606 To Close at 1 PM Today in BOTH Directions

Route 606 will close at 1 pm today (Tuesday, June 20) for about 1 hour to allow the Loudoun County Sheriff's Office Crash Reconstruction Unit to finish their investigation of yesterday's fatal accident. A 70 year old man was killed when he attempted to make a U-Turn near the auto auction facility and was hit by an oncoming dump truck. My thoughts and prayers are with his family as they deal with this loss.

Upcoming Configuration Changes on Route 606- Delays Expected

As construction progresses on the Route 606 Widening project, there are two configuration changes that will be taking place within the next month that I want to share with you.

First, on or about June 23, 2017, westbound Route 606 traffic between Pebble Run Place and Evergreen Mills Road will be shifted onto the newly constructed parallel roadway. Currently, as you approach the signal at Evergreen Mills Road, the road widens out to two lanes at the intersection. When this new configuration is put into place, the road will remain one lane at the intersection for approximately 2-3 weeks. This reduced lane configuration is necessary to carry out the planned scope of roadway work that includes earthwork,

drainage, grading and full depth pavement/median construction. I do expect delays in this area as a result of the lane closure. After completion of this work in the vicinity of the Evergreen Mills Road intersection, the existing two-lane configuration at the intersection will be restored. This configuration change is scheduled to begin at 10:00 pm on Friday, June 23, 2017 and be completed prior to 9:00 am on Saturday morning, June 24, 2017.

Second, on or about July 14, 2017, eastbound Route 606 traffic between Evergreen Mills Road and Pebble Run Place will be shifted onto the newly constructed parallel roadway to allow for reconstruction of the existing section of Route 606. This configuration change will begin at 10:00 pm on Friday, July 14, 2017 and be completed prior to 9:00 am on Saturday morning, July 15, 2017.

Both of these interim configuration changes are necessary as the project team prepares for the connection of Loudoun County Parkway from the north, expected to take place this fall. The complete widening and reconstruction of Route 606 is expected to be completed during the summer of 2018. For more information, visit VDOT's Route 606 Widening project [page](#).
