Loudoun County Parkway Now Open

I am extremely pleased to announce that Loudoun County Parkway, north of Evergreen Mills Road is now open to traffic! VDOT and Shirley Contracting opened the full intersection at Route 606 following a ribbon cutting ceremony held onsite this afternoon.



More than any other, this project was the one that inspired me to get more involved in local government. One of the first things the Board of Supervisors did when I took office in 2012 was conduct a "missing links" study that guided our prioritization for the local road network. This missing link was at the top of the list. Getting this project to

fruition required a great deal of effort from a lot of people. The road was constructed as a proffer from Brambleton, but that proffer was adjusted and had to be renegotiated during the last Board's term. At the time, I took the position that I would oppose any applications from Brambleton until the County had a firm commitment to complete Loudoun County Parkway. As a backstop, I even pushed for the road to be included in the County's budget, which fortunately wasn't needed because of the new proffer.

In addition, the initial design for the intersection was clearly going to be inadequate for traffic volume, so then-Chairman Scott York and I halted everything and forced a redesign to allow for 3 left turn lanes on the westbound side. Once the Route 606 widening project kicked off, Shirley Contracting committed to having this intersection open in September 2017, and they have delivered.

Having this direct link to Brambleton and the southern part of Ashburn should help relieve some of the traffic that currently uses the Stone Springs/Evergreen Mills/Belmont Ridge corridor to access the area. Though it may take some time for drivers to settle into a new pattern and realize the new route has been opened.

This intersection is one milestone in the ongoing project to widen Route 606 from Evergreen Mills Road to the Greenway. The full project is expected to be completed by the end of 2018.

Pebble Run Place Detour

On Friday September 8 at 9:00 p.m., Pebble Run Place will be closed to traffic entering or exiting to/from Route 606. A detour will be in place for all traffic to use Overland Drive to access Pebble Run Place during this time. The detour will remain in place from Friday night September 8 through Sunday night September 10 to allow for full re-construction of Pebble Run Place at Route 606.
