



Hello, Loudoun

I hope back to school was a success for the residents with school aged children. My prayers and thoughts go out to the residents of Houston and Florida.

On September 16th, I attended an unveiling ceremony for the historic Ashburn Colored School. This school was renovated less than a year after it was vandalized thanks to the fundraising efforts of the Loudoun School for the Gifted students. I asked everyone in attendance to keep up this good work.



Legislative Program and Statues

At the September 20th Board business meeting, I am proposing a legislative initiative to amend <u>Virginia Code 15.2-1812</u> to provide a process whereby localities have discretion over war or veteran monuments and memorials on property owned or controlled by the locality. The proposed initiative would give authority for erected monuments on public property to the locality.

On August 25th, the Attorney General of Virginia, Mark Herring, released an official advisory **opinion**. Mr. Herring's opinion stated the following: "Because the existing state law was passed in 1904, it does not apply to any monument or memorial built prior to then." Loudoun's monument was erected in 1908. I will be asking my colleagues for their support on Wednesday. For an item to be added to the 2018 Legislative Program, it must first be approved by the full Board.

Please note that this week's Board business meeting is scheduled for Wednesday, September 20th at 5:00 pm. The meeting is being held a day early to accommodate Rosh Hashanah, which is on September 21st. This meeting will be policy heavy. We will have an update from Metro CEO Paul Wiedefeld, results from the Nonprofit Needs Assessment and final votes on phase one of the Classification and Compensation Study. Transparency

Promoting an open government that is accountable to the people is very important to me. At the September 5th Board business meeting, I initiated a process to post agenda summaries of Board Business Meetings and Public Hearings in all Loudoun County Public Libraries to allow residents, who do not have sufficient internet and technology access, to view the proposed items in a timely manner. An estimated 30,000 residents in western Loudoun are under-served or unserved when it comes to internet access. Therefore, these residents may not be informed on items that pertain to them. Due to free wireless internet and technology access, the public libraries are an efficient medium to post this information.

Town Center Zoning

I made the motion for this item because I worked closely with the Lansdowne Conservancy to address their concerns with the zoning change. This group not only expressed concerns but they also found a solution. I want to thank staff, my neighbors, the Lansdowne Conservancy and Lansdowne Village Green HOA. Residents are paying attention and have good ideas. This zoning change was initiated to provide a business friendly environment and encourage innovative designs for town centers. Option C was approved which limits data center uses to no more than 49% of a building in both core and fringe areas and data center generator testing to weekdays only between

8 am and 5 pm. Regulations for storage and mini-warehouses were also approved as a special exception use in fringe areas only.

Pennington Garage

While installing the deep foundations for the Pennington Parking structure in Leesburg, two sinkholes developed. At the September 5th Board meeting, we were told sinkholes are unpredictable but staff believes the drilling aggravated the subsurface creating these sinkholes. Staff came to the Board requesting additional funds for sinkhole remediation and mitigation to protect other parts of the structure. We voted to increase the contract for the construction of the Pennington Lot Parking Garage in the estimated amount of \$3 million. We also authorize staff to process a budget adjustment to transfer \$5.4 million from the Courts Complex Phase III project for the construction of the Pennington Lot Parking Garage.

I am uncomfortable with the cost override because it is significant and will affect our Capital Improvement Program for FY19. However, I was informed that abandoning the site and starting over would come at a greater cost because 50% of the structure is already fabricated. Staff plans to do weekly project updates and I will communicate any additional issues or requests.

To recognize Suicide Prevention week from September 10 - 16, Chair Randall highlighted two nonprofits that are making a difference.





Solarize Loudoun

Loudoun County government is joining with Solarize NOVA to promote the use of solar power in Loudoun County homes and business from September 4th through October 15th. The program offers a one-stop-shop for the community to learn more about solar power options, installation and financing for homes and businesses. This year, the Solarize
Loudoun campaign features Loudoun County based solar installers. The financial benefits of solar power include a 30% federal tax credit and an estimated 6% annual return.

Solarize Loudoun workshops have been scheduled for residents and business owners who are interested in learning more about solar power and reduced-pricing options. The last available free workshop is on Thursday, September 28, 6:30 to 7:30 pm in the Purcellville Library, 220 E. Main Street in Purcellville. RSVP here to ensure seating.



Investing in Transportation

On September 6th, Chair Randall participated in a ribbon cutting ceremony for the following important transportation improvements on Loudoun County Parkway and Route 606:

- A signalized intersection at Loudoun County Parkway and Old Ox Road. This
 is one element of the overall VDOT-administered project that will also
 reconstruct and widen Old Ox Road from two to four lanes between Evergreen
 Mills to the Dulles Greenway (about five miles) and add a multi-use path. This
 \$119 million project will be completed in the summer of 2018.
- A one-mile extension of the Loudoun County Parkway from Broad Run to Creighton Road. It also includes a recently completed segment of Shreveport Drive, connecting Belmont Ridge Road to the Parkway, with two new signals at the Parkway and at Belmont Ridge Road.

Loudoun County Transit encourages everyone to try a form of transit during Virginia's "Try Transit Week" September 18 - 22. Participants who pledge to try transit at www.trytransitweek.org are eligible to win a year of free transit service from the Virginia transit operator of their choice, along with a pair of round-trip tickets aboard Amtrak's Northeast Regional train. Pledges will be accepted through September 22nd. In addition, anyone who lives or works in Loudoun, and who pledges to try transit, is eligible for prizes from Loudoun County Transit. Two winners will each receive a \$50 SmarTrip card that can be used on Loudoun County's Premium Commuter buses and most Metro Connection buses.
