

Dear Leesburg Resident,

Don't forget, tomorrow is the Halloween Parade on King Street in Leesburg at 6:00 pm. For 60 years, the Leesburg Kiwanis Club has sponsored the annual Halloween Parade. I hope to see you there!

Loudoun County and Buddy Rizer, Executive Director Economic Development, were featured on a CBS News segment called, <u>"The heart of "The Cloud" is in Virginia.</u>" Up to 70% of the world's internet traffic passes every day through a Loudoun County data center. Our data centers provide \$100 million in tax revenues to the County every year, while generating very little traffic.

At the October 19th Board business meeting, Chair Randall and I recognized the month of October as Disability Employment Awareness Month. There are 179,000 individuals with disabilities who are employed in Virginia. An estimated 1 in 5 Virginians will have a disability at some point in their lifetime.

Congratulations to my friend, Valerie, who was married on October 21st. I wish Val and her husband many healthy and happy years together!

#### **Transportation Update: Route 15 North**

A <u>Route 15 Congestion Report</u> update was presented to the Board at the October 19th business meeting. The following action was taken:

- Staff will coordinate with the Virginia Department of Transportation (VDOT) to implement Phase 1 improvements as defined in the Route 15 Congestion Report. Phase I improvements include adding a northbound auxiliary lane between North King Street merge and Tutt Lane that will cost between \$1.7 to \$2 million. These improvements will provide immediate relief as early as next spring.
- Staff will coordinate with VDOT to procure the services of an engineering consultant to prepare the design and construction plans for the remaining phased improvements, utilizing the remaining Federal and state funds designated for the Route 15 Corridor.

- 3. Staff will refine the specific improvement alternatives, using information collected through public meetings, the technical analysis and coordination with Supervisors, and report back to the Board for their endorsement of those project components in the first quarter of 2018.
- 4. Staff will transmit a request to the Town of Leesburg for their funding participation in the Route 15 Congestion Report improvements between Battlefield Parkway and King Street. This area is located within the Town.

To improve safety in the short term, VDOT plans to install rumble strips along the Route 15 North corridor. This year, VDOT will fill in the gaps in the centerline rumble strips. Next year, shoulder rumble strips will be added.

The Countywide Transportation Plan amendment to extend the limits of the 4-lane, median divided roadway, from Tutt Lane to Montresor Road has been initiated. A Planning Commission public hearing is planned in December and a Board of Supervisors public hearing is planned in February 2018. It is expected the CTP will be voted on by the Board in the spring 2018.

I want to thank our citizens from Exeter and Potomac Crossing, our staff and Supervisor Higgins for their hard work on this item.


#### **Transportation Update: NVTA**

The **Board discussed eight candidate projects** for submission to the Northern Virginia Transportation Authority (NVTA) Six Year Program in the amount of \$331,142,000 that included \$54 million to widen US 15 to 4 lanes from Battlefield Parkway Interchange to Montresor Road. The Board also endorsed the Town of Leesburg's Route 7 and Battlefield Parkway Interchange project in the amount of \$25 million. According to the Transportation Planning Board, the Route 15 North corridor is one of the most congested in the Greater Washington DC Area. It is the only location in Loudoun County to make this top ten list. I would like to be as proactive as possible to make sure we receive the NVTA funding for Route 15 North. Information on the rankings will be provided to the Board at the November 8th business meeting.

#### **Exeter Sinkhole**

A 30-foot-wide presumed sinkhole developed on Jared Square, off of Fieldstone Drive, in the Exeter Community on October 10th. The hole was in the parking lot of the community.

The geologist hired by the Town of Leesburg to evaluate the hole has determined that it is not, in fact, a sinkhole, finding no evidence of karst formation. The pavement collapse was due to soil settlement over time and was precipitated by heavy rain following a long dry spell. The Town plans to fill the excavated area with structural rock overlaid with geotextile fabric before reinstalling the utility lines and backfilling with soil. This work is now complete. Thank you to all those in the neighborhood for looking after each other.



#### **Envision Loudoun**

Staff **presented preliminary land use recommendations** for the new comprehensive plan in the Suburban and Transition Policy Areas at the October 3rd Board business meeting. Based on the comments from Phase I and II community outreach, the majority of the public would like to leave the Transition Policy Area as it is with no changes. However, staff recommends 12,000 additional houses than allowed by-right; and the Stakeholders Committee recommends adding even more residential units with 18,000 being proposed. These recommendations do not take into account the traffic impact of that many additional houses. We do not have the roads or the bus system to accommodate additional residential growth in the Transition Policy Area. And the recommendations do not get into the school needs and budget implications. Board comments from this meeting will be summarized for the Stakeholders Committee. The Stakeholders Committee will finalize a draft of the comprehensive plan for Phase III community outreach public meetings tentatively scheduled for January 2018.

#### **Housing Summit**

On October 16th, the Board held a <u>Housing Summit</u> to investigate options for a diverse housing stock that could be located near jobs and bus lines or Metro. This summit is the beginning of a process that will take 2 years or the rest of the Board's term. The following motions were voted on by the Board:

- Develop a resolution of intent to amend the Zoning Ordinance to establish necessary revisions and newly created amendments to incentivize workforce housing. The resolution will be sent to the Transportation and Land Use Committee (TLUC) before going to the full Board.
- Develop a public land inventory which will be discussed at TLUC before coming to the full Board.

 Develop a formal revolving loan program for the Loudoun County Housing Trust Fund and report back to the Finance/Government Operations and Economic Development Committee.

The first Board business meeting in November was moved to Wednesday, November 8th due to Election Day. The second Board business meeting in November was cancelled due to the Thanksgiving holiday. Thank you.

### **Mayor Kelly Burk's Corner**



VA Telework Tax Credit: Virginia businesses with a telework program may receive up to \$50,000 in tax credits for telework-related expenses! Thinking about starting a telework program or ugrading laptops or computer security software for teleworkers? Now is the time! To qualify, your business must be a private (for-profit) company located in Virginia. Additionally, you must file Form TEL-1 Telework Expenses Tax Credit Reservation Application by October 31st to qualify for expenses incurred in 2018.
