

LCSO: Be Prepared to Run, Hide, or Fight in Active Shooter Incidents

In the wake of recent active shooter incidents and acts of terrorism, the Loudoun County Sheriff's Office is joining law enforcement agencies nationwide in reminding residents how to best handle these situations in the workplace or in public.

Loudoun County Sheriff Mike Chapman is encouraging residents to watch and share a video titled Run > Hide > Fight. "The video demonstrates the actions you may need to take to survive an active shooter incident," said Sheriff Chapman. "You need to be prepared to make quick decisions such as fleeing the area, hiding or taking measures to fight the attacker to save your life and the lives of others," Sheriff Chapman added.

The video was produced by the City of Houston Mayor's Office of Public Safety and Homeland Security (Ready Houston) as part of a Department of Homeland Security Grand Funded Project of the Regional Catastrophic Planning Initiative. The video was developed to educate residents on how best to respond during an active shooter incident.

Please be advised that the initial sequence of the video may be disturbing to some viewers.







Alert Loudoun

Alert Loudoun is the notification system the county uses to send citizens emergency information, news releases, traffic information, weather alerts, and more.

The system will send you **information you need wherever you are**. For example, subscribers may register to receive weather alerts that affect not only their home address, but also their work location, their children's day care provider, their children's school, or their parents' home.

The Alert Loudoun system also gives subscribers the ability to customize how they receive information – by text, email, cellphone and/or mobile app. The new system will first send a message to what you designate as your primary means of notification. If it doesn't reach you that way, it will try another method.

Loudoun County Sheriff's Office App

The app, available on the iTunes App Store (iOS) and Google Play. (Android), allows residents to submit crime tips, report crimes and traffic issues, and learn the latest public safety news in the county.

Additional features of the app allow residents to view real-time information on traffic incidents, review daily crime reports, read the latest public safety news, and learn of upcoming events held by the agency.

Other features of the app include citizen feedback, allowing residents to comment on the quality of service of the agency and follow-up on case information. Residents will also be able to receive non-emergency community notifications from the Loudoun County Sheriff's Office that are specific to their station area
