



I wanted to recognize Sean Conroy (ECC) and Dave Young (DIT) for going beyond their normal course of duties to ensure a community notification was sent to residents regarding a possible barricade situation on Rockfield Court on April 6, 2015.

The Loudoun County Sheriff's Office responded to a home on Rockfield Court after receiving a 911 call from a person claiming they had just committed a shooting and they threatened to harm themselves. Deputies arrived on scene and were unable to make contact with anyone inside the home. Sgt. Lee Williams requested a Reverse 911 message be issued to the surrounding homes due to the possibility of a barricade situation involving a firearm.


Dispatcher Conroy began initiating a Reverse 911 message. Unfortunately the mapping software was not functioning properly making it impossible for him to send the message. Dispatcher Conroy contacted Dave Young of DIT to assist with fixing the issue. Between their efforts, a message was sent to the residents advising them of the situation and to remain inside their homes. Not only were the residents initially notified of the situation, they were able to receive an updated message that was sent after the scene was determined to be an isolated incident and there was no threat to the community.

Dispatcher Conroy realized the importance of this community notification and called Dave Young of DIT to assist with the matter. Dave Young made sure he was available and worked afterhours to help complete the task of sending the notification.

Their efforts ultimately ensured the safety of the residents on Rockfield Court by making sure a message was sent advising them of the issue in their neighborhood and the necessary precautions they needed to take.
