Upon their arrival to the United States, a senior delegation member was detained at the Dulles Airport and transferred to the custody of your staff at the Loudoun County Adult Detention Center. Your staff demonstrated superior professionalism ensuring the Coast Guard and the government of Jordan were kept apprised of the individual's condition and case status. In addition, your staff extended the utmost discretion and courtesy by facilitating a visit by the Jordanian Head of Delegation and our representative, Lieutenant Commander Alan Hansen.



- > On Friday, March 11th at 8 a.m., my 17 yr old grandson, Jason Sorrells was involved in an incident on Database SQ. Aldie, VA. My grandson is severely autistic and can be extremely violent and out of control.
- > Jason was visiting his Dad when after an argument he ran out from the resident in to traffic. He proceeded to jump onto the hood of several vehicles doing extensive damage. Deputy "Rusty" Shelow responded to the scene.
- > The purpose of this letter is to commend deputy Shelow for handling the situation. For over a year, his parents have been trying to get the proper help for this boy. My daughter, Monica Sorrells has called 911 many times because of his violent behavior to her, his brothers and their property. The only help she has gotten is "in home counseling". Deputy Shelow was so concerned, that he inquired to my son-in-law as to who he can contact to get him the help he needs. He took it upon himself to contact the appropriate, authorities and within three days Jason was placed in a secure facility (Grafton) where he can get the help he needs.

Dear Sheriff Chapman: Mike,

I am writing to commend the outstanding police work of three members of the Loudoun County Sheriff's Office.

The Alexandria Police Department has been investigating a series of murders that occurred in Alexandria over an almost ten year period. Each of the three victims was inexplicably shot after answering a knock at the front door. As you can imagine, these crimes were both shocking and frightening to the citizens of Alexandria. After an exhaustive investigation, Alexandria detectives identified Charles Severance as the suspect for these crimes. Once Severance was identified as a resident of Ashburn, Virginia, Alexandria detectives sought the assistance of detectives from your agency.

Alexandria detectives contacted Detective Collette Cunningham and Detective Steve Schochet who were willing and able to assist. These detectives assisted in obtaining and executing search warrants, conducting interviews, and collecting evidence. They willingly provided whatever assistance was requested, and their efforts were vital to our murder investigation.

Charles Severance was charged in Loudoun County on weapons charges while the Alexandria case was prepared for indictment. During that time, Detectives Cunningham and Schochet continued to provide support. In addition, Captain Ebersole and his staff at the Loudoun County Detention Center went out of their way to provide Alexandria detective access to recorded jail calls, inmate mail, and brought to our attention several inmates who provided information about Severance.

Last month, after having been convicted of the three murders, Charles Severance was sentenced to serve three life terms plus 48 years in prison. This successful outcome was due in large part to the outstanding work from members of your agency. I wanted to commend the efforts of Detective Cunningham, Detective Schochet, and Captain Ebersole, and express my sincere appreciation for the support from you and the Loudoun County Sheriff's Office.
