My name is Michael Middleton and I am a Senior Trooper with the Virginia State Police assigned here in Loudoun County. I wanted to bring to your attention two of your deputies that assisted me in making an arrest back on Feb 1<sup>st</sup> of this year.

I had stopped a vehicle approximately 0200 hrs. for speeding and swerving on Rt. 28 North at Cedar Green. During my contact with the driver, I could detect he had been drinking and was showing signs of being very intoxicated. The driver stated he was not coming outside of his vehicle and was declining to perform any field sobriety test. I advised the driver that he was under arrest and ordered him to exit his car. He would not exit, so a struggle ensued between me and the driver. I was able to call my dispatcher and request for assistance. I had been fighting with the driver for about three minutes and was becoming very exhausted when Deputy Sean McCormack arrived to help. He eventually had to tase the driver twice because he was still being unruly. Deputy J. Bracke also arrived, and after the driver exited his car, both deputies and I were able to get the driver in custody. I sustained a torn rotator cuff and have been on light duty ever since.

I was hoping to have these two deputies recognized for their actions that helped me in a very serious traffic stop that could have turned deadly.
