


Hello Major Tate,


I also wanted to thank you for allowing us to use some of the gear you are currently not using so we can practice, attend an upcoming training, and attend a few events.





Many times there are victims that come into our office for help, to charge someone, or to get Protective Orders etc. Most times there are no Spanish speaking road deputies that are available to help the victims fill in paperwork. The personal interaction with a deputy at these times is a comfort to victims and sometimes gleans an insight that we cannot get with a translator over the phone. Dep. Santos is one of the few Deputies at the ADC that speaks Spanish. Her language skills and "people skills", the way she treats victims (and defendants) is invaluable. Deputy Santos really explains the process and makes sure the people leave with a full understanding of what is going on and what is to come. Her presence is calming to victims and they open up more.
