The deputy was able to find the pickup parked nearby on a local street.



It is very difficult to explain what is happening and the reasons for such bizarre behavior from a loved one. The training that you have provided to your Deputies made it much easier to explain the situation to them while we were under tremendous stress. Your Deputy quickly grasped what was happening, and he was able to provide us calm guidance that reassured us. He then took deliberate and swift action to defuse and resolve the situation.

As I mention on the Compliment Form, Deputy Raughley not only stayed late on that Saturday so that he could make sure our son was receiving the proper treatment and to brief us, but he also came in on Monday, his day off. We really appreciated him sacrificing precious time with his wife and children so that our son might be better helped.

Deputy Ramirez was a flat-out professional - calm, helpful and compassionate. His very presence on that Thursday night helped calm my wife. Heck, even the Deputy that was standing guard in our hearing at LAMPS on Monday was a sharp young man. We don't recall his name, but we had a chance to talk and he was also great. At one point, prior to the hearing, one of the patients in the hospital there became violent and was yelling and screaming. Your Deputies (both Raughley and the young man guarding the hearing) responded out of caution and, had it been necessary, they would have helped out. Their professional concern was obvious.





I know there will be a trial or bargaining before this is a closed case, but you have to know that our family understands that you were indefatigable in your case work.


I am sure you are thinking that you were doing your job. Some people do their jobs better than others; and it is true of you.


I would like to take this opportunity to recognize Crime Scene Investigator Robert Bruns for the assistance he provided to this department during a recent homicide investigation.

We are writing to let you know how helpful one of your deputies was to us. On Wednesday, February 27, 2013, shortly after 10 p.m., we noticed that a car had parked in front of our house and had blocked half our driveway. Unfortunately, due to overcrowded housing in nearby town house developments in both Loudoun and Fairfax counties, this has happened to us several times in the past. When we would call the Sheriff's department, a deputy would come out in a timely fashion and write a ticket for the offending vehicle. This time, Deputy Sheriff C. A. Forsch #2359 arrived shortly after we called to report the blocking of our driveway. Deputy Forsch checked the car, and then came to our home to ask if we were the ones who had reported the car. We told him that, yes, we were the ones who called. He asked if any of our neighbors were having company and we told him it didn't appear that way. Then he told us that it was unacceptable the way the car was parked and that he would get it moved for us. He noticed that the house diagonally across the street had lights on inside, then he went there to ask if they knew who the car belonged to. The neighbors did not know. We were pleasantly surprised to see that Deputy Forsch had arranged for a tow truck to remove the offending car. In the past, deputies would only write a ticket when this happened. It was a relief to us to see that tow truck. While we don't go out late in the evening, what concerned us is that should we have an emergency and need to leave the house, a car partially blocking our driveway would make it extremely difficult, if not impossible, to get out of our driveway. Likewise, if an emergency vehicle needed to come to our house, it would be very difficult to access our driveway. Deputy Forsch went above and beyond the call of duty.
