



I would like to take this opportunity to recognize Detective Rob Reed for his invaluable assistance to the Leesburg Police Department during a recent murder for hire investigation.

Information came to the attention of this department that Wendell Mansel confided to an acquaintance in Leesburg that he was seeking to hire an individual to murder his wife. Mansel and his wife resided in Anne Arundel County, Maryland. In order to obtain convincing evidence of Mansel's intention to have his wife murdered, it was necessary to introduce him to an undercover law enforcement officer. Through coordination with your Criminal Investigation Division, Detective Reed was selected for the undercover role. Detective Reed was outstanding in his undercover role during his contacts with Mansel that culminated in Mansel's arrest and the recovery of a handgun and payment for murder soliciation.

On April 22, 2013, Mansel pleaded guilty to Conspiracy to Commit Murder, Solicitation to Commit a Felony, and Use of a Firearm in a Felony. Most importantly, Detective Reed's contributions to this case prevented the murder of an innocent person.
