


Hello, Loudoun

LOUDOUN STATION

Discharge of Firearms

Based on an accidental shooting incident in the Willowsford community, I moved that staff report on the Codified Ordinance, Discharge of Firearms, describe the process for how the current ordinance was developed and amended, present maps depicting the boundaries of regulated areas, and identify the State Code to regulate the discharge of firearms at the June 21st Board business meeting. I also requested that staff invite a representative from The Department of Game and Inland Fisheries, Sheriff Mike Chapman and Commonwealth's Attorney Jim Plowman to discuss state code regulations, the County's Codified Ordinance, and the investigation into this specific incident. The public is welcome to speak to the Board about this issue at 5:00 or 6:30 pm. Advanced sign-up for public input is available by calling 703-777-0200 until noon the day of the meeting.

Leesburg North Landing

The Board majority forwarded the special exception to permit up to 14 fuel pumps (12 pumps under canopy and 2 diesel pumps) on Route 15, north of the Village of Lucketts, to the July 3rd Board Business Meeting for

action. Thank you to everyone for coming out to the public hearing last Wednesday. Some points were made that I had not considered and will research like the spillage from the gas pump nozzles. If the spillage from the nozzles negatively affects wells in this area, this will impact my vote. I will also research the topography of the land to determine how the additional fill will impact runoff to properties at lower elevations. There will be a public input session at 6:30 pm and residents are encouraged to sign-up in advance by calling 703-777-0200.

Transit Summit

The Board is hosting a Transit Summit on Monday, June 25th at 6:00 pm to follow-up on the items discussed at last year's summit (see list below). The public is welcome to attend but there will be no public input session.

- Bus stop inventory and Americans with Disabilities Act compliance
- Dulles north transit center
- Process for soliciting, receiving, and evaluating stakeholder requests for transit
- Metro-connection and local fixed route service, transition to a combined system



Voice for a Cause StoryBook Treasures

StoryBook Treasures is a nonprofit organization with the goal of providing books and reading materials to promote literacy and education to all children. StoryBook Treasures is designed by teachers, provides an innovative curriculum that builds upon a student's strength for using their imagination and curiosity to empower children to establish a love of books and become successful life-long readers. StoryBook Treasures is growing at an incredible rate and is currently active in 5 states (Florida,



Nevada, Alaska, Maryland, and Virginia) and impacts over 150 classrooms and 3,000 students.

Investing in Transportation

The Northern Virginia Transportation Authority (NVTA) adopted its first six-year transportation program. Loudoun County is receiving \$337 million, which is approximately 21 percent of the available funds in the six-year program. The Loudoun projects are:

- Dulles West Boulevard Widening: Loudoun County Parkway to Northstar Boulevard
- Evergreen Mills Road Intersection Realignments: Watson Road and Reservoir Road
- Northstar Boulevard: Shreveport Drive to Tall Cedars Parkway
- Prentice Drive Extension: Lockridge Road to Shellhorn Road
- Route 9 Traffic Calming
- Route 15 Bypass Widening: Battlefield Parkway to Montresor Road
- Route 28 Northbound Widening: Between Dulles Toll Road and Sterling Boulevard
- Shellhorn Road Extension: Loudoun County Parkway to Randolph Drive
- Interchange at Route 7 and Battlefield Parkway

As the Vice Chairman of NVTA, it is an honor to be part of this historic milestone for the Authority. The 44 projects in our first Six Year Program will deliver major improvements throughout the region that will not just relieve congestion but improve the quality of life for all Northern Virginians. My mother, Enid, left Uganda and came to America in the mid-'80s after her two brothers were killed during her home country's civil war. She met my father while studying for her first degree at UDC. She continued her education and worked full-time until I was born. She worked hard to earn her bachelor's degree, even while moving to Georgia and expanding her family.

My mother raised her four children with strong values, including a global citizenship mindset. She taught us to make a difference in our world, environment, and generation. She discovered a deep passion for helping parents who come to this country from other shores and have trouble in their marriages and parenting, especially in a different culture. She wanted to address these challenges, so she went back to school and earned a master's degree in marriage and family counseling.

When our family moved back to Virginia in 2013, I hoped to work for the government but did not know how to go about it. The next day, my mother and I attended church and met a man who introduced me to then-Congressman Frank Wolf. Soon, I was working for him at the U.S. Capitol. When he retired, I worked for a New York senator and then for the Obama Administration, where I helped with policies concerning the environment and climate change. As usual, life has a way of throwing us curveballs. After more than 27 years of marriage, my father suddenly left our family in 2016-without saying a word to any of us. No family in Loudoun should have to cope with such loss.

THE NEXT CHAPTER

I believe tragedy is not intended to destroy us but to soften our hearts. Our church community supported us. Because of their kindness, we did not fall. We were fortunate to have a professionally trained counselor in our mother, who could help us all heal. In 2014, my mother and I founded a nonprofit to help new immigrants-mostly high school-aged girls-and under-served families find their way through a system that can seem daunting to navigate. We help them adjust to their new culture and community, enroll in educational

courses, and find internships or jobs. Along the way, we provide these families with hope, purpose, encouragement, and opportunities.

Many of the young women who come to Loudoun from various countries do not quite understand how different it will be to live here. Many come here only to find themselves on the periphery, thinking they will never fit in. People need to feel authentic connections with friends, co-workers, church members, and neighbors. My family's journey has taught us that we all can open our eyes and our hearts to embrace everyone from every culture. If we do, we can go far to make this a richer nation and to End the Need in Loudoun.
