Overview of Projects






West Poplar Road: Project Progressing

- On September 20 the Board of Supervisors voted to transfer \$115,700 of funds to the West Poplar Road project
- The project has to go through the Virginia Department of Transportation process—it is expected to be completed in the first half of 2019
- Will create a one-way street (current road not wide enough for two lanes under modern standards). Part of the road will be for parking, part for traffic.
- Safety improved as children only have to look one way
- The revised road will include a fire lane
- Parking will be prohibited in the area of Greenthorne/West Poplar
- This project is expected to be completed in the first half of 2019



Augusta Drive: Project Progressing

- On September 6, 2016 the Board of Supervisors approved 9-0 a Board Member Initiative which included studying safety on Augusta Drive
- On March 7, 2017 the Board of Supervisors approved 6-1-2 a traffic engineering study which included Augusta Drive
- On October 18, 2018 the Board of Supervisors unanimously approved moving forward with the project
- Premature for a concrete timeline, but summer 2019 the best estimate for completion right now



Key Findings

- Changes to intersection control and pedestrian accommodations were not recommended
- Opportunities for improvements at spot locations
- Sight distance can be improved to enhance safety




Augusta Drive Improvements

- Add center left-turn lane(s)
- Reduce lane width
- Reduce pedestrian exposure to vehicular traffic
- Reduce number of conflict points during crossing

Sidewalks

- \$20.1 million over the next six years moving to pedestrian improvements on Route 7 (shifted from a shared-use path along Atlantic Blvd.)
 - Two sidewalks at intersections in the Target, Nova, Cascades Overlook area
 - A sidewalk near Community Plaza & Lakeland Drive (Chick-Fil-A/Rite Aid area)
- "Sidewalks, Trails Get Attention in New Capital Projects Plan" (Loudoun Now)

Sidewalks

- Consultant study: build four sidewalks in Sterling
 - Church Road east of Cascades Parkway to Sterling Boulevard
 - Cascades Parkway between Loudoun Park Lane to Potomac View Road
 - Potomac View Road between Cascades Parkway to west of Benedict Drive
 - Across Park View High School property from the entrance on North York
 Road to the Scout Trail at Claude Moore Park
- County's Sidewalk and Trail Program begins in FY 2022, sequence of projects
 TBD
 - "Study Eyes At Least \$4.7M for Sterling Sidewalks" (Loudoun Now)







W&OD Trail Bridge Over Sterling Boulevard

- Supervisor Saines brought forward a Board Member Initiative to explore an elevated or underground crossing of the W & OD Trail over Sterling Boulevard in 2016. The purpose of this was to improve safety of pedestrians and bicyclists on the trail
- It passed out of committee 5-0 on December 13, 2016
- The Board approved it 8-0 on January 3, 2017
- \$7.75 million allocated to construct the bridge in fiscal year
 2021 as part of Loudoun County's Capital Improvement
 Program








Milestone Telecom Proposal: Monopole in Claude Moore Park

- Proposing to build a telecommunications monopole and a related equipment compound on 2,224 square feet of leased area in Claude Moore Park, next to Park View High School
- Stated purpose: to 1) improve coverage in Sterling in the areas around Cascades Parkway, North Sterling Boulevard and Route 7 2) relieve congestion traffic in other areas to maintain same quality of coverage there
- One option is to have a monopole that looks like a tree. The other option is to have a traditional looking monopole

Bus Shelter Covers: Background

- County has been running local fixed route buses for only about 4 years
- County now looking at standards for stops, shelters, etc.
- First step: creating an Americans with Disabilities Act Transition Plan
 - Completed earlier this year, will be implemented at a cost of \$4 million
- County avoids shelters, due to purchase and maintenance costs
 - Existing shelters in Loudoun County were proferred by developers or installed when Virginia Regional Transit was operating the buses
 - \$20,000 cost to place a bus shelter at a stop







Bus Shelter Covers: Going Forward

- County transit staff are looking at what amenities to place at the bus stops
 - Can include but are not limited to the following: seating, benches, shelters, canopies, informational signs, maps and schedules, digital and electronic signs and waste receptacles
- Once the amenities are determined, a implementation/installation plan will be created and funding will need to be found







Rockwool Factory in Ranson, WV

- Discussed at the October 2 Board of Supervisors Meeting
- Board passed 9-0 a two-part motion
 - Loudoun County to request more analysis and compliance investigations from the Virginia Department of Environmental Quality ("VDEQ) regarding the impact on Loudoun
 - Asks VDEQ to install a second air quality monitoring station in Loudoun where the air would most be impacted by the factory
 - Board options limited: the factory is in another jurisdiction and state







Commercial Vehicles

- •Section 5-800 Limitations on Vehicles in Residential Districts
- (B) Commercial Vehicles. The parking or storage of a commercial vehicle, or a container constructed for the transportation of cargo is prohibited in all residential districts, except that one (1) commercial vehicle with a manufacturer's rating of less than 1-1/2 tons may be parked on any lot on which there is located a principal building, provided that such vehicle is parked in an enclosed garage, accessory building, approved off-street parking area or behind the nearest portion of buildings to streets and is used by a resident of the premises. This regulation shall not be interpreted to prohibit commercial vehicles or containers from loading and unloading in any residential district.


Commercial Vehicles: Progress

- Jennings Farm Drive/Maple Leaf Place
 - Effective October 15, parking will be banned on the side of this road
- Old Ox Road/Route 606
 - Parking ban to go into effect later this year
- In both cases commercial parking per se wasn't banned—all parking was
