I would like to express my appreciation and comment on Deputy Osborn for the assistance he provided during a traffic stop on January 22, 2018, shortly after I left the NAACP event in Leesburg.

At approximately 9:22 p.m., I witness a vehicle westbound on Route 7 traveling at a very high speed. The vehicle was checked at speeds between 110 and 120 mph. The vehicle suddenly exited off onto Route 9 westbound and then took a sudden right turn into the Beacon Hill Estates. The vehicle suddenly stopped in the intersection of Beacon Hill Road and Grindstone Court, and multiple occupants could be observed in the vehicle. Not knowing the reason for the extremely reckless driving behavior, and the actions of the vehicle occupants, I requested assistance from the Loudoun County Sheriff's Department and within minutes Deputy Osborn arrived on scene

Deputy Osborn assisted me in conducting a felony stop and detention of the vehicle occupants to secure the scene to allow us to investigate the incident. His conducted himself in a highly professional manner during this incident.
