



Route 50 Eastbound Closure Near Fair Oaks Mall April 26-28

All lanes of eastbound Route 50 (Lee-Jackson Memorial Highway) near Fair Oaks Mall will be closed from 7 PM on Friday evening, April 26 until late Sunday night, April 28. VDOT will be replacing a stormwater pipe during this time. VDOT made temporary repairs earlier this week but will be working on permanent repairs during the closure.

Traffic will be detoured via West Ox Road (Route 608), Monument Drive, Fairfax County Parkway (Route 286), and eastbound I-66 back to eastbound Route 50. Please see the map below for VDOT's recommended detour route during the closure.

Two of the three ramps from the Fair Oaks Mall loop to eastbound Route 50 will be closed, but the ramp closes to I-66 will remain open. Westbound Route 50 will stay open and not be affected by the work.

Please expect delays and plan to use alternate routes if possible.

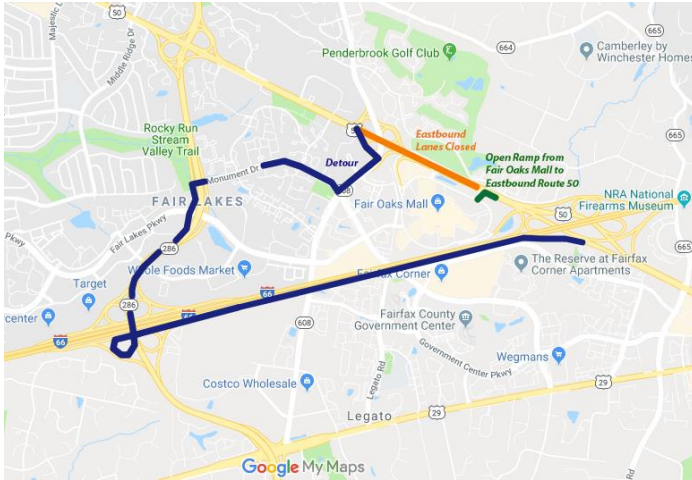
