Governor's Updates

Virginia's restaurants, and retail establishments will remain closed until May 14, the Governor said at today's press conference. However, Governor Northam was optimistic that Virginia can begin Phase 1 of reopening on May 15.

Governor Northam also announced that the Battelle Critical Care Decontamination System (CCDS) in Blacksburg, VA is fully operational. The other Battelle systems located in Newport News and Chesterfield County are expected to be operational by next week.

The Battelle CCDS uses a concentrated hydrogen peroxide vapor to decontaminate N95 masks, which can sustain up to 20 decontamination cycles

without degrading filtration performance. This technology will help address the national shortage of critical PPE and protect healthcare workers and first responders on the front lines of the COVID-19 pandemic. Each unit can sterilize up to 80,000 units of PPE per day.



Loudoun Public Library Prints PPE for First Responders and Health Workers

Loudoun County Public Library (LCPL) is assisting front-line health workers and first responders in the county by manufacturing face shields using 3D printers. These face shields will be distributed through the county's Emergency Operations Center.

LCPL expects to produce 1,000 to 1,200 face shields per week utilizing the Makerspace equipment at its Brambleton, Gum Spring, Rust and Sterling branches. The face shields produced by LCPL will go to a variety of county agencies as well as long-term care facilities that have identified a critical shortage of this type of personal protective equipment (PPE).

The library is using 23 3D printers to create the headbands for the face shields while laser cutters are used to cut the plastic shields for the masks. The face shields are being made in accordance with National Institutes of Health guidelines.

When the county's Emergency Operations Center receives a request for PPE, a team evaluates the appropriateness of the request and matches it against stock on hand. Unfortunately, demand generally outweighs supply. When this is the case, the EOC has a prioritized methodology to distribute scarce resources. "That's why we are so thankful that LCPL is joining Loudoun County Public Schools and the Howard Hughes Medical Institute to increase the available supply by manufacturing face shields for the county," Goodfriend noted.

In addition to these organizations' efforts, the community has donated more than 17,000 pieces of PPE since late March, which has been distributed through the EOC.
