### Governor's Updates

At today's press conference, Governor Ralph Northam reiterated his desire to begin Phase I of reopening on May 15. The Commonwealth is currently on track to meet CDC guidelines that stipulate the rate of daily new cases must decline for 14 consecutive days before reopening can be considered.

However, Governor Northam stated that localities will be given flexibility to maintain additional restrictions if they feel doing so will help control the spread of COVID-19. To learn about the Governor's Blue Print for reopening, [click here](#).

Governor Northam also announced that two poultry companies are conducting mass COVID-19 testing for plant workers and results are expected in the next few days. A CDC team is assisting in these efforts and the Virginia Department of Health will test communities near such poultry plants.

Furthermore, the Virginia National Guard assisted with 12 mass testing events throughout the Commonwealth. The federal government is helping to finance these operations and Virginia will continue receiving this assistance until the end of May. Governor Northam has asked for an extension.

## County Staff Has Been Asked to Report on PPE Procurement

During our regular Board of Supervisors meeting last night, it was revealed that the county has lost PPE orders through federal diversion and outbidding. County staff has been asked to report

to the board such interruptions to our efforts to acquire PPE for our front line workers. In the midst of a uniformly failed national response to this pandemic and subsequent pressure on states and local governments to fend for ourselves during this crisis, it is imperative that our county document its efforts to keep our community safe and any systematic interruptions to those efforts.



## Loudoun Continues to Seek Monetary Donations

Loudoun County is renewing its call for monetary donations to be used to purchase personal protective equipment (PPE) that can be distributed to long-term care facilities and other health care providers facing a critical need for PPE. Monetary

donations allow the county to use its buying power to purchase PPE in bulk to create a sustainable supply that can be provided to Loudoun-based agencies,

including those caring for people who are most vulnerable to COVID-19, such as the elderly.

Loudoun residents and businesses have responded generously to the county's requests for donations of PPE as well as monetary donations. More than 17,000 pieces of PPE have been donated since the program began March 27, 2020, and more than \$20,000 since the county began accepting monetary donations April 23, 2020.

## COVID-19 and Mental Health

Make sure you have access to media but limit excessive exposure. If you're feeling anxious, consider turning off social media feeds, automatic notifications and updates on COVID-19.

### **Identify feelings and talk about them**

Identify the feelings you are experiencing. Understand that your feelings are normal and talk about them with others. Be sure not to isolate yourself. Personal relationships are crucial in maintaining perspective, elevating mood and allowing distraction away from concerns that trouble us. Combat loneliness and keep talking by phone or video chat.

### **Keep healthy habits**

Stay healthy by maintaining a routine, sleeping regularly, eating right, avoiding alcohol and other drugs, exercising, relaxing and doing things you enjoy. Laugh, have fun and let yourself cry.
